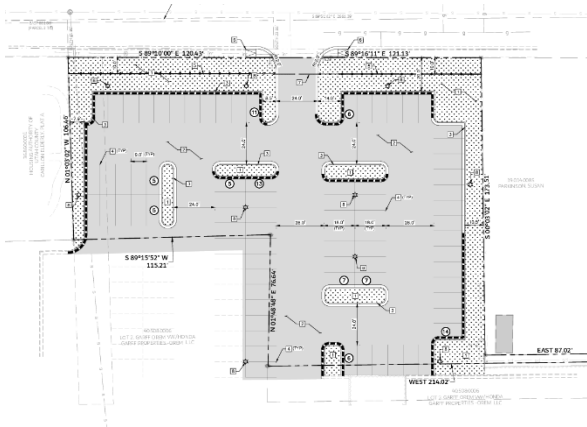
11:03 a.m. Jared Hall called the meeting to order.

1. Site Plan – Ken Garff – Located generally at 134 E 1200 South – Approved

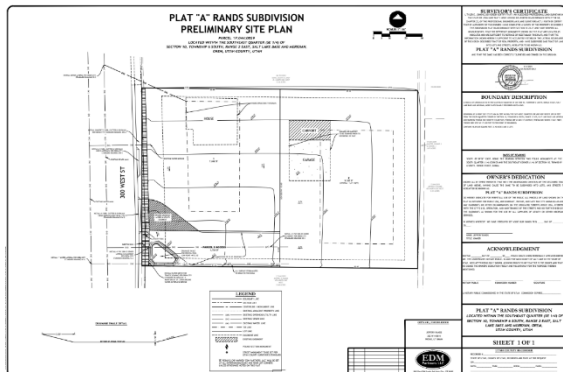
