<b>SUMMARY:</b>	This item is intended to act as an introduction for the Council of a proposed comprehensive update of the Taylorsville General Plan. This proposal will repeal our existing General Plan in its entirety and replace it with this new updated plan.

**ORDINANCE NO. 25-06**

**AN ORDINANCE OF THE CITY OF TAYLORSVILLE ADOPTING A  
COMPREHENSIVE REVISION OF THE TAYLORSVILLE GENERAL PLAN.**

**WHEREAS**, the Taylorsville City Council (the “Council”) met during its regularly scheduled meeting on June 18, 2025, to consider, among other things, approving a comprehensive revision of the Taylorsville General Plan; and

**WHEREAS**, pursuant to TAYLORSVILLE MUNICIPAL CODE § 13.35.050, notice of a public hearing before the City’s Planning Commission was published on the City’s official website on January 29, 2025; and

**WHEREAS**, notice of a public hearing before the City’s Planning Commission was published on the Utah Public Notice Website on January 29, 2025; and

**WHEREAS**, the City’s Planning Commission held a properly noticed public hearing on the proposed amendments on February 11, 2025; and

**WHEREAS**, pursuant to TAYLORSVILLE MUNICIPAL CODE § 13.35.050, notice of a second public hearing before the City’s Planning Commission was published on the City’s official website on February 26, 2025; and

**WHEREAS**, notice of a second public hearing before the City’s Planning Commission was published on the Utah Public Notice Website on February 26, 2025; and

**WHEREAS**, the City’s Planning Commission held a second properly noticed public hearing on the proposed amendments on March 11, 2025; and

**WHEREAS**, the City’s Planning Commission met in a regularly scheduled public meeting on the proposed amendment on April 22, 2025, during which the Planning Commission voted 6-0 to forward a positive recommendation to the City Council regarding this matter; and

**WHEREAS**, although not required by City ordinances, the City Council heard courtesy public comment on the proposed amendments during its regularly scheduled meeting on May 7, 2025; and

**WHEREAS**, after careful consideration, the Council has determined that it is in the best interest of the health, safety, and welfare of the citizens of Taylorsville to approve the comprehensive update of the Taylorsville General Plan, including:

1. Repealing the existing 2006 Taylorsville General Plan in its entirety;
2. Adopting the following new sections of the 2025 Taylorsville General Plan: (a) introduction; (b) Community Character; (c) Land Use; (d) Mobility; (e) Economic Prosperity and Resilience; (f) Parks, Recreation, and Open Space; (g) Neighborhoods;



(h) Moderate Income Housing; (i) Environmental Stewardship; (j) Taylorsville Active Communities Plan; and (6) Taylorsville Expressway Stations Area Plan.

**NOW, THEREFORE, BE IT ORDAINED** by the Taylorsville City Council that the proposed comprehensive revision of the Taylorsville General Plan is hereby adopted.
