My name is Scott Walker and I have lived in Roy for almost 25 years.

Increasing taxes to not cut staffing- Tax increases is a normal part of life and due circumstances they always go up not down. I would support tax increase but I would like to feel like my voice is heard and I am appreciated for the support I give the city and community. An example would be people that have lived in Roy for 20 plus years get free access to the Roy Complex. A sliding scale with 25% off with living in Roy for 5 years, 50% off with living in Roy for 10 years, etc. It makes people feel good to get something for support. In reality most people living in Roy over 20 years are going to be the senior citizens and they would have the silver card and would get it free anyway. It's the little things that can be presented in a certain way to help people feel good about something and support decisions being made.

Zoning- (R3 & R4)- Multi dwelling's (condos, town homes, etc.) is appropriate in certain areas but not in single family home areas. Down 6000 there is no place to put these types of buildings. Do these changes affect the people making these types of decisions? Look at the maps it is all little houses except down by Winco. Changing R4 from 12 units per acre to 18 units to acre is not right or fair and a smoke show to the residents in that area.

Why are we making decisions to heighten everything and take out the feeling of what Roy has always been and has always stood for? Why are condos and town homes the answer to everything? Why is trying to shove as many people in the smallest space possible the answer?

Steve Parkinson and Brock don't listen to the residents. Isn't their job to work with the residents not against them and not care about their needs? I understand city code is important but if something has been in place for over 20 years and it it's causing any harm or concerns why can't it be talked about rather than black and white thinking? I had to move a carport that was on the side of my house. They took pictures and kept sending them to me and when I tried to talk with them, they did not care what I had to say. The carport was in place over 20 years. I tried showing them the original receipt and I did not feel I had a voice or they cared about my opinions or the hardship they were putting on me. The black white thinking came across with force not solution based with alternative ideas. I'm not sure

why or how these two individuals got so much control and power, but the first 23 years I lived in Roy I would do anything for my community and city now not so much due to the way I have been treated by these two individuals.
