Recognition of Exemplary Staff Member

Mayor Peterson recognized Zac Root from the Water Department, and his team. On May 19th, 2025, dispatch reported a leak from a 150lb Chlorine tank at the water treatment plant, with workers already in the process of evacuating upon arrival of the Fire Department Hazmat Truck 120. We would like to recognize Zac and his team for their quick actions in evacuating the affected area, protecting themselves and others from injury, notifying dispatch and providing pertinent information that resulted in rapid mitigation of the Chlorine leak.

Fire Chief Nate Thompson report:

- 72 calls in May, up from 55 in April, and a total of 384 to date.
- Aircraft Rescue Firefighting Day held with 10 new certifications and 13 recertifications. This is a unique training involving fuselage fire scenarios.

78 several months including:

- 79 • Fire Department: 3% increase.
- 80 • Sales tax allocation to the Eccle Ice Arena ends in December.
- 81 • Cemetery has switched to secondary water, saving on culinary water.
- 82 • If the General Fund Balance is over 10% at audit time, it is recommended by staff to transfer the
83 excess to Capital Fund account for use towards the Community Center and 2850 roadway.

- 173 • This is an application to the Community Impact Board (CIB) for a 100% matching grant to create a
174 Stormwater Master Plan, \$50,000 from North Logan over two years, \$50,000 from the CIB.

- 193 • Parcels predate zoning and are currently non-conforming; the intent to rezone these parcels is so
194 they become conforming.
- 195 • The updated zone will support existing lot sizes and potential subdivision development, while
196 improving traffic and safety by consolidating access off 1800 North.
- 197 • Planning Commission unanimously recommended the change after a public hearing.
- 198 • Applicant Steve Taylor in attendance.

- 213 • Proposing firework sales and discharge dates as follows. Division 1.4G (Class C) fireworks can
214 legally be sold June 24th through July 25th; and may be discharged between the hours of 11 a.m.
215 and 11 p.m., July 2nd through July 5th. Hours are extended to midnight on the 4th of July and again
216 on July 24th.
- 217 • Fire Marshals will be hanging closure signs along 1600 East by June 24th, and be removed by July
218 26th.
- 219 • At the sales stands, there are flyers and posters indicating the closed areas.

231 • The map is under development, and in response to House Bill 48.
232 • This will go into effect January 1, 2026, so we're dealing with it now to update old mitigation maps
233 to designate high-risk areas.
234 • We're working with the state to ensure the impacts to our bench residents will be the least amount
235 possible.
236 • Fire marshal's office is working closely with the insurance representatives from the state to ensure
237 that people are covered.
238 • The Utah State Fire Chiefs and the Utah State Fire Marshals are all working with the State of Utah
239 in developing these maps.

252 • To help recruit and retain employees, we're proposing to give 56 hours of annual leave to new full-
253 time employees and 42 hours to three-quarter-time employees upon hire; and reduce the years it
254 takes to achieve each accrual adjustment; more in line with other entities, including USU.
255 • Sick leave accrual remains unchanged.

286 in the community, along Main Street and along Wolfpack Way.

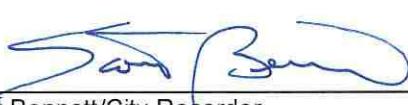
