## ORDINANCE NO. 2025-02 (Replaces 2025-01)

*An ordinance providing for the compensation of elected and statutory officers of  
Wales Town, Utah*

**WHEREAS**, Wales Town wishing to satisfy all public interests and comply with state law adopts a compensation ordinance of elected and statutory officers.

### **NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF WALES TOWN, STATE OF UTAH:**

1. Repealer. All previous salary or compensation ordinances regarding elected and statutory Officers hereby are repealed.
2. Compensation. The compensation of the elected and statutory officers shall be as follows:

**THE FOLLOWING PARAGRAPH IS ADDED:**

The above compensation amounts will include a 3% annual increase beginning on July 1, 2026 and continue for four (4) years, the final automatic increase being on July 1, 2029.

3. Payment. The Clerk shall pay each elected and statutory officer his or her monthly salaries after the approval of the Town Council.
4. Per Diem. Each member of the governing body shall receive mileage and per diem for all trips approved by the governing body according to the schedules adopted by the Utah Department of Finance, as may be approved by the Wales Town Council.
5. Effective Date. This ordinance shall become effective on the 1st day of July 2025.
