RESOLUTION 2025-06

A RESOLUTION OF THE CORMONT PUBLIC INFRASTRUCTURE DISTRICT ADOPTING FINAL BUDGETS FOR FISCAL YEARS 2024-2025 AND 2025-2026

WHEREAS, Part 6, Chapter 1 of Title 17B Utah Code Annotated 1953, as amended (“Fiscal Procedures Part”), governs the fiscal procedures for local districts, including the Cormont Public Infrastructure District; and

WHEREAS, on the Military Installation Development Authority (“MIDA”) Board created the Cormont Public Infrastructure District on January 7, 2025; and

WHEREAS, the Fiscal Procedures Part requires the Board of Trustees of the Cormont Public Infrastructure District to adopt a budget as soon as feasible after the district’s incorporation, and the final budget for Fiscal Year 2024-2025 is now ready for adoption;

WHEREAS, the Cormont Public Infrastructure District held a public meeting and hearing and adopted a tentative budget for Fiscal Year 2025-2026 on May 13, 2025; and

WHEREAS, the Cormont Public Infrastructure District has complied with the Fiscal Procedures Part in adopting both the initial and subsequent budgets, including providing proper notice and conducting a public hearing.

NOW, THEREFORE BE IT RESOLVED, by the Board of Trustees of the Cormont Public Infrastructure District as follows:

1. The attached final budget, as shown in column (c), for Fiscal Year 2024-2025 is hereby adopted.
2. The attached final budget, as shown in column (d), for Fiscal Year 2025-2026 is hereby adopted.
3. The Budget Officer shall certify copies of the respective final budgets for each fund for each applicable fiscal year and file those budgets with the state auditor within 30 days after adoption, as required by the Fiscal Procedures Part.
