**A RESOLUTION OF THE MIDA MOUNTAIN VILLAGE PUBLIC

**WHEREAS**, Part 6, Chapter 1 of Title 17B Utah Code Annotated 1953, as amended (“Fiscal Procedures Part”) governs the fiscal procedures for local districts, including the MIDA Mountain Village Public Infrastructure District; and

**WHEREAS**, on May 13, 2025, the MIDA Mountain Village Public Infrastructure District held a public meeting and adopted a tentative budget for Fiscal Year 2025-2026; and

**WHEREAS**, the MIDA Mountain Village Public Infrastructure District has complied with the Fiscal Procedures Part for adopting a final budget, including providing notice and holding a public hearing.

**NOW, THEREFORE BE IT RESOLVED** by the Board of Trustees of the MIDA Mountain Village Public Infrastructure District as follows:

1. The attached final budget, as shown in column (d), for Fiscal Year 2025-2026 is hereby adopted.
2. The Budget Officer shall certify a copy of the final budget for each fund and file it with the state auditor within 30 days after adoption, as required by the Fiscal Procedures Part.
