- Director Report

Tana Archer began the celebrations section of her report she asked two students to showcase their SEM project to the board. The students presented a hydraulic excavator. Personal professional development during the current school year resulted in a total of \$36,811 with one hundred percent of formal spring and fall observations completed. Teachers at North Star Academy selected Melissa Edman as their colleague to represent them as the LEA's 2024-2025 Teacher of the Year. Fifth grade students were invited to participate in Hope of America performing songs based on US History. There are 531 students registered for the 2025-2026 school year. Tana discussed the middle school elective offerings for 2025-2026. The LEA is hiring for the breakfast service, lunch preparation and service, and data clerk positions. The math curriculum for 7<sup>th</sup>-9<sup>th</sup> grade will be Carnegie Math after careful evaluation from the math curriculum committee. Summer

Tana Archer gave a report on the Positive Behaviors Plan for the 2024-2025 school year. She also reported on 2024-2025 Title IX Athletics. - Financial Review

Cathie Hurst gave an update on the budget where it lies 76 percent of the way through the year. Local revenue is higher due to interest. Cathie said that expenses are in line with how far they are into the year. Purchase services is high, but this was expected. Cathie said they will work on the amended budget and that will be noticed on May 31<sup>st</sup>. It is planned to make a transfer into the PTIF. Overall, the LEA'S budget is stable and in line. Cathie mentioned potentially having a discussion on building repairs and what is needed. Cathie said that Academica West is tracking anything that might be needed. 
