# Monthly Water Charge

- Monthly charge is a fixed fee based on meter size.
- New charge better reflects the fixed costs of utility operations and infrastructure costs.
- Applies to residential and non-residential customers.
- Rate stabilization is removed, resulting in a decreased monthly charge.

# Residential Water Usage Rates

- Maintain inclining block rate structure from existing rates.
- Block rates apply year-round rather than summer only.
- Less water usage in each block.
- Increase in CCF charge in each block.

2025 Rate Structure

Block 1	1 - 10 ccf
Block 2	11 - 30 ccf
Block 3	31 - 60 ccf
Block 4	>61 ccf

2026 Rate Structure

Block	Current
Block 1	1 - 5 ccf
Block 2	6 - 10 ccf
Block 3	11 - 40 ccf
Block 4	>40 ccf

# Non-Residential and Multi-Family Usage Rates

- Block rates no longer apply to non-residential and multi-family customers.
- Uniform rate structure, with a higher uniform rate in the summer.

# Example Monthly Water Rate Change Impacts

- Minimum and low residential use usually reflects indoor household consumption.
- Medium and high residential use usually reflects both indoor and outdoor water consumption.
- Non-residential uses vary greatly depending on how the water is being consumed.

Account Type	Monthly Usage	Meter Size	2025	2026	\$ Change
Residential Minimum Use	6 ccf	3/4	\$36.93	\$40.71	\$3.78
Residential Low Use	8 ccf	3/4	\$41.13	\$47.15	\$6.02
Residential Medium Use	21 ccf	3/4	\$81.13	\$104.77	\$23.64
Residential High Use	61 ccf	1	\$258.51	\$304.19	\$45.68
Industrial Use	8,040 ccf	2	\$19,911.04	\$24,704.40	\$4,793.36
Commercial Use	966 ccf	2	\$2,411.51	\$2,964.69	\$553.18

# Monthly Sewer Charge

- Monthly sewer charge is a fixed fee and is based on dwelling unit (residential) and equivalent residential unit (non-residential).
- New charge better reflects the fixed costs of utility operations and infrastructure costs.
- Rate stabilization is removed, resulting in a decreased monthly sewer charge.
- One ERU = 4 ccf for non-residential.

# Sewer Usage/Flow Rates

- Structural change from a waste-strength class rate to uniform usage/flow rates.
- Rate for residential is based on annual monthly winter consumption for December, January, and February.
- Rate for multi-family and commercial is based on 70% of actual water used.
- One ERU for commercial use is 4 CCF of water use.

# Water Quality Rates for High-Strength Dischargers

- Waste-strength class structure changing to per unit cost per pollutant.
- Addition of Ammonia and Total Phosphorus, per regulation.
- Pollutant rates are in addition to flow charge rate.
- These customers are typically industrial.

**Monthly Impact on Select City Customers**

Account Type	Annualized Average Winter Water Usage (CCF)	2025 Fee	2026 Fee	\$ Changes
Residential Minimum Use	2 ccf	\$21.34	\$20.82	(\$0.52)
Residential Low Use	4 ccf	\$35.46	\$37.94	\$2.48
Residential Medium Use	8 ccf	\$63.70	\$72.18	\$8.48
Residential High Use	15 ccf	\$127.11	\$132.10	\$4.99

\*Industrial, commercial and institutional charges include a base fee per ERU and 70% of metered water flow effective 7/1/2025. Due to variability of fees in this class, customer rates may be calculated upon request.

# Stormwater and Streetlighting Rate Changes

# Monthly Stormwater Charge

- No structural change to stormwater charge.
- 5% increase in monthly charge.
- Stormwater credit maximum changed to 25%.
- New stormwater credit applied to all new developments. Phased approach to reduce stormwater credit for existing over 25%.
- Reduction in stormwater credit will reduce future rate impacts to customers as cost of service is more fairly distributed.

Account Type	ERUs	2025 Rate	2026 Rate	\$ Changes
Single and Duplex <.25 Acre	All ERU	8.33	8.75	0.42
Single and Duplex >.25 Acre	All ERU	11.63	12.25	0.62
Triplex and Fourplex	All ERU	16.64	17.50	0.86
All other Parcels	Per ERU	8.33	8.75	0.42

\*1 ERU = 1 residential property or 2,500 square feet

# Monthly Streetlighting Charge

- No structural change to streetlighting charge.
- 15% increase in monthly charge.
- One ERU is one single-family residence or 75 feet of street frontage for non-residential properties.

Flat Rate or Block	2025 Rate per ERU	2026 Rate per ERU	\$ Change
<b>Base</b>	4.51	5.19	0.68
<b>Group 1</b>	6.86	7.89	1.03
<b>Group 2</b>	19.28	22.17	2.89
<b>Group 3</b>	53.02	60.97	7.95
