ORDINANCE 25-K, SEWER RATES

WHEREAS, Perry City, (hereafter "City") is a municipal corporation, duly organized and existing under the laws of the State of Utah;

WHEREAS, Utah Code Annotated 10-3-905, 10-6-160, 10-9a-509, 10-18-303, and other applicable law authorizes the City to impose fees for utilities and services;

WHEREAS, Utah Code Annotated 10-8-84 and 10-8-60 allow municipalities in the State of Utah to exercise certain police powers and nuisance abatement powers, including but not limited to providing for safety and preservation of health, promotion of prosperity, improve community wellbeing, and peace and good order of the inhabitants of the City;

NOW THEREFORE, be it ordained by the City Council of Perry City, UT as follows:

SECTION 1: Repealer. If any provisions of the municipal code previously adopted are inconsistent herewith they are hereby repealed.

SECTION 2: Amendment. Section "4.09.030 " is hereby amended as follows.

*An increase of 2% shall be applied annually on
July 01, starting July 01, 2025.

SECTION 3: This change in the monthly utility charge shall be in lieu of the adopted annual increase in the fee schedule for the year 2025. The annual increase shall remain in effect for future increases.

SECTION 4: Severability. If any section, subsection, sentence, clause, or phrase of this amendment is declared invalid or unconstitutional by a court of competent jurisdiction, said portion shall be severed and such declaration shall not affect the validity of the remainder of this amendment.

SECTION 5: Effective Date. This ordinance being necessary for the peace, health, and safety of Perry City, shall go into effect at the expiration of the 20th day after publication or posting or the 30th day after final passage as noted below or whichever of said days is the more remote from the date of passage thereof.
