### STAFF REPORT(S)

#### 1. 2025 Summer Series update, Lori

Lori told the board that due to the Murray Theater not being finished, that the HONK! performance was being moved to the amphitheater with the dates being July 7-12.

She also has added the Jersey Tenors to the concert series on September 5<sup>th</sup>. She told the board that she had canceled the contract with the Carpenters Platinum band due to them scheduling in both Salt Lake and Taylorsville close to their scheduled date at the amphitheater. She is also working on a contract with Lovin'Spoonful for September 20.

Caitlin reported that the secondary art show was held and there were 116 entries most from Murray High School. She will hang the winners of the show as the next ROD in City Hall. She told the board that the Storytelling Showcase was held on April 26 and there were 57 students participate with 19 moving on to Story Crossroads which is the county festival. She also reported that all the afterschool musicals were finished. Lori asked the board their thoughts regarding the afterschool musicals. She wondered if they should be made available every year to the schools as this support is popular with most of the elementary's. She explained that supporting arts education is one of the items listed in the ordinance, however,

Horizon Elementary has not participated in an afterschool musical for several years. Jessica mentioned that partnering with BTS (Beverly Taylor Sorensen) specialists was helpful however, not all schools have a BTS Specialist. Lori suggested that perhaps a neighboring school could perform their afterschool for Horizon. The logistics would be difficult.

Katie reported that some painting has been done, but the opening date has been pushed back to Oct.

Lori had Kim talk about the mural on the side of the Murray Theater and her vision along with the boards vision that was discussed months ago was to make it a community project. She reminded that board that we wanted youth artists from Murray High School to join us with her University of Utah Students on Fridays. Stephanie wanted to help as well and Kim reminded her that we had originally wanted all community members that wanted to participate to feel welcome. The logistics will need to be worked out with staff for a couple of scissor lifts etc. but is very aware of OSHA rules that will be strictly followed. Kim will bring more information to work out with the board and has asked that the mayor join us as well as they pick out a theme for the mural.

Lori said the Grand Opening of the Mansion/Museum was wonderful and all went well. Jessica brought the next set of pictures to hand to children at the museum, and Lori thought that perhaps it would be best to have the next drawing ready for July.
