

After much debate regarding the EyesOn case, the PI Board made the following determinations:

Ms. Celestial Burns - Notice of agency action regarding trespass, failure to notify, et al. (Accessed private property to obtain trash on multiple occasions). The GPS questions were already resolved with no action taken. A few of the Board members stated that they felt the behavior of the trash pulls was unprofessional and rose to a violation of privacy. Motion of unprofessional conduct by C. Burns set by Hullinger on 18 instances. All affirmed. Final sanctions: The motion was by Hullinger, seconded by Love, a letter of concern with a one-month suspension. Unanimously passed.

Ms. Samie Hardman - Refusing to display ID card, recommendation by BCI is a letter of concern. Chief Ferguson made a motion that S. Hardman did not commit a violation. The Board passed the motion. No action was taken/unsubstantiated. Motion to dismiss was passed unanimously.

Ms. Trinity Ceasar - Refusing to display ID card, recommendation by BCI is a letter of concern. Sgt. Elsholz made a motion that there was no violation. It was passed by the Board. No action was taken/unsubstantiated. Motion to dismiss was passed unanimously.

Ms. Christy Layne - Accessing license plate data via TLR. Recommendation by BCI was revocation of the license. Colby explained how BCI arrived at that conclusion. Motion was issued by Hullinger and the Board passed that it was a violation. Spencer voted nay. Regarding final sanctions against Ms. Layne: Spencer made a motion for a mere letter of concern and Chief Ferguson, Dr. Love agreed with it. Elsholz and Hullinger wanted to pursue possible suspension. Hullinger moved to amend the motion to include a \$500 fine with the letter of concern. Elsholz, Ferguson, Rice, and Hullinger carried the substituted motion. Love and Spencer voted nay.

Mr. Kevin Wyatt - A collection of violations committed by apprentices because of a failure to supervise (TLR access and trash pulls). Hullinger made a motion that Mr. Wyatt committed unprofessional conduct by allowing 18 trash grabs by a subordinate. Hullinger, Ferguson, Dr. Love, Rice voted yes. Elsholz and Spencer were nay. Motion regarding TLR access by Hullinger was unanimously approved. Final sanctions: There was much back-and-forth regarding the severity of Mr. Wyatt's actions. Chief Ferguson made a motion for a six-month suspension with a \$500 fine. It passed with Rice, Elsholz, and Love's affirmation. Sullinger and Spencer didn't vote.

Grant Roll recused himself during the EyesOn investigation/hearing due to an employee conflict.

Short break in the meeting from 1215-1223.

Trinity Renee Caesar - Applied to become a registrant. This was the argument between a criminology degree and a CJ degree from the previous board meeting. Hullinger first, Spencer second to approve. Unanimously passed.

Jim Elliott - Applied to become an agency agent. All documents were in order. Grant Roll first, Hullinger second to approve agency agent.

Chad Soffe - Notice of action: Falsification of government records, currently in diversion. Recommendation of revocation. Soffe argued that a diversion is not a conviction. Jorgensen demonstrated that since the charges were filed after the license was issued, it was possible to pursue the case. Elsholz made a motion that the Board found that unprofessional conduct occurred. Spencer seconded the motion. It was unanimously approved. All approved the sanction of a letter of concern.

Mike Funk - An individual didn't like the way that he attempted to serve papers. Spencer motioned to have it dismissed. All approved.

Joshua Massey - Would a PIA affect a Bail Enforcement license? Class A misdemeanor. Electronic communication harassment. Elsholz made a motion to revoke the license. All concurred. Motion passed.

Applicant on appeal from Chicago. Hullinger made a motion to table the case. All unanimously voted and upheld.

Spencer reading - Richard Taffet, documents in order. Motion to approve. Elsholz second. Passed.

Jonathan Guthrie, documents in order. Motion to approve. Elsholz seconded. Approved.

Leah Rosse - Documents in order, motion to approve. Elsholz second. Approved.

Elsholz reading - Ronald Beard, docs in order, motion to approve, Spencer second, approved.

David Olsen - Docs in order, motion to approve, Spencer second. Approved.

Corey Dennart - Docs in order, motion to approve, Spencer second, approved.

Christian Mickelson - Docs in order, motion to approve, Spencer second, approved.

Daniel Barfuss - Docs are in order, but hours are in dispute. Motion to deny with additional hours information necessary and then will approve. Spencer second. Approved.

Grant Roll reading - Paul De La Torre, hours are questionable, motion to deny with the possibility to approve with accurate info. Hullinger first, Grant second. Approved.

David Ferronato - Documents in order, motion to approve, Love second. Motion approved.

Dr. Love reading - Thomas Flannery, Bail renewal, docs in order. Love first, Roll second. Approved.

Sean Skogrand, docs in order, Love motion, Roll second, approved.

Chief Ferguson reading- Maria Caruso, docs in order, motion to approve, Spencer second. Approved.

Ed Rice reading - Brad Jenkins, docs in order, bail enforcement, motion to renewal, Roll second, carried.

Jacob Jenkins, bail enforcement renewal, docs in order, Rice motion, Roll second. Carried.

Vincent Castaldo, renewal recovery license, hours have no signature, motion by Rice, second by Hullinger. Denial passed.

Hullinger reading - Stanton Van Wagner, PI registrant, docs in order, Spencer second, approved.

Sierra Schilling, PI registrant, motion to deny with approval if current docs are provided. Second by Love.

Jonathan Buma, Agency license, former FBI, signed his own hours but has documentation to back it up, motion to approve. Roll second. Motion passed.
