County Fire Warden Jeremy Jorgensen provided a brief update of the 2025 fire season and other vital information. He introduced his Assistant Warden, Paul Benoit. There are currently no restrictions on the unincorporated areas of the county, however, that could change any time. He reported that 100% of fires in Emery County this year have been human caused. They are looking at increasing public awareness to encourage people to use "fire sense". There is currently a reg flag warning for Carbon and Emery counties for high winds and low humidity. No burn permits will be approved through June 22.

DISCUSS/APPROVE/DENY 2025 TAX RATES FOR EMERY COUNTY.

Clerk/Auditor Brenda Tuttle requested approval for the 2025 Certified Tax Rate for the General Fund, Library, Aquatic Center, and Assessing & Collecting as follow:

General Fund 0.003698 to generate \$7,741,677.00 Library 0.000429 to generate \$ 898,102.00 Rec/AQ Center 0.000068 to generate \$ 142,356.00

Assessing/Collecting 0.000463 to generate \$1,022,609.00

Commissioner Jensen talked about lowering some of the tax rates because of new potential sources of income from the Solar Companies and the Inland Port Authority. Brenda suggested having some discussions before changing anything as the budgets are set for 25. She added that once you lower the rate you can never increase it again. Lowering the rate would be a permanent decision for future budgets. Reducing the rates may affect a citizen's taxes by, maybe, \$10.00, but could severely impact the county. None of the potential sources have started to provide revenue to the county. The Commissioners will have discussions regarding the tax rates for next year's budget. Commissioner Jordan Leonard made a motion to approve the 2025 Certified Tax Rate for Emery County. The motion was seconded by Commissioner Dennis Worwood. The motion passed. Commissioner Jensen voted NAY.

Jacob Sharp, Manager CVSSD requested approval for the 2025 Certified Tax Rates for their General Operations and Interest and Sinking Fund/Bond as follow:

Cory Worwood, Weed/Mosquito Director, requested approval for an ongoing Russian Olive Invasive species Mitigation Grant. The amount of the grant is \$57,750.00 from the Utah Department of Agriculture to remove Russian Olives along the river bank on the western end of the county. Commissioner Dennis Worwood made a motion to approve the Russian Olive Invasive Species Mitigation Grant Agreement for FY July 1, 2025-June 30, 2026. DISCUSS/APPROVE/DENY ORDINANCE IMPOSING A TRANSIENT ROOM TAX NOT TO EXCEED 4.5% ON SHORT-TERM RENTALS OF ACCOMODATIONS AND SERVICES AS AUTHORIZED BY UTAH CODE 59-12-301(1) (A)(II).

Travel Director AnnDee Mead explained an Ordinance imposing a Transient Room Tax not to exceed 4.5% on short-term rentals of accommodations and services as authorized by Utah Code 59-12-301 (1) (a) (ii). This authorizes counties of second through sixth class to impose a transient room tax (TRT) on charges for accommodations and services. Emery County is a county of the fourth class and desires to impose this tax at the maximum allowable rate in order to promote tourism and mitigate the impacts of recreation and visitor use. This would include short-term rentals of tourist homes, hotels, motels, trailer courts, and similar accommodations. Revenue from this tax would be used exclusively for the purpose of establishing and promoting tourism, recreation, film production, and conventions, acquiring, constructing, or maintaining tourism-or recreation-related facilities and infrastructure. Also, mitigating impacts of recreation, tourism, and conventions through support for emergency services, law enforcement, road repair, and solid waste management, as well as, making payments for bonds for such purposes. Commissioner Dennis Worwood made a motion to approve Ordinance 2025-6-17 imposing a Transient Room Tax not to exceed 4.5% on short-term rentals of accommodations and services as authorized by Utah Code 59-12-301 (1) (a) (ii). The motion was seconded by Commissioner Jordan Leonard. The motion passed.
