### 1. HEBER VALLEY EIS UPDATE – CRIAG HANCOCK

A. **SUMMARY:** Craig Hancock, Utah Department of Transportation Project Manager, presented a progress update related to the Heber Valley Bypass project. Craig explained the recent municipality public meetings they have presented in and how certified mailings were sent to land owners potentially affected by the projected and are continuing to coordinate public outreach opportunities. Craig continued to describe the two current alternatives going through the EIS process including a review of the connection points at 900 N and at College Way. Currently UDOT is in the detailed alternatives evaluation phase and are hoping to have a preferred route established by fall 2025.

### 2. DISCUSSION OF A POTENTIAL WASATCH COUNTY E-BIKE ORDINANCE #25-05 – DUSTIN GRABAU & DOUG SMITH

A. **SUMMARY:** The Council convened the Transit and Transportation Subcommittee to discuss potential e-bike regulations in an attempt to reach a level of conformity with Heber City and Midway City. Doug Smith, Wasatch County Planning Director presented current state code, implications of adopting code, different classes of e-bikes, e-ohv motorcycle description, and

the adopted ordinances from Midway City and Heber City. Council advised having a first reading of the ordinance on June 18<sup>th</sup>, 2025 regular council meeting.

**Council Chair McMillan invited attendees to comment.**

- Pam Shivers asked if e-bikes and horses will be sharing the same trail.
- Heath Norm from Switchback Sports expressed desire to work with local law enforcement to help spread education about the laws of e-bikes on trails.

**3. DISCUSSION REVIEWING ROBERT'S RULES OF ORDER – DUSTIN GRABAU**

A. **SUMMARY:** In the interest of pursuing the county's value of excellence, the council expressed a desire to review Robert's Rules of Order. Dustin Grabau, Wasatch County Manager, shared the guidelines and provided recommendations for how some of the basic principles apply to Wasatch County. Dustin explained the basic definitions for motion, second, amendments, role of the presiding chair, general procedure for handling a main motion, and general rules for debate. Councilmember Rowland suggested that anytime a new councilmember is elected that this be included in the councilmember training packet.
