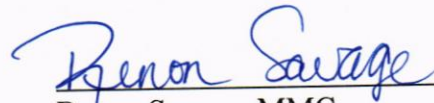

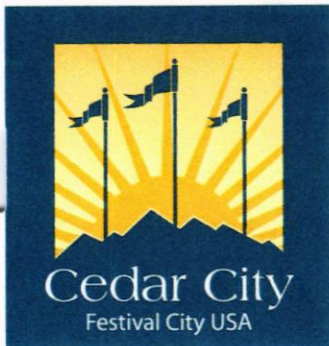
APPROVE MINUTES DATED MAY 7, 2025: Cox moved to approve the minutes dated May 7, 2025; second by Melling; vote unanimous.
