AN ORDINANCE OF THE EMIGRATION CANYON COUNCIL REPEALING CHAPTERS 19.08 F-1 FORESTRY ZONE, 19.44 R-M RESIDENTIAL ZONE, 19.56 C-1 COMMERCIAL ZONE, AND 19.86 HISTORIC PRESERVATION FROM TITLE 19 ZONING

RECITALS

WHEREAS, Emigration Canyon is a municipality and has authority to adopt land use regulations, pursuant to Utah Code § 10-9a-501 in accordance with the Municipal Land Use, Development, and Management Act, Title 10, Section 9a, Utah Code; and

WHEREAS, the Council deems it necessary to amend its land use ordinances to eliminate zones that are not used on Emigration Canyons adopted zoning map;

WHEREAS, the Emigration Canyon Planning Commission held a public hearing on July 10, 2025 to consider repealing Chapters 19.08 F-1 Forestry Zone, 19.44 R-M Residential Zone, 19.56 C-1 Commercial Zone, and 19.86 Historic Preservation from Title 19 Zoning (the "Proposed Action") in accordance with Utah Code §§ 10-9a-205and 10-9a-502; and

WHEREAS, the Planning Commission has recommended that the Council repeal Chapters 19.08 F-1 Forestry Zone, 19.44 R-M Residential Zone, 19.56 C-1 Commercial Zone, and 19.86 Historic Preservation from Title 19 Zoning to eliminate unused zones and chapters and for the protection and preservation of the public health, safety and general welfare.

BE IT ORDAINED BY THE EMIGRATION CANYON CITY COUNCIL as follows:

- 1. Chapter 19.08 F-1 Forestry Zone is hereby repealed.
- 2. Chapter 19.44 R-M Residential Zone is hereby repealed.
- 3. Chapter 19.56 C-1 Commercial Zone is hereby repealed.
- 4. Chapter 19.86 Historical Preservation is hereby repealed.
- 5. <u>Severability</u>. If a court of competent jurisdiction determines that any part of this Ordinance is unconstitutional or invalid, then such portion of this Ordinance, or specific application of this Ordinance, shall be severed from the remainder, which shall continue in full force and effect.

- 6. <u>Direction to Staff</u>. Staff are authorized and directed to take such steps as may be needed: (a) for this ordinance to become effective under Utah law, including but not limited to compliance with the requirements of Utah Code § 10-3-711; and (b) to finalize and post the ordinance to Municode, including but not limited to making non-substantive edits to correct any scrivener's, formatting, and numbering errors.
- 7. <u>Effective Date</u>. This Ordinance will take effect immediately upon publication pursuant to Utah Code § 10-3-712.
