4. Public Comment:

Ordinance No. 16

Greg – we’ve been talking about this for a while. The future of this town will depend on people filling these town council roles. This is a way to incentivize.

Amy Pendleton, 277 Luzern Rd. – feels this compensation is minimal. She’s thankful we’ve had people to volunteer over the years. She personally thinks the compensation should be even higher. She doesn’t see anyone else stepping up to fill their shoes.

Joe Smith, 347 Luzern Rd. – it’s ridiculous that it’s only happening now. She wants to second what Amy has said.

Chris Pendleton, 277 Luzern Rd. doubles her comment.

Claire Osborne, 275 St. Moritz – Claire’s lived here since 2003. She feels that unless we compensate people, we will have to pay more for contracted service. It’s important for us as a town moving forward to incentivize help. HOA is a more expensive option.

Matt Hermann, 230 Edelweiss Ln. – he wants to thank the council for responding to his emails regarding compensation. He is trying to help and not hurt the town’s efforts. He thinks the compensation for the council is reasonable. He suggests that we post notices on the side of the road. He’s concerned that the posting at the pumphouse and the post office box is not sufficient.

Greg – we are exceeding the requirements for noticing through the post office, the pumphouse, individual emails, Utah public notice website, the town website.

Matt feels we are in violation because we aren't providing an adequate physical location for public noticing. Bart Smith responded that the town's posting at the Midway post office is consistent with the state requirement, and is the same place Midway uses for their postings.

FY2026 Budget

Matt asked about whether we are running a deficit. Bart Smith clarified the budget with regard to this and several other questions, and recommended Matt review the budget documents provided online that cover the topics he brought up.

Greg- taxes will go up with the goal of putting \$30K into Reserves. The amended version uses that \$30K for road repairs.

Council member Dixon moved to adjourn the public hearing. Council member Jacobson seconded the motion. The motion passed unanimously. The hearing was adjourned at 6:39pm. The regular town council meeting will begin after a short break.
