Council Member Belliston made a motion to approve an Ordinance for Zone Change Z-25-16 to update the existing PUD-C and PUD-R located at 1075 E Telegraph Street approving only portions as follows: Pod 1, Pod 2a, and 2b; approving setbacks as outlined in the staff notes; an amenity plan that is consistent with other PUDs at 33% must be in before 34% permit being pulled for both pods. Bulloch Street to be fully constructed with curb, gutter, and sidewalk along its entire frontage, with the exception of any landscaping requirements on the South of Bulloch Street. Future submittals for 2C or anything south of the Bulloch will include a contract that sets date, time, terms and other details of water rights. No approval is granted for any density allocation or any development south of Bullock Street or for Pod 2C as part of this motion.
