Mayor O'Hare said Okay. Good evening, everybody. My name is Mayor O'Hare. We'd like to go ahead and open up our public hearing to amend the 2024-2025 budget for Snowville. Last month, everybody remembers that we had the Snowville town government unit, 2025, 2026. Fiscal Year, everybody was given this. I don't think there was anything that the town council had it added or anything because there was nothing sent. We had no comments from the town. Tammie said so this public hearing is for last year the budget we're in now that we just need to amend it and balance the amounts across the accounts that have money and that those that don't. So I just we just need to let the public know that we will be moving \$5,000 from the administration budget down to the sanitation budget. They were a little bit over. They're going to be a little bit over come June 30, and then also we will be moving so in the culture and recreation budget, that's with the Park, Recreation and Cemetery. Those three, the Cemetery has gone over just a little bit. So within that we'll be between the Park and Recreation. We just need to adjust some funds there to balance out the Cemetery.

Mayor O'Hare asked Do we have the amount for that one?

Tammie said to be safe? Let's just say \$2,000 that's more than enough.

Mayor O'Hare said so \$2,000 from Park slash Recreation, Rec to Cemetery.

Tammie said yeah, and then, just so everyone's aware, we for the B&C Roads, we did move money from their P.T.I.F. is budget or account of \$43,000 over to cover the expenses previously that you had, but that was done back in January, so, but you don't have to have a public hearing. You're waiting for that. That's just for your information, because that's tax money that, and the numbers we talked about last month, we're all still correct.

LuAnn said We're good.

Tammie said yeah, so you're good with that.

LuAnn said the milling. Okay.

Tammie said so that's all. We're not over very much

on any of the others. So just those two. Basically the cemetery was just over a little bit.

And, yeah.

Mayor O'Hare said the sanitation.

Tammie said between the two of them.

Mayor O'Hare asked So with the sanitation, we were over. So we're not taking in enough money from the town to pay for it.

Tammie said What happened is, when we budgeted last year, we but I think the price increased during the year, but we didn't account for it.

Mayor O'Hare said Okay.

Tammie said so; it's all in the new budget. It. We moved it up a little bit.

Mayor O'Hare asked the Town Council. Have any questions for Tammie on this?

Rod said, Sounds like you guys have done a bang job and kept it, didn't we in the pink? So that's good.

Tammie said Yeah.

Mayor O'Hare said we need it. Well, we don't have any citizens here, so no.

Tammie said So, just basically to let the community know about Mayor O'Hare said okay.

Tammies said with their tax dollars.

Mayor O'Hare said So if that's it, then we'll go ahead and close the meeting.

Tammie said Thank you.

Mayor O'Hare said Thank you.

Mayor O'Hare said I'm sorry. I shouldn't even ask you. Did you have anything else?

Mayor O'Hare said Okay, like to welcome everybody to the Wednesday, June 11, 2025, town council meeting for Snowville town. I'm Mary O'Hare. We have Trish Arbon, council member, Rod McGary, LuAnn Johnson, Heather O'Hare, as long as well as our clerk, Tammie Morgan, also like to recognize our chief of the Fire Department, Jed Pugsley. We also have our maintenance manager for our park here, Matt Wilcox. And I don't think we have to excuse anybody right now, so we're going to go ahead and open up the meeting with the pledge. Trish Arbon led us in the pledge, and then Rod McGary will give us our prayer.

Trisha said I pledge allegiance to the flag of the United States of America and to the republic for which it stands, one nation under. God indivisible with liberty and justice for all.

Rod said our dear kind, Heavenly Father, we are truly thankful this day for blessings and for guidance and being able to meet as a town council, and at this time, we pray for thy insight and guides to direct our paths, to help the members of this town to have greater appreciation, love for one another and appreciation for the town that they live in, help us to set forth the guidelines and the practices needed to make it so we pray that you may be guided by thee. Pray for each member of our town and those about that they may feel thy love and blessings too, and pray for guidance and protection for all we ask in the name of Jesus Christ. Amen.

Mayor O'Hare said Amen.

Mayor O'Hare said Thank you, Trish, thank you, Rod.

Everybody was town council was sent the acceptance of the agenda. Oh, before I start, I always have to say this. So just let everybody remind everybody that this is a hearing, or this is a meeting for the town council to make decisions on the town. This isn't for them to vote on stuff for the town. If you have any comments, we please ask that you wait till the end of the meeting, and we will open up the comments for comments only if there's any time you want to address the town council and ask questions. We ask that you please be put on the agenda so we can give you ample time to do so. Thank you. So the town council has given was sent the agenda for this week, as well as the minutes from the previous meeting of May.

Was there any additions that everybody was able to see that and read that? Was there any additions anybody had?

LuAnn said no.

Mayor O'Hare said I want to make one addition, hold on.

Where are we at? Eric he emailed me and asked if his wife could have 10 minutes to address the town council. I said yes, but we it's she just wants to address the town council, so we're gonna give her 10 minutes before he comes in.

LuAnn asked about what?

Mayor O'Hare said that's what I'm pulling up right now so, his wife works at the family place in Cache Valley, and she has been tasked to visit community governing bodies in Northern Utah and share a presentation on mental health first aid. So that's what she wants to just address the town council for about mental health first aid. So if they show up, then she will before, before Eric's time.

And so, anybody else have anything to add? Okay, if I get a motion to accept the minutes, I'm sorry, the agenda for June, and the minutes from May.

Trisha said I make a motion to accept the agenda with the following, with the addition for the 10 minutes for Eric's wife, and the minutes from May.

Mayor O'Hare said I have a motion from Trish. Do I have a second?

Luann and Rod both said second.

Mayor O'Hare said I have a second from LuAnn and Rod. All in favor. Any opposed? Okay, we passed.

And Kjerstin, we're gonna town website update.

Kjerstin said I printed this off. It's kind of hard to read, so I'm gonna read it to you, but this is like a skeleton of a website. But I want your feedback so we know what sections you want added. So this is the first page is like the home page, so up at the top the sections that you can't read. It says, Home, Cemetery, History, Town Council, contact, pay, water bill, and more, and under more, there's like town ordinances and documents. And then we'll put the Parks, the Parks page two, so under the picture, there's an events calendar. So far, the only event is the 4th of July, but we'll add, like, town council meeting and anything else that people want to add. And then there's like, he added, he embedded the current weather and driving directions that are on the main page.

On the second page that you have. It's a sample of the cemetery page where, if we get the plot map, we can upload. And there's actually a way we can make it so people could either contact or reserve plots or paper plots, or there's a way he can embed that into the website.

LuAnn said We can't do that online, though; they have to come out in person to get the plots.

Kjerstin said Right, yeah.

Matt said they would put in a request.

Kjerstin said They would put in a request email to Yeah. Or we can just put it informative. This is where people are buried, or however the information is given to us.

Matt said we can and it will be searchable. So they'll search like a last name, and they'll see or that last name is buried.

Kjerstin said then a history. He pulled this just off of online. So I'll probably try to reach out. Who would be the best person to contact that we could get, like, a brief history of Snowville.

Rod said Well, there's a whole book that was put out the Larkins.

Kjerstin said the Larkins?

Rod said yeah, Garn, they have a whole book.

Kjerstin said Where could I get? Is there a copy I could borrow or something?

Rod said talk to Garn, Garn Larkin.

Kjerstin said Garn Larkin, okay.

Rod said they our out there.

Kjerstin said So we'll have, like, a little history page, and then there's a town council page. So I need a picture of all of you and the spelling of your names, at least.

LuAnn said no picture you put my name in.

Kjerstin said Oh, come on.

LuAnn said no picture for me.

Kjerstin said so and the contact, we can put just the main email, email, if you don't want, like people to specifically be able to email whatever info you want, just so that people like informative. We were just looking at examples of other towns and what information they have. So that's where you're going off of. So the names there are just when we pulled in that, when he embedded it, it gave examples. So obviously the mayor is not Jane Anderson or whoever's written there. So those are the only pages that we had kind of customized at this point. So now I just wondered if there were other.

Matt said we have to wait for the government to approve the domain. So they told us somebody could be getting an email. Whoever it would be.

Mayor O'Hare said the town that gets it.

Matt said it'll be from like log in.

Mayor O'Hare said Could you tell me the tabs again at the top. Kjerstin said the tabs again at the top are Home, Cemetery, history, Town Council, contact, pay water bill, more.

Mayor O'Hare said and then more.

Kjerstin said drop down menus and Documents and Park.

Mayor O'Hare said Oh, so the ordinances will be there. We need to also add town minutes.

Kjerstin said town minutes, okay.

Mayor O'Hare said yeah, and the agenda, because that way, because we have to post the agenda and the minutes in certain places, and this will be a place that we can post.

Kjerstin said so meeting minutes and agenda.

Mayor O'Hare said yeah.

Kjerstin said okay.

Matt said hopefully by next the next town council.

Tammie asked something on the front page would be like, the dumps open from, you know.

Mayor O'Hare said we want to call it the Trash drop.

Kjerstin said yes.

Mayor O'Hare said Don't call it the dump or the landfill. Trash wasn't that what we decided, Trish?

Trisha said trash drop, yes.

Kjerstin said do they have to contact her in their own services?

Trisha said there is a sign out there.

Matt said general information they need up, okay? Like, a general information this page.

Tammie said Yeah.

Matt said they just need information.

Tammie said so, like, if there's fire burnt, like, you can get burn permits, just, yeah, or remove your garbage. If there's snow on the road, some snow plow doesn't hit them. Just that kind of stuff. Kjerstin said okay, yeah, and pay the water bill, there will be a tab at the top that they can click, and it will just take them to the website, the Express Bill Pay. And we can also add a button, can't we own the main page? So it's in two places, so hopefully they can find it.

Mayor O'Hare said Trish has got, you got the picture? Okay.

Well, this is the town dome, but it's got all the information on it. Trisha said There's two pictures. So I'll get your number,

Kjerstin said yeah, just text it to me. That's perfect. Um, yeah. So if you think of anything, let me know.

Tammie said Can you put something about the water too. Like, just like the city water.

Matt said the city water.

Kjerstin said okay.

Mayor O'Hare said Yeah.

Tammie said, like, if they need to get a new hookup.

Kjerstin said Yeah, okay.

Mayor O'Hare said like, a request for hookup or.

Trisha said the waste drop site.

Mayor O'Hare said Waste drop site, that's what it's called.

Kjerstin said Yeah.

Mayor O'Hare said, Instead of trash.

Kjerstin said okay.

LuAnn said we're not gonna end up taking their just green.

Kjerstin said Just, yeah.

Trisha said anything that will burn.

Kjerstin said Then we can put the instructions.

Trisha said Pit, and then whatever I deem.

LuAnn said, but we're not taking fridges and couches and chairs and all that.

Tammie asked Kjerstin What was your question?

Kjerstin said my question.

LuAnn said the book is like this big, just so you know.

Kjerstin said okay, but as far as the part goes, at some point, we're gonna clean out all the broken stuff like those bleachers, the stuff that's in the sheds that we don't use.

Trisha said Put it in the pit.

Kjerstin said if there's a couple broken picnic tables and stuff that I think would be burnable. So, how can we schedule to do that. Trish said I will just give you my number.

Kjerstin said okay. I don't know when we'll get to that.

Trisha said, But if people are reaching out to me.

LuAnn said the dump is for the garbage, and the thing is full.

Trisha said Yeah, it's on my list. Call Rupp's to come get it.

Kjerstin said so, okay, perfect. Um, as far as the website goes, I talked to Stacey, and we didn't get it for sure vote on if we want the full integration of the Express Bill Pay or the part.

Mayor O'Hare said right, because we had some questions from last month on that, correct, I don't have my.

Kjerstin said Oh, and maybe I didn't get how much we asked you to find out. She told me that she would just put it for it to be voted on again.

Mayor O'Hare said so, I didn't, yeah, there, but there was, let me pull the minutes up.

Trisha asked Kjerstin Can you remind me what the A part was and what the B part was.

Tammie said the A part was you, they could just, they had to know the amount of their account number, then no all that.

Trisha said, and the B part, it would all just pull up. But it was a matter of what the different price.

Tammie said yes, definitely more for like, to be able to pull all of it up.

Trisha said Oh, our, I think our question was, do we have to sign a contract, or can we start out with.

Kjerstin said right.

Trisha said If we don't like it.

Kjerstin said yes, okay.

Trisha said Can we cancel?

Kjerstin said so, I'll have to get that still. I have it here, right here. Trisha said okay, so when you find that out that I think we can vote.

Kjerstin said okay, perfect.

Trisha said because we don't want anyway.

Kjerstin said so, we're not gonna, well, I think we should still be fine.

Matt said on the name I did, snowville, town.gov.

Tammie said yeah.

Matth said I just guessed.

Kjerstin said yeah.

Tammie said Well, that's perfect, as long as you spelled Snowville right.. Matt said Well, I can change it still, I just.

Trisha asked Are you spell checking his work? Yeah, so as soon as we find out those prices and if we locked in or not, then.

Kjerstin said yes, yes.

Trisha said we wonder about that.

LuAnn said I think what you said was six months for the trial period, and after six months.

Kjerstin said that's what we were hoping, right? We did that we could do a trial. Yes, yep, okay.

Mayor O'Hare said yeah so the contract.

Tammie said I can't remember.

Kjerstin said I have it. How much will it cost for travel? What's the 65 cent fee for.

Mayor O'Hare said oh yeah.

Kjerstin said Can the town, cover the fee. Why is there an ACH fee as well? And what's the contract.

Mayor O'Hare said on the contract? Yeah, is there a contractor.

Kjerstin said so that you'll have the information before the next meeting? So, yeah, okay.

Matt asked do we just get the information to you or Stacey here? Mayor O'Hare said Yes, just send it to Stacey, and she'll forward it to everybody.

Tammie said or the email.

Mayor O'Hare said yeah to the town email, and then that way, she'll forward it to everybody when she gets it, and then everybody will have it.

Kjerstin said Okay, any other comments on the website that i can add?

Heather asked no, but if we have anything, is there a way to contact you?

Kjerstin said Yes, yeah, you can text me or email me.

Trisha asked What's your phone number?

Kjerstin said 435.

Mayor O'Hare said wait, what this is public knowledge, so everybody that reads the minutes is gonna have your phone number.

Kjerstin said That's fine. Okay, go right ahead. They can contact me if they have questions on the website.

Mayor O'Hare said That's right.

Kjerstin said 57575409.

Mayor O'Hare said because this the our minutes goes out to everybody in the state of Utah, so you know that, yeah, okay,

I'm not even gonna go there. Perfect. Anybody else have any questions for Kjerstin?

Mayor O'Hare said thank you so much.

Kjerstin asked do you need us for the park. Or are we good? I don't think we have any questions.

Mayor O'Hare said nope, we'll get down to that part. Or, well, yeah, do you guys might as well go ahead and hit it if you guys need to leave.

Matt said So we changed the toilet. Everything's Yeah.

Kjerstin asked Do we build that to the maintenance or to the park? Or does it matter?

Mayor O'Hare said for just put you you just send your hours in, yeah.

Kjerstin said But if you could make a difference.

Mayor O'Hare said if you could put maintenance that way, because we have, you know, because I call Eddie, and then Eddie tells you, hey, I need this fixed or whatever, so we can have it as maintenance instead of as Park duties.

Kjerstin said Yeah, okay.

Mayor O'Hare said so anytime there's maintenance work that you do for Eddie didn't just mark it as maintenance, then she can.

Tammie said then it doesn't come out of the hours.

Mayor O'Hare said yeah. or it comes out of the maintenance.

Matt said yeah.

Tammie said it comes out of different funds.

Kjerstin said Okay.

Mayor O'Hare said Perfect.

Kjerstin said okay.

Mayor O'Hare said thank you for that too, because it looks.

Really good.

LuAnn said It does it looks fabulous.

Kjerstin said I really have tried.

LuAnn said really good.

Kjesrtin said well, if there's anything else we can do.

LuAnn said okay, thanks you guys.

Mayor O'Hare said So the vote on the Express Bill Pay A or B is going to be pushed to next month. So the those are questions. Questions are answered, yep.

Mayor O'Hare said so the bell repair at the park, and signs for the bell, don't climb, does everybody? Was everybody aware of the incident that happened?

LuAnn asked did it break the bell?

Mayor O'Hare said Yeah, the bell fell, landed and crushed the young girl's hand.

Heather said which is weird, because the day before that, I saw four people standing around. They're messing with it, adult people, which I thought was really strange.

LuAnn said so we need to make it so that it's attached.

Mayor O'Hare said so, yeah, so I contacted it needs to be welded.

Trisha asked When did that happen?

Mayor O'Hare said this happened a week ago, yeah.

LuAnn said maybe 10 days.

Trisha asked so what happened?

LuAnn said there was a group of kids that were here.

Mayor O'Hare said yeah.

LuAnn said they weren't watching them. And the kids climbed up on it, and the Bell came off, and it squished a good little girl's hand.

Mayor O'Hare said It broke three fingers.

Tammie said I guess they went to the diner and they left their information there.

Mayor O'Hare said Yeah, I have everything here. I have the letter.

Trisha said your own risk.

Mayor O'Hare said or don't climb.

LuAnn said No. I mean, you should watch teacher. The teacher wasn't watching them.

Trisha said Oh, really.

LuAnn said yeah.

Trisha said I don't think that's our responsibility.

Mayor O'Hare said It's not and like I said, I've contacted the attorney. Let's send him an email.

He hasn't got back to me yet, but I did get a narrative from the lady on my phone, and they also filled out a piece of paper that I have as well for the attorney that basically, they said it was, you know, she was climbing up there, climbing. And I explained, you can't, shouldn't be climbing on a memorial, because that's 18, what, 67 Bell.

LuAnn asked was she nice? Or was she?

Mayor O'Hare said very, very nice. They were very apologetic that the Bell was broken.

Trisha said Okay.

Mayor O'Hare said so, yeah.

Trisha said definitely, we need to get something.

Mayor O'Hare said I had AJ go over look to make sure. And it's, the Bells, like over 200 pounds, it's heavy, so it's not going anywhere.

LuAnn said well, I know a really, really good welder.

Mayor O'Hare said Kyler said he could weld.

LuAnn said he name is Hayden. He does a fabulous job at welding. He's like a pro.

Mayor O'Hare said well, yeah, I talked to Kyler because I didn't know anybody else.

LuAnn said yeah, that's good too.

Mayor O'Hare said Kyler said he could do it. But if you guys want what, soon as we get bid on it, then we can get it fixed.

LuAnn asked how are we going to make it stay up there?

Mayor O'Hare said For people climbing on there?

LuAnn said Yeah so it doesn't fall off again.

Mayor O'Hare said That's what I'm saying. We got to weld it. LuAnn said you're gonna weld it to the.

Mayor O'Hare said yeah, it was welded already.

LuAnn said to cement.

Mayor O'Hare said No, no. Up back, there's a metal bar. It comes across, it goes down.

LuAnn said it got knocked it right off the bar.

Mayor O'Hare said Yeah, it came right off. You can see where the where the U hook goes over the top of the pole, and the U hook came down to the bell, the top of the bell. And you can see the top of the U hook, where the where the welds were, and it just the welds broke.

LuAnn said Oh, my heck.

Mayor O'Hare said So I don't know if it's just, I don't know how long ago they welded it.

LuAnn said probably a long time ago.

Trisha said probably when they put it up.

Mayor O'Hare said where people pushing on it, trying to ring it, probably, I'm thinking, probably is what broke it.

Heather said But it's weird that I saw four people just stand there messing with it right the day before. Literally, it was weird.

Mayor O'Hare said yeah.

Heather said they were, and I was like, What are they doing?

Mayor O'Hare said If anybody sees anything like that in town, stop and ask a question. It was like yesterday. There was a truck out here sucking water out of our fire hydrant to the back of a of a bucket, you know, and mixing all this.

Tammie said AJ stopped them too.

Mayor O'Hare said Right over here across by Mollie's, it was the county they were doing weed control, and they were out there filling up to do their weed spraying for but I told him, I said.

Tammie said, but they claim to have an agreement, and I don't think they have an agreement with us.

Mayor O'Hare asked Jed, do they have an agreement with us? Trisha said Yeah they might have one with the fire department.

Mayor O'Hare said So I stopped and talked to him, because I'm like, well, they're like, Well, we're with the county. I'm like, Well, I didn't know that, because your truck is not marked with the county. You know, it's just so.

Tammie said still I mean, it'd be different, you as citizens are paying for that water.

Mayor O'Hare said right?

Tammie said yeah.

Mayor O'Hare said yeah so I guess we need to find out.

Trisha said they probably we're using it. Because they were going around town spraying.

Mayor O'Hare said They were they were spraying the noxious weeds.

Trisha said I don't really have a problem with that. If they're spraying the weeds. I mean, the county provides the spray, and we have an issue with weeds out here that we need to get on top of. So anybody else? Yeah, I don't have a problem with that. That's we gotta, we gotta have some help to get the weed situation under control. My dad, Brent. I mean, it's Brent when. Over and spray at the landfill.

LuAnn said he sprayed again today. He sprayed three times in the landfill, now.

Trisha said yeah, and my dad's been spraying the road and the county. We reached out to the county to have them come spray, because it's out of hand.

LuAnn said that's probably why they came.

Trisha said That is why they came.

LuAnn said there is noxious weeds everywhere.

Trisha said yeah, they probably should have had their truck marked, but they were spraying for the town.

Mayor O'Hare said yeah, when I found out, they were spraying for the town. I just left them alone. I said, Okay, thanks, and then, but because I don't know the contract.

Trisha said that would be kind of low getting water out of there. Mayor O'Hare said yeah, so on the bell,

what does the council think about signs we put?

LuAnn said Yeah, I think we need a sign.

Mayor O'Hare said but what kind of where are we gonna put the sign? How are we gonna put the sign? How we don't want to really mount it to the to the memorial.

Trisha said I we should have something kind of like what we did for the landfill right outside where they walk in, just mount it to the fence there that says, Do not climb.

LuAnn said Stay the hell off the bell.

Trisha said Off the bell.

Mayor O'Hare said That's a good one. I like that. Stay the hell off the bell.

Trisha said You are at your own risk, Snowville Town is not responsible this is no a toy. If your kid gets hurt on your toys. We just need something.

Mayor O'Hare said I will come up with wording, and I'll send it to everybody, and you guys let me know if that's okay.

Trisha said then we can just post it right on that gate.

Mayor O'Hare said then I'll go down and have it. Let's post it. I'll go down and have it printed up once we get approval on it.

Trisha said Yeah, I can pick it up, and we can get it. We can get it easy enough problem solved.

Mayor O'Hare said so you guys want the wording to say, Stay off, stay the hell off the bell. In so many words, stay off bell.

LuAnn said if they see a swear word on the sign, they might look at it.

Mayor O'Hare said anything inside of the of the park, okay.

Trisha said basically, enter at your own risk. It's like when you go up to ride at somebody's arena, you know, a lot of people have it posted now, you're here at your own risk. We are not responsible. You're welcome to use it, but this is this.

Mayor O'Hare said Yeah, real quick, yeah. And I'm also going to look at some other towns, town ordinances, or town places.

Trisha said I'm sure other people have it posted all the time.

Mayor O'Hare said Okay, anything else on that? Anybody? No, okay, so vote to amend the budget. So again, we had the public hearing just prior to this and the budget. Did anybody, any town council members, have the questions? Tammie, anything you need to say before we put it to a vote?

Tammie said No, we already discussed it. So, just to make those changes, and then the next one is just to set the budget for the next year.

Mayor O'Hare said Okay, so on 2024, we're changing, we're going to be moving \$5,000 from the admin to the sanitation.

I thought she said \$5,000 from the admin.

Tammie said \$5,000.

Mayor O'Hare said \$5,000 from the admin to sanitation. Then we're going to be moving \$2,000 from the Park slash Rec. to the Cemetery, and then just for FYI, \$43,000 from the P.T.I.F. over to the Roads for the projects we're doing now. So if that's okay, if I could get a motion to accept or to amend the budget for the 2024- 2025.

Trisha said I make a motion to amend the budget for the 2024- 25.

Mayor O'Hare said I have a motion from Trish, do I have a second?

Heather said Second

Mayor O'Hare said I have a second from Heather. All in favor. Any opposed. It's passed.

Mayor O'Hare said and then we need to vote on accepting the budget now that we've amended it. So do I have a motion to accept the budget for 2025-2026.

Heather made the motion to accept the budget for the 2025-2026. Mayor O'Hare said I have a motion from Heather. Do I have a second?

LuAnn said second.

Mayor O'Hare said I have a second from Luann. All in favor? Aye. Any opposed, and it's passed. Okay.

Mayor O'Hare said Last week. Everybody remembers. Last week was the application process for the seats that are available this year, we had the mayor seat, a four year Mayor seat. We have a two-year term for one council member and a council member for your term. We the application process went out and we have, we will have elections this year. It'll be the first time we've had elections probably in 10 or 12, years at least. So for the mayor, it'll be that that's put in an application myself, Orlando, Scott O'hare and James D. Beagley for the two year term council member, Luann's seat there was nobody that put in except for LuAnn. So LuAnn will win that by default and or by no not being opposed at all for the seat and then for the four year term council member, Trish Arbon seat, Trish Arbon put in her application as well as Brandon Garbanati.

Heather said Rod staying for at least a year, he already told me. Rod said well.

Tammie said he will be done in January.

Mayor O'Hare said Hold on, all. We're not gonna, we can't talk about that right now. Um.

Tammie said so, there are two, yeah.

Mayor O'Hare said so, I'm confused then, because it says Trisha Arbon seat. Trisha Arbon and Brandon Garbanati are going against each other for what? For the seat?

Tammie said so, there's a four-year term Council. There are two four-year term seats available. So Brandon Garbanati.

Mayor O'Hare said so, this is this. This isn't okay.

Tammie said so, really, the only thing that will be voted on is the mayor.

LuAnn said That's the way I understood it, too.

Trisha said that's not the way I understood it, too.

Mayor O'Hare said that's not the way it is on the on Box Elder County. It's just, it's so and for your the four year for your term Mayor is me and James, four year term council members is Trish and Brandon,

LuAnn said, but Rods will end in January.

Trisha said, and then Brandon will take his spot.

LuAnn said Brandon will take Rod's spot. That's the way I understood it.

Mayor O'Hare said well.

Tammie said there are three seats. Council seats open.

Mayor O'Hare said So we have the Mayor, we have Trisha's seat, Tammie said the Mayor, and then three council seats, so there are four spots open.

LuAnn said Yeah. That's why I understood it too. That's what I thought I understood.

Tammie said maybe Stacey can clarify, but.

Rod said my seat is still good till January.

LuAnn said Yeah.

Mayor O'Hare said well, everybody's seats good until January, I mean.

Rod asked, but then what happens in January?

LuAnn said Then if you, and then if you decide not to reapply, if you didn't fill out an application to rerun.

Rod said that he hadn't done.

LuAnn said So you're done.

Mayor O'Hare said That's why I said, that's why they didn't say that.

Trisha said it had to be done by June.

Tammie said it had to be done by June 9th.

Mayor O'Hare said the way we were told by Stacey was that my seat was up for bid. Her seat was up for bid, and her seat was up for bid. That's what she told us.

LuAnn said, but Rod didn't sign up again. So he'll be done in January, and then Brandon will take his spot.

Mayor O'Hare said well.

LuAnn said so the only election we have is for the mayor.

Mayor O'Hare said but that, no, you got to have this one Brandon put in his papers. You don't put your papers in for somebody that walks off of their seat.

LuAnn said He's not walking off his seat, He'll be done in January, right?

Tammie said I'm pretty sure your terms. Have you been? Do you remember when you were put in to office?

LuAnn said That's the way I understand it.

Tammie said yeah, and we live in two years or four years that would answer, this is your fourth year, then you would definitely be up for reelection.

Mayor O'Hare said so why is there the two year seat then run against each other who answers a two year seat?

Tammie said that's because she came in for somebody that left Mayor O'Hare said right.

Tammie said she came in for someone.

Mayor O'Hare said right, she came in for Jim.

LuAnn said no, I didn't come in for Jim.

Trisha said I came in for Jim.

Mayor O'Hare said Yeah, oh, yeah.

Tammie said so then she must have it wrong. Even

I don't know, you'll have to ask Stacey. But whoever came in for.

LuAnn said I don't remember the two year, when you guys asked me.

Tammie said it's just finishing that, yeah, it would be you, because you came in for someone.

Mayor O'Hare said yeah, she came in for Jim.

Tammie said okay.

Trisha said but then Stacey said, I was re up and for four more years

Tammie said because Jim's seat, maybe you would was up.

Mayor O'Hare said Jim was placed in his seat.

Tammie said I get so confusing because we've had so many people.

Trisha said we'll just have to clarify.

Mayor O'Hare said so let's clarify it.

Tammie said because I understood it that Rod's was done like there was the only person that wasn't being reelected with another year on yours. But I could be misunderstood that?

Mayor O'Hare said so yeah, because the way I look at this, if you look at this right here, four year term Mayor me and Jim, two year term only, LuAnn put her papers in, and then for the four year term, it was Trish and Brandon.

LuAnn said but then I had that I taught. So I called Stacey and said, so what is, is Rod gonna resign up? And she said, No, he didn't fill out the paper. So yours must be up in January.

Tammie said Yeah.

LuAnnn said that's the way I understood it.

Trisha said so when I come in and filled out my paper, I asked Stacey that same thing, and she said, No, there's two four year terms coming open. So Brandon would be in one. I would be in one, because he didn't come fill out his papers to resign up. And we're not running against each other.

Tammie said Yeah.

LuAnn said that's why I understood it too.

Mayor O'Hare said okay.

Rod said okay.

Trisha said I think you missed the deadline.

Mayor O'Hare said Let me call the let me call Box Elder County, because again, I was looking at the website today, and all of them are listed the same way. All of the counties in Box Elder are listed this way. There are five people running for mayor in this one, and there's two people

running for this seat in this one, and three people running for this seat in this one. That's why, when I look at.

Trisha asked So what happens when he.

Mayor O'Hare said so if he. He so he didn't put his paperwork in. If it was a mistake and he wants to continue, then we will just put him back in his seat. Because if, when a seat goes vacant, then the mayor, the mayor puts somebody in the seat, with advice from council, from the town council, but it's the mayor's job to put somebody in that seat, okay? So like, when you came in, we talked and we and we had said, Okay, everybody said, Yeah. And then I talked to everybody. Everybody was, yes, let's put Trish. Okay, we agreed. So then the mayor puts to the town, we want to put Trish, and then we go through the formality of putting you into the into your seat, if he didn't realize that, and but, but see, that's why I've got to check here, because I, the way I'm looking at it is you and Brandon are running against each other for that seat. That's the way I see it, and that's what, that's what the election is. Because if you look at the website, that's how everybody's is, you know, like some some cities, there's only one person's name for the mayor, and then there's up to five people's name, and then for one, for another seat, there's a bunch of people's name, and then, so that's.

Tammie said Yeah, I don't know. I think that's just something Stacey, I know, has, yeah, she's been working with Marla.

Mayor O'Hare said Yeah. And I can call Marla tomorrow and find out, and then I'll let everybody know. So I will call Marla at the end and check on the elections.

Tammie said, because I'm just looking at what she posted.

You know that you had to have out there that there was a mayor seat, one and a two-year term, or a term and then.

Mayor O'Hare said Yeah.

Tammie said so anyway.

LuAnn said, and it was two four-year terms.

Tammie said It doesn't specify how many on that.

Mayor O'Hare said Yeah. But I think if you look on the are you on the website, Box Elder County.

Mayor O'Hare said Yeah, and it shows on the elections.

Tammie said I will have to find it, it's just.

Mayor O'Hare said I got it right here. Oh, actually, I've got it right here. I got my download files. I downloaded it. There we go. Candidate list.

Tammie said Oh, the Candidate list.

Mayor O'Hare said Yep. So if I go down to Snowville, what they say for Snowville is Snowville, Snowville town mayor,

see maybe that, maybe this is it, okay. Snowville town mayor, James, and I, and then it says Snowville Town Council. And then in parentheses, it says two, so that probably means two seats, and we have two people, okay? And then, like Plymouth, Plymouth Town Council, they have a two next to theirs as well, but there are three people. So yeah, but I just don't understand how that how that works? Is it the first, the one that gets the most votes, gets a seat, and then the one that comes in second gets the next

seat? Because you have, again, you have three people going after two seats. So, is that how it works? I don't know. But anyway, I will check with Marla and call, but that's probably how it is then. Mayor O'Hare said to Rod Did you realize that?

Rod said I, honestly, I was, I was gone last month, and, yeah, my brain was elsewhere.

Mayor O'Hare said you have time to think about it, because the election is not till November, right? No, elections in November.

Rod said, but there's.

Trisha said there's a deadline.

Mayor O'Hare said No, no, I know there's a deadline. Well, if we have two people, then the seats will be taken. Okay, okay.

Tammie said Well, then that means that your seat isn't up for re-election, so you still have two more years if they're only electing two people.

Mayor O'Hare said Well, there's her seat, the two-year and then the four-year. There are two four-year seats, according to this, I guess, there is two four-year seats. This seats up, no, because there are two four-year seats.

Tammie said Well, LuAnn's,

Mayor O'Hare said no. LuAnn's term is a two-year term. LuAnn is oh so on the Snowville Town Council for two and the Snowville Town Council's two-year term.

Tammie said Oh, okay, so there are two four years. I thought there were only two council members. Spots on there, one for two years. Mayor O'Hare said It is confusing. I wish they put seat one, seat two, seat three, seat four.

Trisha said Will you need to get with Stacey and figure it out.

Rod said I'm easy, whatever.

Mayor O'Hare said Let me talk to Marla tomorrow, I'll get all the 911-411-411, I'll let everybody know.

Rod said I mean, I if I'm done in January or November, I'm fine with that. If I need to continue, I'm fine with it, too. So okay.

Mayor O'Hare said Box Elder County Sheriff, did Shaw email you? So, excuse them.

At this time, we'd like to call Mrs. Dursteler up. She's going to present her mental health first aid right for it to the town council. So we'll just have you come up here and then state your name for the record.

Holly said I'm Holly Dursteler, and I work for the Family Place in Cache County. Is it all right if I approach?

Mayor O'Hare said Of course, yeah. Do you have anything to hand out as two handouts?

Mayor O'Hare said, and I'm sorry I pronounced your last name wrong, right? Stellar, star, well, I knew that. I'm just reading what it was written down here, and I was like, well, to get that spelled wrong. Thank you.

Holly said It's a shelf, but it's spelled right.

LuAnn said so we've been spelling your name wrong on our agenda for all these years. Oh my gosh.

Tammie said I have it right.

LuAnn said so what is it?

Holly said Dursteler.

Holly asked Do I have to stand here? Standardize it as long as you speak loud enough to where the microphone can hear you? Holly said okay yes, I have a very quiet voice.

This is about mental health first aid. I am a Mental Health First Aid educator, and what that is, I just I gave you some of my slides because usually we do a slide presentation. I have been trained by the I can't remember the full name, but it's the National Council for mental well being. What we do is we teach about mental health challenges and substance use challenges, and how to recognize those at the early stages and not wait till they're crisis. Because in America, we have a problem with waiting until they are a crisis any of these. So our goal, and there's only three of us along the Wasatch Front, actually, that teaches, so we're trying to get it out to the communities. Our grant pays for our salaries, and also pays for, if you do an in person, all of the paperwork, all of the books, the manuals and stuff. And it's normally \$171 bucks. So it's a very good thing to have. So I'm just going to go through this just a little bit, and I'm giving you the slides that I'm going to talk about. Also, what is it? It's an evidence based education course, and the importance of it, you're going to learn the early warning signs. It reduces the stigma and discrimination in the communities. It opens doors to individuals being able to receive professional help. Because what we were doing is we were empowering during our classes. We empower you with knowledge to be able to make those right choices. When you can see and realize that this person is in in early signs worsening or crisis, you know what to do. It's all. It is truly like CPR for the brain. It truly is then. It is the greatest tool that any adult or or teen could have in their life, especially nowadays. It just gives those who are suffering from a mental challenge or a substance use challenge a new path for resilience and well being. It improves the overall psychological safety, and then it improves the outcome in a crisis situation. It truly does. They've done the studies, and it is amazing. We've and we've actually had things happen. We taught three classes at Schreiber's and by the third class, the first class had already been involved with someone who is at the early signs, took care of it, and it just, it saves time and money and medical things. It just, it's amazing what it does. So you love this class. I am, I am pushing today our virtual because you guys coming here and doing an eight hour class, it's really hard, so we do virtual classes, and the virtual class is six hours over two days, over two time frames, and you do two hours pre work online.

That, to me, is really my favorite, because it's you get it done, you get the information done. You go through scenarios, you work through so that you have to recognize them, and if you don't quite recognize them, then we, as teachers, say, Okay, so do you remember this that we taught? I remember this that we taught? Oh yeah, that's right. And by the end, I am amazed. I had one gentleman who came in angsty and.

Left angsty. So it's not perfect, but everyone else, if anybody comes in and is questioning by the end, they're like, Wow, that was the best six hours I used. So what else do they learn? You learn to recognize and identify the signs and symptoms.

Then you use a five step. We teach a five step. It's called the algae plan, and that's that next, that next one you identify, understand and respond to mental health challenges. Algae step five: five-step plan, notice how the assessment is in the middle. That's because it's nonlinear. You can use any step at any time. You don't have to start with the approach and assess. You can start with listening non judgmentally, or you can start with the last E, which is that encourage self-help and other strategies. It's there is so much information you learn about many of the different challenges and the book you get it when you do it virtually, you get a digital copy of it,

so you can just learn more in depth about what mental health challenges we have out there, and what are the early signs, what are the worsening signs, and what are the crisis? Crisis means out of your hands, you call 911, or if it's, we also teach about suicide and the importance of saying, Are you thinking of killing yourself? And that's a very heavy, very hard thing to say, but we give you the opportunity to say it out loud to yourself, or out loud to the whole group, just so that the first time you do it isn't when someone you're actually with someone. And I actually had to use that the other day, and it's the first time I've had to say it out loud to someone, but I'd said it so often because I said, practice it and practice it. Now I'm teaching it. But it was real life, and it was heavy, and she was crying, and she marked this little note, because I also do art, girl, which at home? Is it home visit things? And it said, Have you had suicidal ideation, or have you thought of killing yourself? And she thought, yes. And I thought, Okay, here goes my training. And I said, Have you had thoughts of killing yourself? And she's she just shook her head and just cried and cried. And I said, Have you made plans? And do you have a plan? And do you have a means? And she said, I did. She says, I am in counseling now. I said, Do you have 988 because that's the crisis line. And she says, No, I haven't heard of that. And I said, Well, put 988 in your phone right now. So she put 988 in her phone, and I said, You call that or call our crisis line at the family place, and they'll pass you through to whoever you need to bring crisis counselors. I said, You are not alone in this. And it was amazing. I've never experienced the change in somebody's office, and there was a change like, Okay, I don't have to suffer by myself and and this is a tiny little drop of what we teach, but that, for me, was a game changer. I knew that this is really one of the best based classes that you really could ever go to. So I challenge you to this page I gave you in the very back. Put it every town, because anyone can go in and scan the QR code, and it should take you right to our Family Place, website, to the mental first aid classes that we are, that we are holding every single month. It's just updated. It just goes right there, and Liz, the one that's the Director of Mental Health First Aid, she updates it every month we do in-house one, so if you wanted to get a group together, but those are four hours for two days or eight hours. So being out here remote, I don't mind doing it, but being out here remote, sometimes it's easier to do the three hour and to do your the two hour before. Let's see what else. Right at the very end, I show the course format. It's approximately eight hours of content, whether it's blended virtual or in-house, but you're just doing two hours on your own for the virtual, the impact and effectiveness research shows improve participants' confidence. So that's you when you become a Mental Health First Aider. It's amazing how you will be more aware, and you'll be able to recognize when somebody is having a mental health just crisis, but maybe it's just early signs. You'll be like, Ooh, I remember that. But then you'll be confident, because you won't be thinking, What the heck do I do? Then you'll know what to do, even if it means I don't remember what to do. I do remember 988, and then you call them, and you tell them what's going on, and they'll. Walk you through it. It's that's an amazing line. It also increases one's willingness to help. It reduces the stigma. We really hammer stigma, because stigma is when you say, instead of you say that person's a drug addict, that's a negative connotation. If you say that person is suffering from a substance use challenge. They've done studies that just changing that one word to the other totally changes the help that they're given, how they're they're viewed, and their view on themselves. So we I am a big proponent of getting rid of the stigma, and there are people that they just don't understand. They just well, but that's what they are. No, they're not. That's what they're suffering from. They're a human being, so

And the very last it contributes to better mental health outcome in the community. So this is only going to help every one of our communities that we can get it to. So if you have any questions, you can ask me afterwards, but thank you so very much for letting me come and just present this little snippet. Mayor O'Hare said Appreciate it.

LuAnn said Thank you for coming.

Mayor O'Hare said Thank you so much. Does anybody have any questions at this time? Or are right. Eric.

AJ said Oh, can I go real quick? Because I got another meeting. I gotta run.

Mayor O'Hare asked Do you mind? Eric,

Mayor O'Hare said Okay, we like to recognize AJ, our water director for the water department. You got two seconds. I'm joking.

AJ said when I walked in, you were talking about the water from the county. I stopped and talked to her,

Mayor O'Hare said Yeah.

AJ said, and whatever you guys want to do there, my only thing I would say, Tricia, if you could ask them to please have a hose that doesn't put more water down the borrow pit than they're putting in their truck.

Trisha said Oh, yeah.

AJ said they were wasting more water than they were pumping. So least have the decency to have a hose it doesn't leak water.

Jed said If they're just filling up small tanks, like 100 gallons or something, I can give them a key to do the frost-free. Over here at the Firehouse, they don't have to tap into the hydrant as well.

AJ said and the and the only thing else I would say is there's no back prevention. And I'm a little hesitant to be filling county spray trucks out of a fire hydrant with no backflow. So we really ought to put a flow meter on that if they're going to pull water or pull it out of the fire station, because that one in the fire station has a backflow.

Mayor O'Hare said That's the one right here in front of the fire department, inside the fire, it's inside, okay.

LuAnn said We need to tell the County.

AJ said Just some kind of back Yeah.

Mayor O'Hare said Yeah, well, we'll just have them either you want.

LuAnn said Yeah, they just need to do it at the firehouse.

Jed said is metered as well, that main system.

AJ said Yeah, and I don't care. I mean, whatever you guys want to do about that part, I'm just more concerned about the backflow, because there's nothing between them. I doubt you would ever get any residue back in because the PSI is so high in the water. LuAnn said, but you don't know that.

AJ said, but who knows?

LuAnn said That's right.

AJ said so whatever you want to do there, the only other thing is, I saw you talked about the Bell. Scott, you talked to me.

Mayor O'Hare said yeah.

AJ said so do to want Kyler and I to fix that Bell?

Mayor O'Hare said what thing Do we have? Did you guys want to do a bid.

LuAnn said no.

Mayor O'Hare said on this.

LuAnn said if you're willing to fix it, go for it, man.

Mayor O'Hare said So, so all.

AJ said I'm gonna do, I'll tell you what I'm gonna do to fix it turn your time. Get a big U bolt I'm gonna put over the top, and I'm gonna cut two new holes and put a U bolt through it, put the nuts on, well, the nuts on the bottom, and weld it on top so it can't turn. LuAnn said okay.

AJ said you probably won't break again.

Mayor O'Hare said okay. Is there one bolt. Is there a way that we can weld the U bolt to the bar where that nobody can do this with it?

AJ said Yes.

Mayor O'Hare said okay.

LuAnn said yeah keep track of you time don't do it for free.

AJ said I know.

Mayor O'Hare said Yeah. Well,

LuAnn said we'll pay you.

Mayor O'Hare said send it through. I'll call Eddie, our town Maintenance Manager, give him the job, and then he'll pass it over to you. So it's all, yeah.

AJ said I don't know when I'll get to it, but that's if you want Kyler and I just fix it. That's when I come by with a loader.

Mayor O'Hare asked the Council Is that okay with you guys?

Trish.

Tammie asked is it going to be ok for the Fourth of July?

AJ said It's that bell so heavy you cannot move that.

Mayor O'Hare said yeah well, we'd be able to do it before the Fourth of July?

AJ said I mean, if you, if you want, we can try.

Mayor O'Hare said because we're gonna have a lot of people out there.

AJ said but you won't move it.

Mayor O'Hare said yeah, I tried. I tried to, you know.

AJ said it's not gonna fall off. And if, like, I told Scott, if it falls off, somebody deserves it.

Mayor O'Hare said yeah.

LuAnn said How did it fall off? Then with those kids, did they crush it out?

Mayor O'Hare said yeah, they were up there playing with it.

AJ said I guess it was a bolt broke. If you go look at the bolt, that's there. It's almost there's only a tiny bit that's shiny. It's been broke for a while, and just happened, somebody must have swung it a little bit and it fell down.

LuAnn said yeah.

Mayor O'Hare said yeah.

AJ said it's heavy. I'm surprised, it's, that's wasn't good. That's that sucker's heavy.

Mayor O'Hare said Yeah.

AJ said so anyway, I have to go.

Mayor O'Hare said Okay, thank you, AJ.

AJ asked any other questions.

Mayor O'Hare said You guys go ahead.

LuAnn said Thank you.

Mayor O'Hare said Do the Bell, yeah, thank you. AJ.

AJ said Yep.

Mayor O'Hare said Where's that? The bell, Bell repair, right there.

AJ and Kyler, okay, all right. Eric, give it to us.

Eric said okay, Mary Ann, bless her heart, provided me an update on this unified water plan that she put the cost in there for. I think she just wanted to kind of remind us everything. I have called Heather Elbert, the state on the grant for this well, Savage City. She had not called back. Yeah, I think she's been pretty involved with the whole unified water project stuff. So again, I just wanted to give it to you tonight, kind of just a reminder, kind of where the parties are and where the money's going. And the unified water plan has those construction timelines in it, anywhere from one to two years to 11 to 20 years. So the instrument, but if I get Heather on the phone, we'll get the person taken care of. Just identify some alternate social water. Okay, that's kind of a plan. So she was, he was just, I think she just had some time today.

And more importantly, here, you asked me to kind of flip-flop the sidewalk for here. So I've done that the distance on here is arbitrary, so understand that we can shortly lengthen that up on Stone Road. So again, I just, I just took the south sidewalk over here by the Ranch Diner, and I mirrored it exactly over the north side.

Mayor O'Hare said so, one over on the Ranch House, stand right at the ranch down, okay.

Eric said See, I just took that and I just flipped it over like this. Yeah, I did crack the curve on it. It was a little goofy over there.

LuAnn asked Where are you going to put the curve?

Eric said so, this is this in here, the Town Hall.

LuAnn said right here.

Eric said Yeah, right here. We want to put in.

LuAnn said okay.

Eric said before was up and around, like this horseshoe thing.

LuAnn said Oh, yeah.

Eric said So let's try this out. So can't flip that, put the handicap ramp on this, this West Side. What's nice, Mayor, is it drains. This drain right here. Hit it perfectly. That works out good for the this new sidewalk on it. How does the hose make it puddle there? So there's an orange, orange box in here is a cash-based on the stormwater system.

Mayor O'Hare said Yep.

Eric said that'll have to go into just sort of some way to.

LuAnn asked Do we have the money left from the grant to do this. Eric said no.

LuAnn said no.

Mayor O'Hare said What's the distance of this compared to the other one?

Eric said this in this 490-333. This was 95 feet.

Mayor O'Hare said that the old one was only 95 feet.

Eric said they just went from here around to here. 33 another 40 feet.

Trisha asked, So if we don't have money from the grant, how are we going to pay for it?

Tammie said Did we ever hear back?

Mayor O'Hare said No, I've called Scott Lyons three times, left messages three times. So my next thing is to go down to,

Yeah, down to the City Hall, which I can stop there tomorrow when I get off work, I should be off work by, hopefully, by 12 noon or one.

Eric said LuAnn split the beans. Last time we got all kinds of money. This is just petty cash for you.

Trisha said we have a lot of roads to fix.

Mayor O'Hare asked So what? What is it that, according to what we spent, on what we have left?

Eric said you got about \$5,004 to \$5,000, that is what was left in that budget on the grant, I recall.

LuAnn said This is going to cost, how much?

Eric said this is probably \$18 to \$22,000; it's about four to five times that you can drop on the sidewalk. You could do curb and gutter to drop that down. Why sidewalks expensive? Yeah, curb gutters, not bad, but you do have some improvements out here in front of that curb and gutter has to be addressed too.

Trisha asked So where's the money gonna be best spent on the improvements that need to be done?

Eric said this one, I think this will help reduce some of the truck traffic through the parking lot.

LuAnn said either way, they will just ruin it.

Eric said Yeah.

Trisha said so, I mean, we don't obviously have \$18,000 we need to take what money we do have and see where that's gonna what's gonna benefit.

Mayor O'Hare asked Do we know the price breakdown if we if we didn't do the sidewalk and just did curb and gutter?

Eric said yes, they honor the price that we have back in 2023 at \$38 a foot.

Mayor O'Hare said okay.

Eric said so you can do \$100 bucks or \$120 10 feet for \$4,000, so, and maybe that's what you want to do, is just the curbing here.

Mayor O'Hare said just the curb.

LuAnn said that is what I'm thinking is just do the curb and gutter for now and then. I won't have any road projects next year, so we should have some extra money next year to maybe do the sidewalk.

Eric said So did you talk about what? What section would you want to do?

Trisha said Do we want a sidewalk or do we want to do something. In the parking lot with extra money.

LuAnn said Yeah, but if we, if we fix the parking lot, the trucks just ruin it.

Eric said Yeah, they just tear it up.

LuAnn said You know. So I don't know what. I don't know how to handle that.

Eric said you've got this, this tower out in front here, too, at least we used to help us avoid the front of the sidewalk.

LuAnn said yeah.

Mayor O'Hare said yeah.

Eric said So we can apply for more grant money.

Tammie said Hopefully, when they get this project done, we get it closed out. I hate to start another project.

LuAnn said Yeah, they're not. They're not even going to start our bridge until August. August of this year, and it'll go off through the winter. So we'll have no blacktop on that road. They're just going to put gravel, and then the snow pile will scoop off all of the gravel, and then they have to come out and re gravel it.

Eric said we could apply again for some CDBG funds.

Tammie said I don't know. They awarded like a point system. So I don't know if you still have an outstanding grant, if you, if there's, it doesn't. So, I mean, we can apply in January again for funds to do some maintenance around the town hall and finish that.

Eric said you need to get with the mayor's Association.

Tammie said yeah.

Trisha said we need to do something about the heat system here. Tammie said yeah.

Eric said well, then they were looking at bids and stuff, so I don't know.

Tammie said yeah, I don't know why it was way more than \$2,000

Mayor O'Hare said Yeah, it was.

Luann said I think it was definitely for was.

Heather said just talking about just replacement.

LuAnn said It was a lot, because you got to it was a lot. It was a lot more than I thought it was going to be.

Mayor O'Hare said yeah, it was like \$6,000 or something like that for over here, because we were talking about here and then talking about electrical over there. And that was \$13,000 and this was \$6,000 or so.

LuAnn said I don't know how we're gonna do the Fourth of July without electrical work in town hall.

Tammie said well, so.

Mayor O'Hare said no, we'll do the Fourth of July in a minute.

Eric asked So do you want? You want to find out how much you have left, and maybe, maybe you could retain it?

Mayor O'Hare said Yes.

Eric said you're just hanging on the project. Then I can give this landmark, get an updated cost on this, if this which approach you want to take on it.

Mayor O'Hare said I think right now, the curb and gutter, if we, if we have enough money to do the curb and gutter, that would be the way to go. And then we could do the sidewalk later on down the road.

Eric said how would you just go from maybe here around the corner, then just get that in.

Mayor O'Hare said probably a little bit before to stop sign.

Eric said okay.

Mayor O'Hare said and then, and then try to go here at the end of the grass, maybe someplace in there.

Eric said or maybe two.

Mayor O'Hare said, or maybe, maybe to where, yeah, maybe right across from the maybe halfway of where the tower is, halfway that way. If a truck does come out of this tower here, which I don't think he will come that close to the tower to turn, but he's not going to hit the curb.

Eric said okay.

Mayor O'Hare said, and take it out.

Eric said okay. We could gravel this in the meantime, right? Put the curb down, grab this area here, just let it be gravel for now. Mayor O'Hare said Yeah.

Eric said, Since that'll be the way you see it here.

Mayor O'Hare said Yeah, I would go probably, what about 20 feet in front of the stop sign and then around?

Eric asked Are you okay with this look on it? Then does that look okay?

LuAnn said Yeah, I like it how it looks. It looks really good.

Eric said Okay, the sidewalk is just behind her, in front of that pole out there. Here's your new sign, your stop sign. It sits right there. So it's just, it just kind of fits in.

LuAnn said Yeah.

Eric said That's kind of duck around the pool.

LuAnn said we won't have to worry about anything over in Mollie's because they're going to tear that down.

Mayor O'Hare said they are tearing it down. Thought they were selling it.

LuAnn said they're gonna try, but it's pretty hard to get money on that old little building. I think everybody's having a hard time with that. And so they're gonna leave it up for sale for a couple more months, and then I think they're just gonna tear it down. If they can't get it sold.

Tammie said probably the property is worth more.

Eric said Yeah.

Mayor O'Hare asked Yeah, but they're not gonna be able to put us, they're not gonna be able to put a septic tank in there, right?

LuAnn said for a price.

Mayor O'Hare said Yeah, so if they tear it down, it's down that that property is now is dead for any type of anything, because they can't put a septic tank in.

Eric said, Unless they can use the old one.

Mayor O'Hare said, and the old one, from what I understand, is just, there's a car, yeah, on the ground from back in the day. That's what I was understood, right? Did you guys?

I don't know if it is, but that's what I heard.

LuAnn said they're hoping they should get sold. There are a couple of people interested in it, but whether or not they can get the money.

Mayor O'Hare said so if.

Eric said they do sell it, and they do tear it down. Right, Steve will have to come inspect the tank to make sure it's still accessible and usable. If not, then it has to come out.

Mayor O'Hare said If, it's a car that they're that they're used to, like they said, the story I'm hearing is it's a car, yeah, you could replace that with a brand new septic tank, right?

Eric said if it's in current use.

Mayor O'Hare said yes, if it's in current use, they can replace it. So then somebody can build if they put a home or well enough, they could put a home there because it's zoned.

Eric said for they would be more strong on the left field they are now. They'll take care of that, right?

Mayor O'Hare said Okay,

Eric said but, but that has nasty.

Mayor O'Hare said that's what they used to do back in the day. That's what I heard, too.

Trisha said My dad was talking like back they used to put logs now on the tarp.

Mayor O'Hare said Yeah.

Eric said we had a mattress.

LuAnn said a mattress.

Eric said they dug a hole and through a mattress on it.

LuAnn said Oh my goodness.

Trisha said It didn't used to be.

LuAnn said Oh my goodness, I did not know that. That's not very sanitary.

Tammie said the big thing is, it is right by our water source.

Mayor O'Hare said so.

Eric said Do you want me to get a cost then? I talked to.

Mayor O'Hare said Yeah, if we could do from here around 20 feet before the stop sign, and then right about some place in there, you know, what it can even go before it can even go here, you know, or maybe even right at the at this.

Eric asked, Where is your critical area, grass line here, I guess.

Mayor O'Hare said yes.

Eric said Big in there.

Mayor O'Hare said Yeah, that's what we wanted to be protected, yeah.

Eric said Okay.

Mayor O'Hare said So I would go 20, this is a stop sign. Go 20 feet before and then maybe just go to the edge of the there of the grass line.

Eric said Okay, okay.

Mayor O'Hare said that way. I mean, if it's not gonna cost that much to go the extra.

Eric said Yeah, then I'll go as far as I can. So I go 20 feet here and go.

Mayor O'Hare said Whatever our whatever, that \$5,000, that's what I gotta check and see what we got left. And if we can get we can use it.

Eric asked anything else for me, then?

Mayor O'Hare said Yeah, I do. I've got a question. Oh, does anybody have a question about the curb and gutter?

LuAnn asked for this price, how much? How much were you getting? What you doing?

Mayor O'Hare said So we're gonna go 20 feet before to stop sign. LuAnn said Okay.

Mayor O'Hare said Stop sign right here. So we're gonna go 20 feet before and either go at the edge where the grass is down here, or if it's not that or right here.

LuAnn said Yeah.

Mayor O'Hare said Or if it's not that much more, go to the middle of the tower.

LuAnn said tower.

Mayor O'Hare said Yeah.

LuAnn said okay.

Mayor O'Hare said just to protect that corner, yeah, from turns and stuff.

LuAnn said yeah.

Mayor O'Hare said Um,so is, is there a grant or anything for like ADA, like, if we build a building and we're going to put, you know, ADA acts, which we're going to have to, but is there anything that that the ADA has just CBDG.

Tammie said I know CBDG.

Eric said yeah, I can't think of some accessibility issues. We tried for grants, like, after Parks and Recreation.

Mayor O'Hare said yeah.

Eric said it's not an independent item on your.

Mayor O'Hare said okay, I just didn't know I was trying to, I'm in the process of working and trying to.

Eric said yeah.

Mayor O'Hare said for the Bowery.

Eric said I'll make a phone call. I know some grant writers. We gotta go. Brett.

Mayor O'Hare said okay, I'm working on this.

Eric said he know what to do.

Tammie said That's why I have this. Why do I have this blading thing?

Eric said She's a hot rod give her a call.

Mayor O'Hare said The Bowery. We need a new Bowery, if that price comes in before, before the next meeting, can you email it to me?

Eric said Yeah, well, you let me know how much you have, and I'll work backwards.

Mayor O'Hare said Yeah, yeah. I'm gonna call them. I try to call them again tomorrow. If not, I'm gonna go to the town, up, down City Hall and see if I can get Scott on the face to face, because I know where his office is. Okay. Perfect. Thank you. Eric, anybody have any more questions for Eric?

LuAnn said No.

Mayor O'Hare said okay. Snowville Fire Department Chief, Pugsley.

Jed said One thing that I have is that the Burt windows closed. Mayor O'Hare said Okay.

LuAnn asked what started the fire? Yesterday? Negligence.

Jed said negligence.

Mayor O'Hare said Okay.

Jed said thank you.

Mayor O'Hare said Yes, sir.

Jed said So yeah, burn windows closed. It won't be back open until fall. That's just for residential burning. So tree limbs, grass clippings, that sort of stuff, can't close agriculture burning for people that want to come calling you to permit, there's more than five acres, and they're burning fence lines and that sort of thing. We are super, super dry, and we're anticipating stage one restrictions, which will mean pretty much nothing without a spark, arrester, barbecue grills, all that sort of stuff. So

it is getting scary dry.

Mayor O'Hare said Yeah.

LuAnn said it actually has been the whole dang year.

Jed said yeah, it has been. It's been that way for.

LuAnn said there's no grass for the cows. There's nothing.

Jed said It's pretty scary. So what we do have for grass, we'll try and keep protected the very best we can. But we're a lightning storm, and off to the races again, we're,

LuAnn said Yeah.

Jed said We're pretty lucky. On the one, yesterday that we were burning Olson's house down.

LuAnn said I know that came close. It was right to the fence line. Jed said scary there for a bit.

LuAnn asked So, who called 911 Was it Olson's? Or was it?

Jed said No, I was heading to town and actually seen it, and started talking with the fire marshals on it. And then.

LuAnn said, Were they burning trash? Or what were they doing? Jed said Don't know. Say he started a fire. That's all. He did. So it

kind of took off, and we put a lot of resources into it. We had to call Thatcher in to come and help us. They sent us two trucks.

LuAnn asked Do they have to pay for that? Where was it there on their property?

Jed said Um, probably so. So the county will probably go after restitution on that one. That's the third time in three years we've been out on networking fires on that property. And so there are criminal charges that were filed on that one. And so I'm sure the county's gonna go after restitution on it. I mean, we were there four hours, and it'll probably be \$60 or \$70,000 fire.

LuAnn said Oh my gosh.

Jed said that by the time they pay for resources and trucks, and everything along those lines. It's

pretty sad. But don't

play with fire. Kids.

Mayor O'Hare said Yep.

Jed said take off, other than that, we're just trying to make sure trucks are up and running, and plug away with stuff.

Mayor O'Hare said so, make sure everybody knows. Stay safe. Stay hydrated. If there's anything, if there's anything you need from us, let us know.

Jed said Thank you. We did have a the house burn, which was fun, a good morale builder for everybody.

LuAnn said Sure, left a lot of metal behind, didn't it? I was really surprised.

Jed said there was more metal in that thing than we were expecting.

LuAnn said Yeah.

Jed said the rest of the consumables that burned really good, all the wood that's good insulation, and everything else. So

The family is excited that it's down, and yeah, they can start building again.

Mayor O'Hare asked Jed, Are you going to do the EMS update as well?

Jed said I can.

Mayor O'Hare said Okay.

Jed said I've just been talking with Dave a little bit on it. It sounds like the second ambulance is pretty much ready to go.

I think either tomorrow, a guy from the state's coming out to kind of give it the final stamp of approval, but then we'll have it up and ready to go for the motorcycle races that were on Wednesday. Sorry, on Saturday.

Mayor O'Hare said this Saturday.

Jed said Yeah.

Mayor O'Hare said, and that's out to Eliason Ranch?

Jed said Yep.

Mayor O'Hare said Okay.

Jed said so we'll have an ambulance stationed up there, and then the blue one will be back down here to cover the rest of the town, community, and everything.

Mayor O'Hare said Okay.

Jed said we did get the variance. I think Dave talked about that last time for the EMRs. So we're just kind of working through that, getting see what we need to get some of those guys licensed.

Mayor O'Hare said Perfect.

LuAnn said Awesome.

Jed said Other than that. It's kind of a skeleton crew this time of year with haying and cows out, everything else, but we're staying covered for the most part.

Mayor O'Hare said Perfect.

LuAnn said Thank you.

Mayor O'Hare said Well. Anybody else got any questions?

Jed said Happy to do it.

Mayor O'Hare said Thank you, Chief. Appreciate you.

Holly said If I could mental first aid, you're part of Box Elder. And so there is, there is mental health people, but it's a two-hour wait. But they, they will come, if there's a mental health crisis.

LuAnn asked Come out.

Holly said They will, because you're part of Box Elder, they serve. They serve Cache Valley and Box Elder. It is usually a two-hour wait, but it's better than bringing out, you know, or not them, but the police, and then they don't know how to deal with it because they haven't been trained.

Mayor O'Hare said Yeah.

LuAnn said Okay,

Mayor O'Hare said Tammie, I don't really have anything. It was just to adopt the budget. You guys already did that up above. So,

oh, and let's, is that what you mean? Or the Carson was going to be here for the Fourth of July update, but he's bailing, I guess. Do you want me to give you an update?

Mayor O'Hare asked He's bailing out? Oh, bailing. Oh, yeah, yeah, yeah, if you have an update, that'd be great. He's bailing. That's right, that's what I was thinking. Yeah. Well, it took me a minute. Oh, Bailey, hey, that's right.

Tammie said So I think that he has a pretty well-planned They did decide to just do hamburgers and hot dogs.

Mayor O'Hare said good.

LuAnn said So and keep the cost down. Just little bags of chips, nothing fancy.

Mayor O'Hare said I've got in my car, and I'll, I didn't bring my car. I'll bring it tomorrow. I've got six cases of mini waters.

Tammie said Oh, good.

Mayor O'Hare said each case holds 80 bottles.

And I will, maybe, yeah, I'll.

I'll see if I can, but I got some given to me from Niagara, where I work, so.

LuAnn said Oh, perfect. That's wonderful.

Mayor O'Hare said so I'll bring them in. Like I said, they're only eight ounce little bottles of the baby bottles.

Heather said but it is water.

Tammie said So we decided to plan on 350 this year.

Mayor O'Hare said 350 people.

Tammie said we plan on 500 last year, and we have a lot left over. LuAnn said It's too bad we can't afford to do more for the meal. But I just figure it's, it's, I think the hamburgers will be perfect for years.

Tammie said good old fashioned.

Mayor O'Hare said Yeah.

LuAnn said yeah.

Tammie said They're gonna do some fun games, just like, like, tug of war, like the rope.

Heather said the Easter stuff I have, if you want to use those, the jumping bags.

Tammie said Oh.

Heather said we get into jumping racing bags, adults and kids. I want to use them.

Tammie said anyway, there some fun games with that. And then lola is doing a cornhole tournament, because we kind of started last year.

LuAnn said what?

Tammie said she is cornhole tournament.

LuAnn said Oh yeah.

Tammie said apparently she's like, big into, like, all the rules, like she she knows her stuff, so.

LuAnn said oh, lola from Mollie's.

Tammie said yeah.

Mayor O'Hare said What about the parade?

Tammie said Yeah. So we are doing the parade.

LuAnn asked Did they get Maddie to do it?

Tammie said Yeah, Maddie, she's just gonna sit at the table and people have to.

LuAnn said well, she's gonna be, like, nine months pregnant.

Tammie said So, yeah, it's gonna be simplified.

Mayor O'Hare said good.

Tammie said but I think it'll be good.

LuAnn said I think, yeah.

Mayor O'Hare said yeah, sure is.

Tammie said the other thing is that the band isn't gonna be able to sing. They're not.

Mayor O'Hare said yep.

Tammie said together, I guess, anymore.

LuAnn said Yeah, they broke up.

Tammie said they broke up.

Heather said You could just play music.

Tammie said Yeah So we're gonna not be live music, but Ryan and Dennis are working on a playlist for us for the night, and they were going to use some of that, like, to get the kids involved and do, like, some freeze dancing and stuff, just some more active games and stuff, rather than just throwing out a bounce house and having to sit there and watch The kids all the time, you know. So.

Mayor O'Hare said I think it's gonna be more laid back and it's gonna be more relaxed.

Tammie said the Fire and EMS, right?

Jed said Yeah.

Tammie said doing the breakfast that morning. We opted out of doing the run in the morning because there just wasn't enough participation last year. So we aren't going to do that.

Trisha said McCoy is going to be sad.

Jed said he can jog around the block.

LuAnn asked What time will the breakfast be?

Mayor O'Hare said And this is going to be on Friday the fourth, the actual Fourth of July, okay.

Jed said eight or nine.

Tammie said I think it's, I think we said nine.

Jed said noon.

Mayor O'Hare asked And is that what a paid breakfast? Or is that just being put on by the fire department?

Jed said Fire and EMS.

Tammie said Yeah, it's at 9 am.

Trisha asked What time's the parade?

Tammie said 4:30 line up at four.

Mayor O'Hare said, and then eating at six.

Tammie said, and she's actually going to start the corn hole. You have to be signed up by five because she thinks it's going to go all night, like she just is really.

Mayor O'Hare said good.

Tammie said I hope it does. Like last year, there was a lot of people have a lot of fun, yeah, so, and then they are going to play softball too, if they want to play. But some people want to do the softball.

LuAnn said one of the cheap things to rent that we always used to rent and just had a total blast was the dunking machine. And it was cheap to rent. And everybody just had a blast.

Trisha asked Do they make those any more?

Mayor O'Hare said we had one year that one year.

Tammie said a liability, when they hit the tin at the bottom, you know, or something. I don't know.

LuAnn asked Oh, there's a liability.

Tammie said I don't know.

LuAnn said Oh, we just ran a dunking machine. It was a lot of fun. Jed said a lot of them are so booked out anymore, especially on the holidays. You have to book one a year in advance.

LuAnn said, but it was fun, kind of an old-fashioned thing that we did.

Tammie said Yeah.

Heather asked Is there anything else needed?

Tammie said just everyone's help that day. You know.

Trisha said I'm ready.

Mayor O'Hare said Good thing is I'm actually off that day.

Tammie said So you guys like to help.

Mayor O'Hare said Yep.

Tammie said You know you can help serve the council members.

Heather asked Do you need breakfast help too?

Jed said We always need help. With that.

Heather said I will be up at nine.

Mayor O'Hare asked Any more questions on Fourth of July.

Okay, we're gonna move on to Rod.

Rod said that he had nothing.

Mayor O'Hare said you're good. And then LuAnn.

LuAnn said Um, I'll try and call Kasen in again tomorrow with Morgan Pavement and see if they've got a date yet, a start date to get our asphalt done. And then after they get the asphalt laid, then we all voted on doing the milling.

Mayor O'Hare said Yep,

LuAnn said, and we okayed the financial part of it through Tammie to make sure we had enough money. So we're good.

Mayor O'Hare asked, so we're good with all that, correct? Tammie, LuAnn said we're good with all that. So I'll find out a date, and then I'll text everybody.

Mayor O'Hare said It says, Here, bid on gravel.

Tammie said Yeah, I don't know what that was.

LuAnn said she read it in the Remember when we were just gonna have this county give us a bid to haul gravel on the sides of the road?

Mayor O'Hare said Oh, yeah.

LuAnn said, and then we decided just to mail it, so we weren't, didn't have any liabilities. That's what that was.

Mayor O'Hare said So okay, so we don't need it.

LuAnn said No, we don't need that.

Mayor O'Hare said Perfect. I know we haven't started. You have a good, good job on everything. I really appreciate all that, all that you've done this year. You've done a lot of work with the bridge, and are also taking on all.

LuAnn said Tammie has done most of the bridge stuff, all this stuff. I listen to the meetings and don't know what they talk about. Tammie said I need to do a follow-up with them. Have you heard from them?

Mayor O'Hare said not one word came there since that last meeting?

LuAnn said Yeah, the last meeting, and I had a doctor's appointment. So you went, she listened.

Mayor O'Hare said That was that. That was the online one, right? Yeah, I was in on that one.

LuAnn said, and I did the one before. But I don't understand anything they say.

Tammie said They just have to get on the same page because they're using two different funding sources.

Mayor O'Hare asked Do we ever get a final on how much it's going to cost for the bridge now that they've changed it to what we said to begin with?

LuAnn said so, because I asked that question several times, I said, so that's going to make our portion?

Mayor O'Hare said Yeah,

LuAnn said and but they still had to get the contract from or the bid from the contractor, which I'm sure they've got now, so they should know about exactly what.

Tammie said they're supposed to have. Like,

LuAnn said yeah, most of cost. I don't have to have a meeting before they put bids out, or just a pre construction a prebid meeting.

Mayor O'Hare asked but they are going with the concrete Gully, or with the concrete? Well, the concrete, yeah, they're going with so this shouldn't cost millions. Then even gonna cost a million.

Tammie said we will have to give our money back.

LuAnn said It's the box culvert. Is what they're putting in.

Mayor O'Hare said Yeah, the culvert, the cement culvert.

Eric said concrete spans and bridge.

Mayor O'Hare said yeah, but the culvert goes underneath. Are they gonna that's gonna be concrete as well, right? I'm curious to see, because I've already, I got a bid from from the county to do this one over here, and it was nowhere near a million dollars.

LuAnn said Oh, this it was.

Mayor O'Hare said it was going to be like around well, the culvert itself cost about \$50,000 just for the concrete and then to do the work and all that. They were thinking right around \$200 to \$250,000 to do it all. So that's why I'm wondering what this is going to cost over here.

LuAnn said it's federal money, so it'll be a lot. Well, of course,

Okay, LuAnn, yeah, but thank you for all the work on the on the roads too. We really much appreciate that.

LuAnn said we got to figure we got to do some point. We got to do the striping again.

Eric said yeah, I kept the sidewalk.

LuAnn said after the sidewalk. Yeah, we'll do that. We'll get we'll get Eric's stuff done first, and then we'll do the stripping. They will do this.

Mayor O'Hare asked Heather, do you have anything?

Heather said Nope.

Mayor O'Hare asked Trish, do you have anything?

Trisha said Nope.

Mayor O'Hare said Okay, so on the last I just wanted to add I am going to be going Tammie. I need to get the name of the person from the gold mine that we need to talk to about. Remember when they came and I was looking back in my paperwork, I couldn't find it, maybe Rod you might have it when they first came. They said, if there's anything that town needs, please let us know we're willing to you know when, when we told them about the ambulance? They said, Oh, if we would have known that, we would have paid for the ambulance.

LuAnn said Give us money.

Tammie said Well, last year, we asked them to help with the 4th of July and they gave us \$200.

Mayor O'Hare said okay, well, that's fine, but I want to go meet face to face with the person that that came and told us that, because I'm trying, I'm trying to do what I can to get money for.

LuAnn said the Bowery.

Mayor O'Hare said Yes, exactly. That's what I'm working on right now, is to try to get, I thought, money from wherever I can, to tear down the Bowery and build a new one. That's the goal. I know it's a big goal.

Trisha said but everybody needs to be motivated.

Mayor O'Hare said That's right. I mean, I've actually, I'm actually going to talk to Cleary buildings. I'm going to talk to Beehive

Structures, and all of them, because you don't know, if you go ask them, maybe they, maybe they'll donate a building for us for the town.

Jed said His name's Pete.

Mayor O'Hare said, Pete.

Jed said Camie started working up there.

Mayor O'Hare said Oh, did she.

Mayor O'Hare said If you give me his number, that'd be great, and I'll give him a call. And then, like I said, if anybody else has any ideas. Of anything, let me know, because I'll take all ideas and any options, but I'm gonna go with my little cardboard sign saying we'll work for a new Bowery and see what I can do. But I've been like I said, I'm planning on going to meet to see if you don't know, unless you ask.

Jed said I look at the one up in Fielding, so I know it's a little bit different, but like their town hall, like their offices, and then like a big rec center hill in the middle that people can come out and rent with a kitchen or whatever.

LuAnn said it's really nice inside.

Jed said And it'd be nice to do something like that right against that frontage, and then have a multi-purpose building.

Mayor O'Hare said Yeah, I mean, even a pol barn type, you know, could be, I mean, as long as it got insulation, it keeps it warm, keeps it cool.

Jed said, and that's the way that it is in building. It's just a metal barn, pretty much.

Mayor O'Hare said Yeah, on the inside, maybe I'll go look at Fieldings.

Heather said Yeah, Scott, you got internet here. Let me just get a building. You worked your butt off on that internet.

Mayor O'Hare said That was Eric and me doing trying to get that finally got that took forever.

Thanks, President Trump, for the money.

Yeah, right.

Okay. Anybody public comments? Anybody have anything for pub, for the town council? Public comment at this time? No, okay, everybody was emailed the, I'm sorry, did you have something? Everybody was emailed the expenses did every bit. Was everybody able to read it? The expenses? No, it was very it was, it was.
