**2. Discussion Tentative Budget – Dave Oxman**

The city council reviewed the tentative budget for 2025-2026, which included various cost increases and proposed adjustments for city operations and capital projects.

**3. Department Head Reports:**

- **Finance Director – Dave Oxman**  
Presented the tentative budget for review.
- **Treasurer – Marilu Zamudio**  
Excused.
- **Recorder – Natalie Crosby**  
Nothing to report.
- **Police Department – Chief Steve Gray**  
Operations are continuing as usual, and the department remains on track for the upcoming merger of July 1, 2025. The department has been approved for an \$80,000 grant focused on officer mental health and school support services; however, its implementation may be affected by the merger timeline.
- **Public Works – Colter Allen**
  - Splash pad is operational; one pump was replaced.
  - Power Plant Campground is now open.
  - The cemetery was well-maintained for Memorial Day.
  - Both city ponds were drained when the temperature cooled off.
  - 3 Days a week water restriction starts this next billing cycle.
  - Pothole repairs are underway.
  - Sand was removed from the old ball fields.
  - Septic tank removal for the old restrooms is scheduled for tomorrow.
  - Treatment plant and well are both fully operational. Certificate to run the plant should be issued soon.

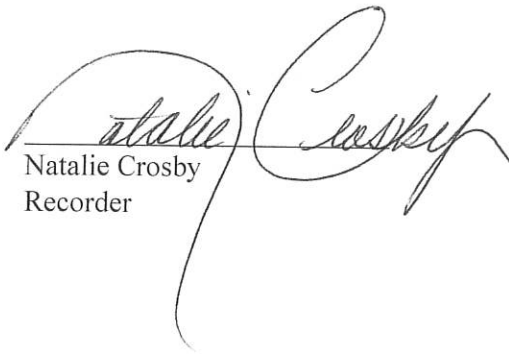

- **Power Department – Tyler Beesley (reporting for Shane Ward)**
    - Several new power services were installed last week.
