Work Session to discuss the Farr West Landing Commercial Subdivision preliminary application

A work session was held with Woodsonia Real Estates to discuss the proposed Farr West Landing Commercial Subdivision Preliminary Application.

Regular Meeting

Chairwoman Genneva Blanchard called the meeting to order.

City Councilman Timothy Shupe reported that the City Council approved a conditional use permit for Jenny Astle. They tabled a conditional use permit for Tavin Rose based upon his request for a variance for the height. They held 3 public hearings regarding the 2025-2026 Budget and Risk Assessment Audit. The City Council approved the proposed budget for 2025-2026 including the new tax rate of .000327. The City Council reviewed a right-of-way

for the Ogden Cycle Association. They set a public hearing for the implementation of the transportation utility fee. He advised the Planning Commission that Weber School District will be removing a bus route, and the city will be evaluating a safe route for children walking to school. Tim gave a brief report on assignments and adjourned.
