Resolution 2025-08, Adoption of Certified Tax Rate for FY 2025-2026

Council Member Ken Krogue stated that this coming year the Council needs to put more time in on the tax rate. The city does have some say in the rate and we are looking for additional revenue for the city.

950 North, Acquire the Paved Portion of the Road

Mayor Chris Anderson stated that part of the new sewer line is projected to go up 950 North and then down to the sewer lagoon. Initially the County said that we would be able to put our sewer line in the road, but they are requiring a flow fill which would add up to \$200,000. The County as intimated that if the city is willing to assume responsibility for the road, then we would need to maintain the road and be able to do what we want. Council Member Randy Strate stated that the city has two choices, one to annex the road up to 700 East, and the other is to take responsibility of the paved portion of the road. From that point it will jog onto private property and cross the street a couple of times. This discussion is to decide if the city should take responsibility of the paved portion of the road. Mayor Anderson stated that in the future it may make sense to annex the whole road. Council Member Strate stated that the benefit of annexing the whole road is that the city can do what we need to with it. The challenge is that we would need to take over the maintenance as well. Mayor Anderson and Council Member Strate discussed some of the issues that the county currently has with the road.

Council Member Randy Strate made a motion to inter into an agreement with the county to over responsibility for the 950 North road from Highway 117 to where the pavement ends which is the East side of the church. The motion was seconded by Council Member Paul Penrod.

Road Bids

Council Member Randy Strate stated that we have three bids to pave 400 North. The first bid is from Bennett paving for \$207,380. 00, the second bid is from Hales for \$218,640.00, the third bid is from Eccles for \$195,190.00. Although Eccles is the lowest bidder there is some concern because we have never used them, they have talked to Cory about moving and re-ringing the manholes. This has not been done in the past and raises the question of how their bid is lower than the other two. Bennett is \$13,000 higher and we have used them in the past. There was some discussion about the materials used and the differences between the bids. The Hales and Bennett bids were for 22 feet and Eccles bid was for 20 feet. After looking at the square footage estimated on the bids Bennett is the ones that bid it correctly at 82,750 square foot. Council

Member Marty McCain stated that he felt more comfortable choosing the company that bid the job correctly.

Council Member Ken Krogue made a motion to go with Bennett and give feedback to Eccles for the next opportunity. The motion was seconded by Council Member Courtney Syme.
