Action Item: Reports from Washington County, Washington City, St. Geroge City, Ivins City, Santa Clara City, Hurricane City and Five County AOG on status of obligated funds and projects.

The COG Policies ask that once per year we will hold a reporting meeting to discuss the currently obligated funds and the status of each project. A list of the obligated projects shows that we have a total of \$1,748,676.75 of obligated funds in the Preservation Fund Project Balance and \$2,632,032.54 in the Construction Grant Fund Balance. A spreadsheet prepared by Camille Hastings of the balances for each project was sent out in an email by Jayanne Lewis on May 27, 2025 to all COG members asking each entity to give a report during our June meeting.
