Jonathan Cox with the Wohali development introduced himself to the council.

Councilor Shaun Powis made a motion to adopt Resolution # 2025-4; 2024-2025 Fiscal Year Budget Amendment Councilor Lynn Wood seconded the motion.

Motion Carried (5-0).

Item 4 – Public Hearing Review, Discussion, and Possible Adoption: Fairview Estates Subdivision Phase 2 Final Plat Acknowledgement with Chalk Creek Bridge Construction, 134 Dobbs Drive (CT-330-A).

Coalville City Community Development Director Don Sargent gave the background of the Fairview Estates Subdivision Phase 2 Final Plat Acknowledgement with Chalk Creek Bridge Construction.

The applicant Courtney Richins addressed the conditions in the staff reports. Councilor Louise Willoughby asked for clarification on the sale of the town homes and the timing of the traffic bridge construction.

Discussion was held between council, staff, and the applicant on the construction of the traffic bridge and townhomes.

Discussion was held over water rights associated with the property.

Councilor Louise Willoughby asked for clarification on the costs that would be incurred by the city for the construction of the traffic bridge.

David Vernon 800 North 50 East gave comment on the traffic bridge.

Mayor Mark Marsh closed the public hearing at 6:31 p.m.

Discussion was held over traffic impact concerns with the additional traffic the bridge may encourage from Chalk Creek Estates Subdivision to Border Station Road.

Councilor Shaun Powis asked if there was an input from the adjacent developers of Chalk Creek Estates, Alan Stanford and Chris Boyer.

Discussion was held over the density of Fairview Estates.

Coalville City Community Development Director Don Sargent presented the revised conditions to the council.

Councilor Brandon Brady made a motion to approve Fairview Estates Subdivision Phase 2 Final Plat Acknowledgement with Chalk Creek Bridge Construction, 134 Dobbs Drive (CT-330-A) with the findings and revised conditions in the staff report.

Councilor Louise Willoughby seconded the motion. Motion Failed (1-4). Councilor Brandon Brady, John Hansen, Shaun Powis, and Louise Willoughby voted in the negative.

Additional discussion was held between the applicant, council, and staff.

Councilor Brandon Brady made a motion to approve Fairview Estates Subdivision Phase 2 Final Plat Acknowledgement with Chalk Creek Bridge Construction, 134 Dobbs Drive (CT-330-A) with the findings and revised conditions recommended by staff. Councilor John Hansen seconded the motion.

Motion Carried (3-2). Councilor Louise Willoughby and Lynn Wood voted in the negative.

Councilor Louise Willoughby made a motion to deny the Larry H. Miller Development Group (Hidden Meadows) Annexation Petition.

It was decided that the applicant would come back to present more information to the council at a subsequent meeting.
