PURPOSE OF PUBLIC NOTICE

The purpose of this public notice is to declare the Director of the Division of Water Quality's intention to renew a Utah Pollutant Discharge Elimination System (UPDES) Permit under the authority of the Utah Water Quality Act, Utah Code § 19-5-106(2)(g). The draft Permit and the Fact Sheet (collectively, the draft Permit documents) are available for review and comment.

BACKGROUND

The influent of the Courthouse Wash Wastewater Treatment Facility (Facility) consists of water from two hotels and one business, which conduct Colorado River guided tours. The Facility consists of a super settler, a plate settler, and a membrane treatment system. A neutralization tank also collects water from the membranes' acid and caustic cleaning processes. The backwash from the membranes is also discharged. See the Permit and Fact Sheet for more information. A Level II Antidegradation Review was also completed as part of this renewal.

PUBLIC COMMENTS

Pursuant to Utah Admin. Code R317-8-6(6.6), any interested person may submit written comments on the draft permit documents and may request a public hearing if no hearing has already been scheduled. A request for a public hearing shall be in writing and shall state the nature of the issues proposed to be raised in the hearing. All comments will be considered in making the final decision and shall be answered as provided in Utah Admin. Code R317-8-6(6.12).

Commenters have an affirmative obligation to raise all reasonably ascertainable issues and submit all reasonably available arguments and factual grounds supporting their position, including all supporting material. Supporting material must be included in full and may not be incorporated by reference, unless the material is already part of the administrative record.
