RESIDENTIAL AND REZONING APPROXIMATELY 2.32-ACRES TO THE R-3 ZONE
FOR PROPERTY LOCATED NEAR 3100 WEST 13400 SOUTH. APPLICANT- ALAN
PRINCE OF MP&G LLC.**


