9000 South and New Bingham Highway Intersection Realignment

The City of West Jordan, in cooperation with the Utah Department of Transportation (UDOT), is planning to realign and reconstruct 9000 South, Duck Ridge Way, and the New Bingham Highway intersection in Salt Lake County. In accordance with Stipulation II, Part A and Appendix A of the Memorandum of Understanding, State Assumption of Responsibility for Categorical Exclusions (23USC § 326)(renewed June 12, 2023), the UDOT assumes responsibility, assigned by the FHWA, for ensuring compliance with Section 4(f) of the Department of Transportation Act of 1966, 23USC § 138 (as amended) and 49 USC § 303 (as amended).

The purpose of this public notice is to offer an opportunity for public comment, pursuant to Section 6009 of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A legacy for Users (SAFETEA-LU) and the associated FHWA guidance dated Dec. 13, 2005, that a Section 4(f) de minimis impact finding is appropriate for the Ron Wood Baseball Complex affected by the subject project. The proposed project will use a small portion of the above-mentioned Ron Wood Baseball Complex. Any person or group wishing to submit comments regarding this project may do so in writing. The public comment period is 14 days, beginning from the first date of publication of this notice.
