1. DISCUSSION AND CONSIDERATION OF UPDATES TO THE WASATCH COUNTY TRAILS, ARTS, AND PARKS GRANT GUIDELINES AND SCORING CRITERIA – DUSTIN GRABAU

A. **SUMMARY:** Since the original adoption of the documents the TAP Tax Board has successfully completed two grant cycles. The council recently requested the board review and suggest changes to the guidelines and scoring criteria with the goal of improving the grant process and opening larger grants to be reviewed by the council prior to the recommendation of funding. Dustin Grabau, Wasatch County Manager, explained that tier changes, more details on ineligible items, and other minor changes. Council discussed ineligible items and requested administrative fee maximums be added to the guidelines. Council also discussed wayfinding signage and requested it be removed from the ineligible item list.

2. CONSIDERATION OF A COUNTY-SPONSORED ANNUAL HERITAGE EVENT IN SEPTEMBER 2025 – DALLIN KOECHER & MARK NELSON

A. **SUMMARY** Councilmember Nelson introduced the topic of Heritage event and how the council has discussed it over the past year. Dallin Koecher, Heber Valley Tourism and Economic Development Director, talked about their mission and how it ties into this event proposal. Dallin explained the community challenge of honoring the heritage without having Cowboy Poetry. Jessica Broadhead, Heber Valley Tourism and Economic Development Assistant Director presented the events that could be slated for the 2025 Heritage Event including train events, fireworks, history tours, tractor days at the Kohler Dairy, heritage photo event at the library, local storytelling, line dancing, heritage themed farmers market booth at the Midway Market and more. Jessica then presented what the Heritage Event could include in future years like community pancake breakfast, student art displays, mountain man traders camp, pioneer games, sheep herding/mutton bustin', kids rodeo, and more. Councilmember Nelson expressed that the Daughters of the Utah Pioneers and the Library had representatives in the audience and how Midway City Mayor Johnson expressed moving the Volksmarch to align in

the same timeframe to promote honoring the community heritage. Councilmember Nelson also asked the council for their opinion on supporting and sponsoring the event. Council expressed overall support of applying for TAP funds to be used to help establish the event as well as applying to the Cowboy Poetry for additional funds. Councilmember Searle requested that this item come back to the council at a later date with an official resolution.

**3. SECOND READING OF ORDINANCE #25-05 ADDING REGULATIONS OF OPERATIONS ON E-BIKES AND OTHER
MOTORIZED VEHICLES – DOUG SMITH** **(VIDEO TIME STAMP: 00:55:00)**

A. **SUMMARY:** Doug Smith, Wasatch County Planning Director, presented what the proposed codes does which adopts the definitions contained in state code, defines the difference classes of E-bikes, speed limit restrictions, helmet restrictions, and more. Doug Smith expressed that this ordinance aligns close with the same code that Heber City recently adopted. Also presented were findings as follows: Utah Code 41-6a-1115.5 provides that a local authority may adopt an ordinance to regulate the use of electric assisted bicycles on sidewalks, paths, or trails within the jurisdiction of the local authority, and State code and the proposed County code allows for the use of e-bikes to be treated similar to regular bicycles and would therefore be allowed on sidewalks and trails, and The Wasatch County General Plan has extensive support for multi modes of transportation as well as providing a safe non-motorized trail network throughout the County, and Wasatch County has a number of trails throughout the County including hard surface and back country trails, and Due to the advent of electric motorized vehicles of all sorts it is essential that the County adopts regulations regarding the use of said vehicles on public trails, and The safety of all trail/sidewalk users is affected by the misuse of these vehicles especially when considering that the speeds of these vehicles can be much greater than the trails may be built to accommodate, and Utah Code 41-6a-1115.5 further provides that when enacting ordinances related to the use of pathway or soft-surface trail, and during the planning or construction of a pathway or soft-surface trail, a local authority shall consider accommodations and increased trail access by a person with a motor disability. Council expressed the importance of community outreach and suggested working with local bike shops to spread information about the ordinance.

i. **ACTION TAKEN:** Councilmember McMillan made a motion to “**adopted Ordinance 25-05 adding regulations of operations on E-Bikes and other motorized vehicles including the findings**” Councilmember Bonner seconded the motion. The motion carried with the following vote:

4. DISCUSSION AND CONSIDERATION OF RESOLUTION 25-06 AMENDING POLICY 165-002: MEMORIAL HILL - DUSTIN GRABAU

A. **SUMMARY:** Dustin Grabau, Wasatch County Manager, explained that the changes in this policy update would go into effect next year. Dustin explained that as part of evaluating the 2025 inductees to Memorial Hill, items requiring clarification were identified in the existing policy. The attached policy addresses these areas of clarification in the following ways: Clarifies that an eligible veteran must have been honorably discharged from military service, Authorizes alternative documentation for establishing military service, and clarifies residential requirements. Councilmember Crittenden request the correction under section 2.3 that it states "facilitate input".
