4. Health and Dental insurance options & renewal: Ernie Sweat

The LEA is facing significant price increases to the Health and Dental plans they provide their employees. Due to the significant increase, they had to look at changing their insurance provider. Ernie Sweat is the LEA's insurance agent and he presented his findings on the best insurance provider options that fit the school's current needs. The LEA's current carrier is Cigna, and if the school stayed with Cigna it would have a 45% increase in costs. The best option Ernie found is PEHP, for health, dental, and vision insurance. With PEHP, the health insurance increase would be 27.5%, which is the lowest increase of increase in costs for health insurance, and vision and dental costs would be about the same. PEHP requires a 3-year commitment, but it guarantees a second-year cost increase no greater than 7.2%. The out-of-pocket maximums will be higher for employees, but the copays are about the same. PEHP offers two networks, Summit and Advantage. The summit network includes the Cache Valley Specialty hospital and non-Intermountain Healthcare providers. The Advantage network includes Logan Regional as well as any Intermountain Healthcare hospitals along the Wasatch Front. Employees will have to choose between one network or the other, they cannot have access to both.
