

**IVINS CITY COUNCIL
MEETING MINUTES
JUNE 19, 2025**

1) WELCOME AND CALL TO ORDER

BACKGROUND and RECOMMENDATION: The law has changed Regarding Preliminary Plans since this Preliminary Plan was submitted so they are addressing this through the prior process. The City does not sign this agreement but approves the Preliminary Plan that then goes to Final Plat, with a condition that this agreement is in place. A cross access agreement is a solution that is used in these situations. A Council Member recalled that the main issues that came up some time ago where that both properties had parking access and addressing the underground gas tanks because those are located right on the property line. The City Attorney clarified that there is a requirement to address that and he thought that the original Conditional Use Permit addressed that. The owner of the property indicated that there is a construction and maintenance easement and the intent is for the property to function as a whole.

B. Discuss and consider approval of a donation agreement with Ivins Inspired

Council Member Sharon Gillespie recused herself and sat in the audience.

BACKGROUND and RECOMMENDATION: The **City Attorney Bryan Pack** explained that Ivins Inspired would be the holding group for the funds. There isn't a way to draft an agreement that fully protects the City. There is the risk of individuals donating to Ivins Inspired, thinking that they are donating to Ivins City and the possibility of any representations made by Ivins Inspired, falling back on the City. There is also a small risk of funds disappearing for whatever reason, a donor asking where the money went and the City not having any control over the money. **Mayor Hart** clarified that those concerns would be the same as with any 501(C) 3 non-profit. The City Council previously supported fundraising for the purchase of the Whitaker wind sculptures and Ivins Inspired has insurance policies in place wherein Ivins City can be named. One **City Council Member** had a concern with the City's side of the agreement in the first paragraph where it read that the City would attempt to use any funds donated by Ivins Inspired for the purposes donated but retains full discretion to direct where the funds are used, as well as there being no deadline identified for the expiration of the agreement. It was also suggested that the agreement define that this is for the Whitaker sculptures. The **Mayor and City Council** agreed that the language that was of concern in paragraph one (1) be removed, add that either party can terminate this agreement and include a timeframe for the agreement to expire. The **City Council** requested that they receive a report as to the status of this agreement, as part of the Arts Commissions annual report.

F. Continued discussion regarding Fiscal Year Ending 2026 Budgets and Truth in Taxation

BACKGROUND and RECOMMENDATION: The trend for the June disbursement is 5% less than the prior year but it was unknown why at this point. The Mayor and City Council need to determine a number tonight for the Truth in Taxation process. The estimated shortfall is approximately \$470,000 but the City is still relying on other revenue that is not reliable, making the shortfall number closer to \$860,000 in the long-term. The **Mayor and City Council** discussed the number for the Truth in Taxation process, ranging from \$470,000 to \$860,000. The Mayor and the majority of the City Council agreed with the number being \$860,000 as the cap number. One **Council Member** agreed to go along with that number if the Council agreed to go with a lower number if the shortfall comes in at a lower number than \$860,000.
