

ORDINANCE NO. O- 29 2024

AN ORDINANCE OF EAGLE MOUNTAIN CITY, UTAH, AMENDING
EAGLE MOUNTAIN MUNICIPAL CODE CHAPTER 2.20 COMPENSATION
SCHEDULE OF STATUTORY OFFICERS

PREAMBLE

WHEREAS, Utah Code Annotated §10-3-818 requires that the governing body of each municipality fix by ordinance the compensation of statutory officers and review it annually; and

WHEREAS, Chapter 2.20 of the Eagle Mountain Municipal Code establishes the compensation schedule for statutory officers in accordance with state law; and

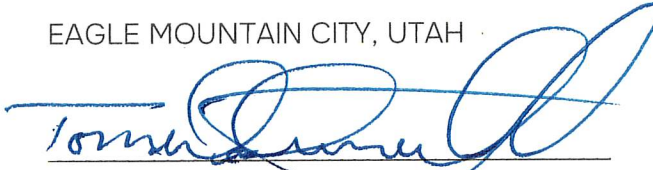
WHEREAS, the City has reviewed current compensation levels using updated salary survey data to ensure fair and competitive pay for statutory positions; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF EAGLE MOUNTAIN CITY, UTAH:

1. **Amendment.** Chapter 2.20 of the Eagle Mountain Municipal Code is hereby amended to reflect the updated compensation schedule attached hereto as Exhibit A.
2. **Findings.** The City Council finds that all required notices, public hearings, and statutory procedures have been satisfied in accordance with Utah law.
3. **Severability.** If any provision of this ordinance is found to be invalid or unenforceable, the remainder shall remain in full force and effect.
4. **Effective Date.** This Ordinance shall take effect upon its first posting or publication.
