

## **NOTICE OF PROPOSED TAX INCREASE GRAND COUNTY SCHOOL DISTRICT IN SAN JUAN COUNTY**

The GRAND COUNTY SCHOOL DISTRICT IN SAN JUAN COUNTY is proposing to increase its property tax revenue.

The GRAND COUNTY SCHOOL DISTRICT IN SAN JUAN COUNTY tax on a \$475,000 residence would increase from \$937.37 to \$975.25, which is \$37.88 per year.

The GRAND COUNTY SCHOOL DISTRICT IN SAN JUAN COUNTY tax on a \$475,000 business would increase from \$1,704.30 to \$1,773.18, which is \$68.88 per year.

If the proposed budget is approved, GRAND COUNTY SCHOOL DISTRICT IN SAN JUAN COUNTY would receive an additional \$26,412 in property tax revenue per year as a result of the tax increase. If the proposed budget is approved, GRAND COUNTY SCHOOL DISTRICT IN SAN JUAN COUNTY would increase its property tax budgeted revenue by 48.34% above last year's property tax budgeted revenue excluding eligible new growth.

The GRAND COUNTY SCHOOL DISTRICT IN SAN JUAN COUNTY invites all concerned citizens to a public hearing for the purpose of hearing comments regarding the proposed tax increase and to explain the reasons for the proposed tax increase.
