### Call to Order

Chairman David Roberts called the UDC meeting to order at 12:35 PM MT. Roll was taken and a quorum was present.

## **Approval of the Agenda**

## 2025 Utah Dairy Commission Election Results

# **Utah Dairy Commission Expenses and Financial Update (March - May 2025)**

Pamela Fry (Director of Finance, Dairy West) presented expenditures and financials for March - May 2025. Pam asked the board if they would like her to move \$350,000 from the money market within Zion at 3.5% interest to PTIF earning 4.47% interest. The board agreed to have Ms. Fry make that change. The board inquired about making a change from banking

with Zion to D.L. Evans. The board has requested Ms. Fry to come back to the next board meeting with a proposal to make that change so that it may be approved by motion.

Chairman David Roberts called for a motion to ratify and approve the financial reports and expenditures for March - May 2025. Commissioner Sheila Sherwood moved to ratify and approve the financial reports and expenditures for March - May 2025. Commissioner Trevor Wayment seconded the motion. The motion passed unanimously.

## **Open Discussion: Future Checkoff Priorities**

Chairman Roberts opened the room to discussion around anything the board members may want to discuss.

Commissioner Fullmer let the board know there will be further discussion in the following Dairy West Board Meeting around board seat allocation. He informed the room that Utah will see a change from three board seats to two. He feels as though the allocation of seats is still equitable but if anyone has questions to be sure to bring them up in the Dairy West Board Meeting.

There was conversation around potentially changing the structure and timing of future board meetings.

Commissioner Fullmer expressed excitement over the keynote speaker confirmed for the Dairy Convention in January 2026. He encouraged the room to make sure others know about the convention and mentioned additional advertising should be done around it to make sure there is good attendance.

Lacey Papageorge (Manager - Farmer Relations, Dairy West) reviewed upcoming events within the state. She also followed up on an action item from the May Board Meeting regarding the Governor's Award. The winners of the award in the past have been added to the Dairy West website. She also reminded the room that nominations for 2025 Hall of Fame award are due August 1st and encouraged board members to submit nominations if they have any.

## **Chair's Report**

Chairman Roberts is excited for the direction that Dairy West is going and is looking forward to Washington and Oregon joining.

Chairman Roberts called for a motion to adjourn the Utah Dairy Commission meeting. Commissioner Hancock moved to adjourn the meeting. Commissioner Sherwood seconded the motion.
