ORDINANCE NO. 25-32

**AN ORDINANCE FOR APPROXIMATELY 0.865 ACRES OF PROPERTIES
LOCATED AT APPROXIMATELY 1394 & 1378 WEST 7800 SOUTH,
IDENTIFIED AS THE SPRINKLER SUPPLY HARDSCAPE DEVELOPMENT; AND**

**AMENDING THE ZONING MAP FOR
THE SPRINKLER SUPPLY HARDSCAPE DEVELOPMENT**

WHEREAS, the City of West Jordan (“City”) adopted the Comprehensive General Plan (“General Plan”) in 2023, as amended, which provides for a general plan land use map (“General Plan Land Use Map” or “Future Land Use Map”), which is periodically updated; and the City adopted the West Jordan City Code (“City Code”) in 2009, as amended, which provides for a zoning map for the City (“Zoning Map”), which is periodically updated; and

WHEREAS, an application was made by ***SS, Inc., a Utah corporation, dba Sprinkler Supply Company*** (“Applicant” and “Owner”) for approximately 0.865 acres of real property, **parcel numbers 21-27-476-066 and 21-27-476-026**, located at approximately 1394 & 1378 West 7800 South (“Property” or “Sprinkler Supply Hardscape Development”), for a ***Rezone*** from the R-2 Zone (Two-Family Residential Zone) to the C-G Zone (General Commercial Zone) (“Application” and “Rezone”); and

WHEREAS, on July 1, 2025, the Application was considered by the West Jordan Planning Commission (“Planning Commission”), which held a public hearing and made a ***positive*** recommendation to the West Jordan City Council (“City Council”) concerning the Rezone, based upon the criteria in City Code Section 13-7D-6; and

WHEREAS, a public hearing was held before the City Council on July 22, 2025, concerning the Rezone; and the City Council has reviewed and considered the Rezone; and

WHEREAS, in its sole legislative discretion, the City Council now finds it to be in the best interest of the public health, safety, and welfare of the residents of the City to approve the Rezone.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST JORDAN, UTAH AS FOLLOWS:

Section 1. Rezone. For the Property, a ***Rezone is approved*** from the R-2 Zone (Two-Family Residential Zone) to the C-G Zone (General Commercial Zone), as per the legal description in “Attachment A”.

Section 2. Severability. If any provision of this Ordinance is declared to be invalid by a court of competent jurisdiction, the remainder shall not be affected thereby.

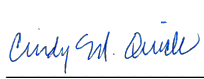

Section 3. Effective Date. This Ordinance shall become effective immediately upon posting or publication as provided by law and upon (i) the Mayor signing the Ordinance, (ii) the City Council duly overriding the veto of the Mayor as provided by law, or (iii) the Mayor failing to sign or veto the Ordinance within fifteen (15) days after the City Council presents the Ordinance to the Mayor.
