**WILLARD CITY ORDINANCE 2025-09: REGULATION OF SNOW REMOVAL
AND STREET PARKING DURING WINTER MONTHS**

WHEREAS, the safety and accessibility of city sidewalks and streets during winter months are vital for the well-being of residents and visitors;

WHEREAS, Willard City is committed to maintaining efficient snow removal operations to prevent accidents and ensure the free flow of pedestrian and vehicular traffic;

WHEREAS, the Willard City Council recognizes the need to amend the municipal code to reflect updated snow removal practices and parking restrictions;

NOW THEREFORE, be it ordained by the Council of the Willard City, in the State of Utah, as follows:

SECTION 1: **AMENDMENT** “18.16.010 Removal Of Snow” of the Willard City Municipal Code is hereby *amended* as follows:

BEFORE AMENDMENT

18.16.010 Removal Of Snow

- A. It shall be unlawful for the owner, occupant, lessor, or agent of any property, abutting on a paved sidewalk to fail to remove, or have removed from such paved sidewalk, all hail, snow, or sleet thereon within a reasonable time after such snow, hail, or sleet has fallen. In the case of a storm between the hours of 5 p.m. and 6 a.m. such sidewalk shall be cleaned before 9 a.m. of the same day.
- B. It shall be unlawful for any person removing snow from the sidewalk, to deposit snow, dirt, leaves, or any other material in the gutter so as to clog or prevent the free flow of water therein.

AFTER AMENDMENT

18.16.010 Removal Of Snow

- ~~A. It shall be unlawful for the owner, occupant, lessor, or agent of any property, abutting on a paved sidewalk to fail to remove, or have removed from such paved sidewalk, all hail, snow, or sleet thereon within a reasonable time after such snow, hail, or sleet has fallen. In the case of a storm between the hours of 5 p.m. and 6 a.m. such sidewalk shall be cleaned before 9 a.m. of the same day. It shall be unlawful for any person removing snow from the sidewalk, to deposit snow, dirt, leaves, or any other material~~

~~in the gutter so as to clog or prevent the free flow of water therein.~~

- A. Sidewalk Snow Removal It shall be unlawful for the owner, occupant, lessor, or agent of any property abutting on a paved sidewalk to fail to remove or have removed from such paved sidewalk all hail, snow, or sleet within a reasonable time after such precipitation has fallen. In the case of a storm occurring between the hours of 5:00 p.m. and 6:00 a.m., such sidewalk shall be cleared before 9:00 a.m. of the same day. Residents are encouraged to ensure their sidewalks are safe and accessible during winter months to prevent accidents and ensure the free movement of pedestrians.
- B. Snow Deposits in Gutter It shall be unlawful for any person removing snow, ice, or other material from the sidewalk to place or deposit said materials in the gutter, where they may clog or prevent the free flow of water. Instead, snow should be deposited on park strips or along the edge of roadways.
- C. Street Parking During Snow Removal Overnight parking on city streets is prohibited from November 1 to April 1 to allow for thorough snow removal. Violators of this prohibition may be subject to towing at their own expense and/or citation with an infraction. Vehicles parked on the street during these months may impede snowplows, resulting in incomplete snow removal on affected roadways.
- D. Driveway Approaches While snowplows make every effort to avoid blocking driveway approaches, it is the responsibility of the property owner or occupant to clear any snow deposited in driveway approaches.
- E. General Compliance Adherence to these regulations ensures efficient and safe snow removal operations, contributing to the overall safety and accessibility of city streets and sidewalks during winter months.

SECTION 2: REPEALER CLAUSE All ordinances or resolutions or parts thereof, which are in conflict herewith, are hereby repealed.

SECTION 3: SEVERABILITY CLAUSE Should any part or provision of this Ordinance be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of the Ordinances a whole or any part thereof other than the part so declared to be unconstitutional or invalid.

SECTION 4: EFFECTIVE DATE This Ordinance shall be in full force and effect from the 25th day of April 2025 and after the required approval and publication according to law.

SECTION 5: DIRECTION. Staff are authorized and directed to make such non-substantive changes and take other actions to finalize, post, and publish this Ordinance.
