SHERIFF MIKE SMITH (*Utah County Sheriff*) GAVE AN EXPLANATION FOR REGULAR AGENDA ITEMS NUMBER 9, 10, AND 11. HE MENTIONED SEVERAL ATTEMPTS BY THE COUNTY AND STATE TO GET MORE TRANSPARENCY FROM IMMIGRATION & CUSTOMS ENFORCEMENT AGENCY (ICE). HIS MESSAGE TODAY IS ENTERING INTO THESE 287G PROGRAMS DOESN'T REALLY CHANGE MUCH OF WHAT THEY HAVE ALREADY BEEN DOING. THESE AGREEMENTS WILL FOCUS ON OUR JAILS AND THOSE THAT COME IN WITH ILLEGAL STATUS, APPROXIMATELY 100 PER MONTH. HE STRESSED THAT HE WOULD HAVE MORE TRANSPARENCY WITH ICE.

HE CAN BE AWARE OF THE ACTIVITIES BY ICE. HE IS AGAINST THEIR RAIDS AND SAID THEY WILL BE ADDRESSING THIS ISSUE WITH ICE.

COMMISSIONER POWERS GARDNER SAID SHE RECEIVED A LOT OF EMAILS AND FEEDBACK ON THIS AND DOES NOT WANT TO DISCOUNT ANYONE'S VOICE. SHE READ A STATEMENT THAT SHE HAD BEEN WORKING ON WITH THE SHERIFF.

WE BELIEVE IN BUILDING A COMMUNITY WHERE EVERY PERSON, NO MATTER WHERE THEY COME FROM, CAN LIVE, WORK, PLAY, AND RAISE A FAMILY IN SAFETY AND DIGNITY. THAT BELIEF GUIDED EVERY STEP OF OUR DECISION-MAKING PROCESS. IN THESE CONTRACTS, WE DID NOT SIMPLY AGREE TO A BOILERPLATE AGREEMENT. WE APPROACHED THIS WITH PRECISION, COMPASSION, AND CLAREYED UNDERSTANDING OF OUR OBLIGATIONS. OUR COMMITMENT IS TO PUBLIC SAFETY AND NOT FEAR. THAT'S WHY WE MADE IT EXPLICITLY CLEAR. UTAH COUNTY WILL NOT PARTICIPATE IN LABOR RAIDS OR IMMIGRATION RAIDS. PERIOD. WHILE THERE MAY BE ELEMENTS THAT ARE OUT OF OUR CONTROL, WE WILL CONTINUE TO ADHERE TO THE PRINCIPLES THAT MAKE UTAH COUNTY A WELCOMING PLACE FOR ALL WHO LIVE HERE AND WHO ARE OBEYING OUR LAWS. WE WILL WORK WITH FEDERAL PARTNERS ONLY IN CASES WHERE IMMIGRANTS HAVE COMMITTED CRIMES THAT THREATEN THE SAFETY OF OUR RESIDENTS. CRIMES AGAINST PEOPLE. WE'VE SEEN THE REAL DANGER THAT ORGANIZED CRIMINAL NETWORKS CAN POSE. A KNOWN HITMAN FOR MS-13 WAS ARRESTED IN OUR OWN COUNTY. WE'VE DEALT WITH ORGANIZED THEFT RINGS. OUR RESPONSIBILITY IS TO PROTECT OUR COMMUNITIES FROM VIOLENCE AND CRIMINAL EXPLOITATION. AT THE SAME TIME, WE FULLY RECOGNIZE AND DEEPLY RESPECT THAT OUR ECONOMY DEPENDS ON THE CONTRIBUTIONS OF HARDWORKING IMMIGRANTS. OUR FARMS, CONSTRUCTION SITES, HOTELS, AND RESTAURANTS THRIVE BECAUSE OF THEM. THEY ARE OUR NEIGHBORS, AND THEIR CHILDREN GO TO SCHOOL WITH OURS. THEY DESERVE TO FEEL SAFE AND SUPPORTED AND NOT TARGETED OR AFRAID. WE DON'T WANT CHILDREN SCARED TO GO TO SCHOOL OR PARENTS TERRIFIED TO GO TO WORK. THAT IS NOT WHO WE ARE AND THAT'S NOT THE KIND OF COUNTY WE WANT TO BE. OUR APPROACH IS GROUNDED IN PRINCIPLE, LED BY DATA, AND DRIVEN BY HUMANITY. WE ARE UPHOLDING THE LAW, PROTECTING OUR PEOPLE, AND STANDING FIRM IN OUR VALUES. BECAUSE IN UTAH COUNTY, SAFETY AND COMPASSION ARE NOT OPPOSING FORCES. THEY ARE TWIN PILLARS OF A STRONG AND DECENT COMMUNITY.

SHE STATED THAT UTAH COUNTY WILL NOT PUT UP WITH CARTELS, ORGANIZED RINGS, AND THEFT RINGS. THESE AGREEMENTS WITH ICE WILL GIVE THE COUNTY THE TRANSPARENCY THAT THEY NEED.

THE AGREEMENTS WOULD ALLOW BETTER COMMUNICATION WITH ICE SO THAT WE CAN DIRECT THEM IN AREAS WE WOULD LIKE TO THEIR OPERATIONS TO GO IN UTAH COUNTY THAT WOULD FIT IN WITH THE PHILOSOPHIES THAT WE'VE TALKED ABOUT IN HONORING, SUPPORTING AND DEFENDING THE DIGNITY OF HUMAN BEINGS.

THESE AGREEMENTS ARE ACTUALLY SETTING GUIDELINES SUCH AS A REQUIREMENT FOR INTERPRETERS, A GUARANTEE FOR CIVIL RIGHTS PROTECTS, THEY CAN NOT DISCRIMINATE AND THEY MUST OPERATE WITHIN CIVIL RIGHTS. THERE IS ALSO A COMPLAINT PROCESS TO FILE A GRIEVANCE. THIS IS SETTING BOUNDARIES AND GUIDELINES. SHERIFF SMITH EXPLAINED THE PREVIOUS AGREEMENT THE COUNTY HAD WITH ICE AT THE JAIL AND WHY IT WAS CANCELLED.

WHAT TYPE OF CRIMES?

THEY ARE FELONY LEVEL CRIMES, HIGH LEVEL DRUG DEALING AND TRANSPORTATION. IN THE MONTH OF JUNE, THEY SEIZED 30,327 FENTANYL PILLS AND THEY WERE LINKED TO CRIMINAL CARTELS.

HOW WILL YOU HOLD ICE ACCOUNTABLE?

IT IS UNKNOWN TO A CERTAIN LEVEL. THE BEST METHOD WE HAVE IS TO TRY TO WORK WITH THEM ON A COOPERATIVE LEVEL, TO SAY THESE ARE THE WAYS WE WANT TO DO THINGS IN UTAH COUNTY.

COMMUNICATION AND TRANSPARENCY?

SHERIFF SMITH SAID THE LEVEL OF TRUST AND COMMUNICATION WITH OUR LOCAL ICE HAS BEEN TREMENDOUS. HE AND OTHER SHERIFF'S HAVE BEEN MEETING WITH THEM.

COMMISSIONERS POWERS GARDNER ASKED WHAT IF ICE DOESN'T UPHOLD THEIR END OF THE AGREEMENT AND THEY AREN'T GIVING PEOPLE DUE PROCESS, WILL YOU COME BACK TO US AND SAY YOU WANT TO CANCEL THE MOA? SHERIFF SMITH EXPLAINED THAT HE HAS TRIED HARD TO COLLABORATE WITH FEDERAL LAW ENFORCEMENT AND HE WILL PUSH BACK.

MASK?

SHERIFF SMITH SAYS HE HAS NO OVERSIGHT OVER ICE AND CANNOT TELL THEM TO TAKE OFF A MASK.

WHAT ABOUT THE PEOPLE WHO ARE AFRAID AND DO NOT WANT TO COME TO LAW ENFORCEMENT WITH A CRIME THAT THEY'RE A VICTIM OF?

SHERIFF SMITH EXPLAINED THE U-VISA APPLICATION. HE SAID IF SOMEBODY CALLS US FOR HELP, WE ARE GOING TO HELP AND NOT GO AFTER THEIR IMMIGRATION STATUS. HOWEVER, IF THE PERSON WHO COMMITTED A CRIME AGAINST THEM HAS AN IMMIGRATION ISSUE, HE WILL ADDRESS IT.

COMMISSIONER POWERS GARDNER ASKED ABOUT IMPERSONATING ICE AGENTS. SHERIFF SMITH SAID HE WOULD INVESTIGATE AND ARREST THOSE INVOLVED. THERE ARE LAWS IN THE STATE THAT ADDRESS THIS ISSUE.

WHAT WILL YOU DO IF SOMEONE IS IN JAIL AND THEY ARE IN THE PROCESS OF BECOME A LEGAL CITIZEN?

SHERIFF SMITH SAID BY ENTERING INTO THIS ICE AGREEMENT IT GIVES THEM THE ABILITY TO SEE THAT INFORMATION AND IT COULD BE HELPFUL.

WHAT ABOUT THE DATA SHARING?

SHERIFF SMITH SAID WE ARE NOT ALLOWING THEM TO HAVE ANY OF OUR DATA. WE WILL HAVE ACCESS TO THEIR DATA; WE CAN RESEARCH WHO WE'RE ACTUALLY DEALING WITH AND ANY INFORMATION THE FEDERAL GOVERNMENT HAS ON THAT PERSON.

WHEN WILL THIS PROCESS START?

SHERIFF SMITH BELIEVES IT WILL BE AT LEAST A YEAR AND SAID WE CAN CANCEL THE CONTRACT ANYTIME WE WANT.

SHERIFF SMITH SAID THESE AGREEMENTS ARE ABOUT KEEPING UTAH COUNTY SAFE.

COMMISSIONERS POWERS GARDNER SAID HER FAMILY HAS BEEN TARGET OF THREATS AND ESPECIALLY TODAY SHE HAD OVER 300 EMAILS FROM ANGRY PEOPLE. SHE HAD TO TELL HER CHILDREN NOT TO ANSWER THE DOOR. SHE UNDERSTANDS THE FEAR THAT EVERYONE FEELS. SHE ALSO TALKED ABOUT HER EXPERIENCE WITH IMMIGRATION FROM CANADA. SHE WOULD LIKE TO SEE A PROCESS FOR COMPLAINTS.

COMMISSIONER BELTRAN EXPRESSED THANKS TO ALL WHO TOOK THE TIME TO COME AND EXPRESS THEIR OPINIONS. HE ENCOURAGED ALL TO BECOME ENGAGED WITH THE PROCESS. IF ANYONE SEES SOMETHING WRONG, PLEASE LET THE COMMISSION KNOW.

COMMISSIONER GORDON SAID EVERYONE IN THIS ROOM IS IMPACTED BY IMMIGRATION. HE EXPRESSED HIS TRUST IN SHERIFF SMITH. HE IS GRATEFUL THAT EVERYONE CAME OUT AND EXPRESSED THEIR OPINION.

COMMISSIONER POWERS GARDNER WANTS TO DO SOME CONTINUED RESEARCH ON THESE AGREEMENTS AND GOT ASSURANCES THAT THEY COULD BE CANCELLED IF NEEDED.
