Agenda Item	Legislative Session Summary – <i>Tom Ross & Van Nguyen & Elizabeth Klc</i>
Notes	<p>Van Nguyen presents a summary of the 2025 Legislative Session.</p> <p>In the 2025 Legislative Session, there were 959 total numbered bills. 582 passed in this session versus the 2024 Legislative Session where only 582 were passed.</p> <p>One of the bills that were passed is House Bill 353 Substitute 4, the Governor's Executive Order. This bill will be a big focus for the commission going forward and will be considered for an interim study item. Multiple commissions will be involved and engage in the conversation of performing the functions of the Executive Order. The commission will take everyone's comments and considerations to create a balance in communication and performing the duties as directed in the order. There is no direct timeline when the conversation needs to be held on a broader front.</p> <p>The Prosecutor Conduct Commission was also passed for the 2025 Legislative Session. The Prosecutor Conduct Commission will be organized under CCJJ.</p>
Agenda Item	UBJJ Grant Awards – <i>Adrienne Buhler, UBJJ Director</i>
Notes	<p>Adrienne Buhler presents the Grant II funds to be awarded to a certain number of grantees. Out of the 33 applications submitted, 14 were approved for grant awards. \$1,300,000 was requested and \$160,000 was approved to be awarded.</p> <p>The commission will vote for approval of the individual grantee awards to count abstentions of commission members with any bias towards the groups.</p>
