The Board of Trustees of the Weber Mosquito Abatement District, Utah, met in public session July 14, 2025, at 6:00 pm., at the District office located at 505 West 12th Street, Ogden, UT 84404. Trustees Jed Jenkins, Jim Harvey, and Ryan Parent were excused.

Bryan Baron, the District's Contract Attorney, was present.

Welcome and Public Comment. Trustees were welcomed to the July 14, 2025 Board Meeting.

Approval of June 9, 2025, Board Meeting Minutes. A motion to approve the Board Meeting minutes of June 9, 2025, was made by Trustee Grover Wilhelmsen, seconded by Trustee Cindy Cox. Motion passed unanimously.

June Budget Report. Director Keith Hill reviewed the Monthly Budget Report. General Fund Expenditures in June totaled \$130,845.14 with no additional Capital Expenses, YTD expenses are at 55.40%. The Public Treasurer's Investment Fund balance is \$1,437,151.65. The Bank of Utah checking account balance as of June 30, 2025, totaled \$315,497.54 and the America First CD totals \$185,442.34 to date.

Approval of the Monthly Bills for June. The Board proceeded to discuss the monthly bills. Keith explained check #19981 totaling \$5,340.00 to Rocky Mountain Unmanned Systems for two new UAV batteries, check #19989 to Target Specialty Products in the amount of \$1,104 for chemical, and check

#20001 to Taylor Anderson totaling \$162.49 for reimbursement of the hamburger patties for the annual Trustee BBQ. A motion to approve the monthly bills for June was made by Trustee Gordon Cutler, seconded by Trustee Katie Williams. Motion passed unanimously.

Approve/Disapprove: Authorization to Order District Vehicles for the 2026 Budget. After a brief discussion, Trustee Carey Seal made a motion granting authority to order two district vehicles for the 2026 Budget within reason, seconded by Trustee Grover Wilhelmsen. Motion passed unanimously.

Director's Report. Director Keith Hill presented Trustees with a Community Report. In June, the District larvicided a total of 214 acres by ground with an additional 758 acres treated by air. A total of 40,026 acres were adulticided by ground with an additional 11,520 acres by air and a total of 137 spray requests were received in June. West Nile Virus testing is up and running, a total of 71 tests have been ran with no West Nile positives to date.

The United States has reported a total of 24 human West Nile positives and no deaths to date.

Adjourn. A motion to adjourn was made by Trustee Grover Wilhelmsen, seconded by Trustee Sallee Orr. Motion passed. The meeting adjourned at 6:23 pm.
