C.S. Lewis Academy respectfully requests approval for a small school expansion to include 7th grade beginning in the upcoming school year. As a K-6 public charter school located in a rural area of southern Utah County, we serve a unique and underserved population. Our community's needs, coupled with our school's mission and capacity, make the addition of 7th grade a logical and necessary step to better support students and families.

1. Rural Location and Limited Educational Options

C.S. Lewis Academy is situated in a geographically isolated part of southern Utah County, where educational choices for middle school students are extremely limited. In our region, there is only one traditional district middle school serving a wide area, which has led to overcrowding and a lack of individualized attention for students. Families in our community have expressed a strong desire for alternative education options that offer a more personalized, community-centered approach to middle school education.

Many parents are seeking a middle school option that aligns with the values and learning environment they have come to trust at C.S. Lewis Academy. Offering 7th grade would also improve student retention and increase family satisfaction by allowing students to remain in a familiar, stable educational setting during the pivotal middle school years.

Extending our grade levels to include 7th grade directly supports this mission.
