### **E. Discuss and consider approval of Development Agreement for Chinle Cliffs**

**BACKGROUND and RECOMMENDATION:** This development is on the south side of town and is the subject of a Settlement Agreement from more than 20 years ago. If the City Council approves the Development Agreement, the Planning Commission will then approve the Preliminary Plan. One change to the agreement has occurred regarding section 5I where it was contemplated that there would be a booster pump for water. That was originally thought to be needed but all parties have discussed that and determined to leave an option to connect to a St. George line so that language has been added. Council Member Lance Anderson recused himself. One Council Member inquired if the original agreement was still in play or if this superseded that. It was clarified that this agreement was in addition to the original agreement. There were concerns about two-story homes being visible but it was clarified that the home would have walkout basements as the two stories instead of going up in height. There was a question if there were any sensitive land issues and it was clarified that there were not. ### **I. Discussion and update regarding 40 acres of SITLA property**

**BACKGROUND and RECOMMENDATION:** Council Member Lance Anderson sat in the audience and made comments as an audience member, including his general concern for the property and the number of homes one developer intends to put on that parcel, totaling 250 homes. That property is located on a hillside and has soil issues with clay that would cost a significant amount of money to dig out and mix and replace the soil. Lance Anderson's philosophy is that a developer can develop small lots for affordable housing and build those where it works. He has one piece of property by the Riders Tire Shop that is zoned Resort Commercial that he is willing to trade with SITLA for the 40 acre property on the hill, so they can build affordable housing but SITLA needs a letter from the City Council that townhomes, condos and affordable housing could go on the piece of property by Riders Tire Shop. Attorney Bryan Pack clarified that what Lance Anderson is referring to would be an administrative interpretation of the ordinance, which he will work on and then update the Mayor and City Council at a future City Council meeting. - D. Discuss and consider the Planning Commission's recommendation on a Class V Conditional Use Permit for a pickleball facility at Black Desert Resort, located at approximately 1500 East Black Desert Drive. Enlaw, LLC-Owner. Koko Head-Applicant

**BACKGROUND and RECOMMENDATION:** The Planning Commission recommended approval at their meeting after a few Planning Commission and City Council Members attending an on-site visit on July 10, 2025. Black Desert Resort has secured the National Pickleball Championship that will be held in the spring of 2026. Black Desert Resort Attorney Koko Head commented that in coordination with the adjoining property developer Jerry Miyahara, they are working together to make sure that existing neighbors directly to the west would be buffered from lighting and sound impact. At the on-site visit, it was noted that The Retreat at Snow Canyon development to the west that abuts Black Desert Resort allows for 35' buildings in between the existing residential homes and the pickleball complex, essentially blocking any lighting that may have been seen. It was suggested by a City Council Member that shielding could be done and if necessary, similar to what was done at Rocky Vista University. A Black Desert Resort representative agreed and commented that they are working with a lighting consultant. There will be two tournaments held per year, one in the spring and one in the fall, each lasting between 5 and 7 days from 7:00 a.m. until 10:00 p.m. with the lights only being on if a court is being used and being off around 10:30 p.m. for cleanup. Regarding parking and traffic, that attendees will be shuttled similar to what they do now for other events. The City Council agreed that the Building and Zoning Official will keep the Mayor and City Council apprised as to when the lighting application is received by the City. The Council requested to see the Conditional Use Permit conditions in writing before approving it. The Council discussed some other issues while the City Attorney put the list of conditions into writing and provided it to the City Council. The Conditional Use Permit conditions are that compliance with lighting code, shuttled parking transportation, and hours of operation from 7:00 a.m. to 10:00 p.m. with clean-up time after if a game concludes at 10:00 p.m. The discussion may be accessed at time stamp 01:05:18.

The agreement needs to be updated to reflect increased costs associated with the increased service. The City of St. George has modified the 2020 agreement and attached a new Exhibit A that shows how the costs are broken down between operations and bus purchased. It was suggested by a Council Member

that the Arts Commission assist in any shelters that are installed for riders. There was also a concern with Ivins City not receiving more revenue than it is from the transit service.
