- Standard hotel, meals, and transportation expenses and reimbursements will be paid in addition to the hourly rate.
- This compensation policy is effective as of May 7, 2025 (Ray noted that The Utah State Legislature in its 2025 Legislative Session made 2025 SB 50, the bill changing district board compensation, effective on May 7, 2025).
