V. Approve submission of proposed rule amendments to the Office of Administrative Rules for publication in the *Utah State Bulletin* *[action item]*

1. R884-24P-66. County Board of Equalization Procedures and Appeals Pursuant to Utah Code Ann. Sections 59-2-516, 59-2-1001, and 59-2-1004.

**Commissioner Rockwell:** The following proposed rule amendments are for the Commission to consider and submit for publication to the Office of Administrative Rules. The amended rules will be published in the Utah State Bulletin on August 1, 2025 and the mandatory public comment period will end on September 2, 2025.

1. R884-24P-66. County Board of Equalization Procedures and Appeals Pursuant to Utah Code Ann. Sections 59-2-516, 59-2-1001, and 59-2-1004.  
This proposed rule amendment fulfills a requirement in 2024 HB 288, Rollback Tax Amendments, that the commission make rules to establish the circumstances under which a late filed appeal may be allowed to the county board of equalization of a county assessor's determination or denial under the Urban Farming Assessment Act. Under current statute, an appeal must be filed within 60 days of a county assessor's determination or denial. The rule amendment allows an additional extension of up to 60 days if certain requirements are met. This rule amendment matches the extension period currently allowed for the Farmland Assessment Act under Rule 66.

**MOTION Commissioner Rockwell:** I move to submit the proposed amendments to R884-24P-66. County Board of Equalization Procedures and Appeals Pursuant to Utah Code Ann. Sections 59-2-516, 59-2-1713, 59-2- 59-2-1001, and 59-2-1004 to the Office of Administrative Rules for publication in the Utah State Bulletin.
