**1. Welcome**

Chair Sonnenreich called the meeting to order at 2:35 p.m.

**2. Approval of minutes of the May 14, 2025 meeting**

Chair Sonnenreich asked for a vote to approve the May 14, 2025 minutes.

**3. Welcome New Commissioners**

#### **5. Report on May 28<sup>th</sup> Meeting of Utah Privacy Governing Board**

Chair Sonnenreich provided a brief report on the May 28<sup>th</sup> meeting of the Utah Privacy Governing Board. Chair Sonnenreich presented the Commission's FY2026 Data Privacy Agenda and Report. The Governing Board tabled official approval of the FY2026 Report. However, considering that the Governing Board only meets twice a year, they have given the unofficial green light to proceed.

#### **7. Advocating Against “phone home” technology for mobile drivers’ licenses**

Commissioner McCown provided a recap of his presentation from the Data Governance Summit on mobile drivers’ licenses. One of the main issues with mobile drivers’ licenses is that some systems operate on server retrieval mode, also known as “phone home,” which requires external servers to verify the credential and allows for those servers to retrieve data on the usage of mobile licenses. There’s little to no control over who is able to retrieve the data, which creates a massive risk. Commissioner McCown shared a statement that has been signed by multiple organizations to opt out of server retrieval mode. The statement can be found at [nophonehome.com](https://nophonehome.com).

#### **8. Report from the Office of Data Privacy**

Chief Privacy Officer Christopher Bramwell discussed the alignment of public policy around privacy and individual rights in Utah and how that may affect government agencies. The Office of Data Privacy (ODP) encouraged collaboration between them and the other government agencies, with 700 guests present throughout the course of the event. Mr. Bramwell summarized the various presentations and workshops available at the Data Governance Summit, including a keynote address given by Governor

Spencer Cox.

Mr. Bramwell expects to continue the Summit on a yearly basis, providing overall themes that are relevant to the timing and context of the events.

Following the comments regarding the Data Governance Summit, Mr. Bramwell commented on workshops and legislation in the works to improve privacy in the state of Utah.

## **9. Commissioners' Comments Regarding Data Governance Summit**

The commissioners' feedback on the Data Governance Summit was very positive. The summit was very well attended and the attendees responded enthusiastically. Chair Sonnenreich stated that the event was overall highly informative without being overwhelming. The tone was also positive, encouraging problem-solving approaches.

Commissioner Vorwaller gave a special thank-you to Representative Jefferson Moss, who has played a large role in privacy legislation and in the Summit.

Mr. Bramwell emphasized the value of the Summit's discourse around privacy legislation, prompting important discussions that could affect legislation in future sessions.

## **10. Report on the Data Privacy Ombuds Workshop**

Chair Sonnenreich reported on the data privacy ombuds workshop, stating that the workshop focused on the broader conversation about what an ombuds does and how the role can benefit data privacy in the state of Utah. Commissioner Wood expressed slight concern about the breadth of the discussed role, but Chair Sonnenreich reminded him of the introductory nature of the workshop's conversation.

## **11. Report from the State Privacy Auditor**

State Privacy Auditor Nora Kurzova gave status updates on two surveys conducted by her team: the AI Risk Assessment Survey and Libraries' Use of Children's Data Survey. For the AI Risk Assessment Survey, 28 responses have been collected. Many entities do not conduct their own risk assessments and rely on privacy policies of the vendors.

Chair Sonnenreich discussed the library children's data survey and how that could impact privacy practices of libraries. Ms. Kurzova stated that the survey has already proved useful in showing libraries how pervasive data collection is, which many libraries never considered. Commissioner Vorwaller inquired which statutes the State Privacy Audit team is using to evaluate potential audits prompted by the surveys. Ms. Kurzova stated that some survey responses may trigger audits, but the main purpose of the survey is to assess risks in the state's entities.

Multiple privacy audits are under way, but not concluded, meaning that Ms. Kurzova cannot comment further until the audits are completed.
