Law Enforcement Major Chad Bettridge asked Assistant Attorney General Kyle Maynard to explain the context of the proposed rule amendments.

00:40:56 Board/RAC Questions

The Board asked about the possibility of the Legislature changing the bill during the upcoming 2025 legislative interim. The Board asked how rule changes and code might be discussed, and in particular if impacted parties might be included in discussions. The Board also commented on public feedback on the fee increase and the perception of what the hunts will be like after the rule changes, and the restriction on the number of guides and spotters on the landscape.

Chad highlighted the changes to the rule.

The Board asked if the Division would consider the element of sponsorship, like what DOPL required, in the process of obtaining an outfitters or guides certificate of registration, and asked about the specific rule requirement that “serious injury” be reported to law enforcement. Kent Johnson disclosed that he is a licensed guide who is discussing the rule change. The Board asked if the rule changes included guides being vouched for, like what was in place under the DOPL licensing process.

The Board asked if the code definition of “serious injury” could be added to the rule. The Board asked for confirmation that the Division of Law Enforcement will respond to reported violations.

Legislative Liaison Justin Shannon told the Board what upcoming conversations the Division has schedule with state legislative representatives.

The Board voiced public feedback about the new fee amount being assessed on guides who guide only on a couple hunts a year, and suggested putting on the Action Log the request to discuss a graduated fee schedule.

The Board argued that with the new law’s restriction on how many helpers can be on

a guided hunt that those who hire a guide might have less help than hunters who do not hire a guide.

The RAC asked if the Wildlife Board can adjust the proposed fee amount.

Chairman Dearth noted that this rule was put forth by the state legislature.

The Board thanked the Division for their work making the rule amendments, and voiced support for a graduated fee schedule.

The following motion was made by Bryce Thurgood, seconded by Bret Selman and passed, 3 in favor, and 2 recusals (Kent Johnson and Gary Nielson).

All RACs passed the rule amendments, with various stipulations and dissent.

Vice-chairman Nielson commented on the vetting process he experienced as a former member of the CWMU Advisory Board, and noted that in the current variance request process specialists form suggestions that are then passed on to the Division, while there also are some people who are against public land in a CWMU as a general rule. The Board voiced support for enforceable definable boundaries.

The Board asked if the public could still hunt on public land in a CWMU for species other than the singular different species for which permits on that CWMU are issued. In particular, could the public hunt, for example, deer and elk on the proposed included public land in the TL Bar Ranch variance request, a CWMU that offers only pronghorn hunts. Chairman Dearth stated that the public needs to understand this.

The Board asked about the hypothetical situation of a landowner drawing a landowner permit, and hunting alongside the public who would be hunting the public ground. Chairman Dearth asked a Northern Region board member how he

was considering voting on this agenda item.

The Board commented that they were being asked to make decisions on land that they have never seen nor have time to see, and that it would seem reasonable to follow the Division's researched recommendations. This was followed by another board member's comment that in the past there have been variance recommendations that were passed that probably should not have, so the vetting process is important.

Chairman Dearth noted that every time a CWMU that has public land in it applies for a new certificate of registration, their application must be scrutinized and approved again. He asked the Division if the CWMU Advisory Committee approved of the TL Bar Ranch variance request.

The Board voiced appreciation for the CWMU Advisory Committee's opinions, and noted that when the CWMU program started it was generous to landowners, but as the changes come about, such as the corner crossing law being passed, things will impact program regulation.

The Board then mentioned how valuable the CWMU program is to ranchers, and made the conjecture that the program currently is helping keep production agriculture alive in Utah.

Chairman Dearth mentioned that the more landowners learn about landowner permits they might prefer that hunting option.

The following motion was made by Gary Nielson, seconded by Paula Richmond and passed unanimously

Adam Denison- Utah Backcountry Hunters and Anglers – There is a value in having an e-tag. UBHA supports this proposal. Need public awareness of getting harvest code in

the field and to remind the hunter to open the app once they get back into service, so their survey can be submitted.

Kent Singleton- Private property in Morgan experiencing the threat of eminent domain and trespassing. Walk-In Access contract being terminated immediately upon the change of ownership per Utah Administrative Rule. He was directed to install no trespassing signs, yet the DWR and Walk- In Access program continue to maintain old and new fishing signage. He said there are thousands of people on his property every day without his permission and that he's not being compensated.

Deputy Chalmers with the Morgan County Sheriff's Department, issued his wife a citation on July 20, 2023 for criminal trespass when she was servicing their security camera. He requested mediation to resolve the issues. He stated mediation was refused. He also states the division refuses to pull signage and encourages the public to enter his property on false pretenses. He is respectfully submitting this as a GRAMA request to the Northern Region RAC.

Wants all outdated fishing signs removed, publicly clarifying his parcel is no longer enrolled in the Walk-In Access program and to reconsider mediation given the division's statutory obligation.

He can provide letters showing the termination of his property in the Walk-In-Access Program, change of ownership transfer records and boundary surveys.

Blair Stringham said he appreciated his comments, and he could give the letters to him or Jodie Anderson and we would get them to the appropriate person.

Austin Carter-(via telephone) E-tagging requirements. Has already witnessed a problem with tagging. Waste and want of multiple bull elk. Not sure if e-tagging will make it better or worse. Commented on bison damage and how the DWR threatened him with an over- the- counter hunt that would take place on his private property. He can't get any compensation or any help. He has been to the capitol. He has dealt with legislators, the director of DNR and is being attacked on these issues. We have a lot more poaching and waste of wildlife situations. Continued with a scenario where he had witnessed the use of helicopters. (Some of his conversation was inaudible.)

SUBJECT: **Cooperative Wildlife Management Unit (CWMU) tools for over objective units**

In June of 2024 the Wildlife Board approved revisions to the CWMU rule. Included in the revision were tools that can be used on CWMUs that are in units that have been 10 percent or more over objective the last 3 years. We are recommending the following tools to be used on the following CWMUs:

CWMU	Recommended tools
Deseret	2 nd cow permit for antlered and antlerless hunters
Ensign Ranches	2 nd cow permit for antlerless hunters
East Fork Chalk Creek	2 nd cow permit for antlerless and antlered hunters
Grass Valley/Clark Canyon	2 nd cow permit for antlerless and antlered hunters
Weber Florence Creek/Stillman Creek	2 nd cow permit for antlerless and antlered hunters

We are also requesting that the Board consider allowing DWR to continue to implement these tools in the future with updates to the Board annually about what methods were implemented, and how effective those measures were.

SUBJECT: **Drought Permits for Henry Mountains Bison**

The Henry Mountains Bison Management Plan calls for a population management objective to “maintain a post-hunt population size of 325 adult (age 1+) bison within the Henry Mountains Wildlife Management Unit”. Strategies within that objective include the following:

- Habitat conditions, including effects of drought, will be discussed with the bison committee when harvest recommendations are reviewed.
- Utilize the United States Drought Monitor...to make temporary adjustments in the bison population size depending on drought severity and range conditions. If drought-related conditions and bison densities negatively impact habitat, recommend additional bison permits at the August Wildlife Board meeting.

Proposed Henry Mountains Bison Drought Permits:

- Aerial survey conducted on August 5-6
- Estimated 360 adults (pre-hunt)
- Over objective for bull:cow ratio
- Mountain was very dry
- Some troughs were dry
- Recommending additional 19 hunter's choice permits
 - 6 permits to BI6503
 - 6 permits to BI6504
 - 7 permits to BI6516
- Additional permits would bring post-hunt estimates to ~280 adults and help bring bull:cow ratio within objective
- Recommendations supported by agriculture and conservation partners
