

Contract Framework to Transfer SVP Water for Misc Purposes (Version 9 – 7/28/2025)



Miscellaneous Purposes Contract No. 25-WC-40-1015

Master agreement between U.S. Bureau of Reclamation and Irrigation Companies and SWUA that establishes the authority of the Bureau to allow SVP water to be used for miscellaneous purposes.



Universal Change Application

Official directive issued by the State Engineer defining use, management, and/or protection of water resources by Irrigation Companies, SWUA, and SVP Shareholders.



Third-Party Contracts

Irrigation Companies and SWUA (1st party) enters a third-party contract with the Bureau (2nd party) to provide for the delivery, use, and payment of SVP water to the SVP Shareholder (3rd party) for miscellaneous purposes, or to transfer SVP water to another Irrigation Company.

Universal Tenets

- Assessments will only be paid to SWUA, original Irrigation Co and an Irrigation Co delivering SVP water.
- An equitable method of assessing lost generation costs outlined.

- List Acceptable Points of Use if there is available capacity.

Irrigation Co Resolutions

- Authorized Person to Sign Misc. Purposes Agreement and Third-Party Agreements
- Carrier Water Percentage
- List Acceptable Points of Use if there is available capacity.
- Transfer Fee

- Authorized Person to Sign Misc. Purposes Agreement, and Third-Party Agreements
- List Acceptable Points of Use if there is available capacity.

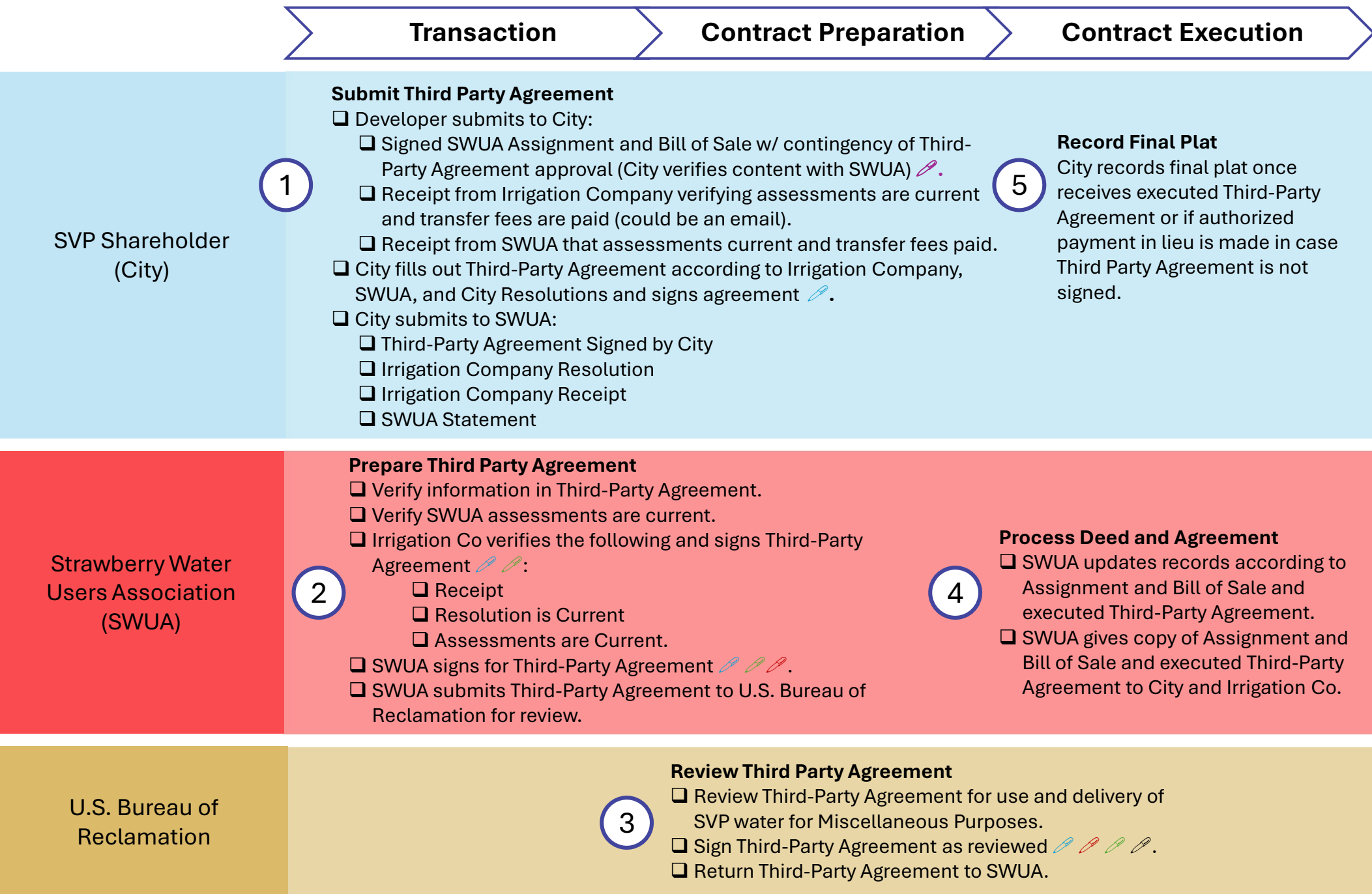

Submit Third Party Agreement

- ☐ SVP Shareholder pays SWUA transfer fees.
- ☐ SWUA verifies SWUA assessments are current.
- ☐ SWUA fills out Third-Party Agreement according to both Irrigation Company Resolutions.
- ☐ SVP Shareholder signs Third-Party Agreement .
- ☐ Irrigation Companies verify the following and sign Third-Party Agreement  
 - ☐ Receipt
 - ☐ Resolutions are Current
 - ☐ Assessments are Current.
- ☐ SWUA signs Third-Party Agreement   .
- ☐ SWUA submits Third-Party Agreement to U.S. Bureau of Reclamation for review.
