**2. Budget Public Hearing (Limited to three minutes per individual. To speak, sign up at the clerk's desk prior to the start of the open forum)**

2.1 Public Comment (Individuals will receive three minutes for comment). 21 - 171

The Board of Education received attached written public comments prior to the meeting, with an additional 86 comments submitted in person and online during the public hearing. The overwhelming majority of these comments expressed opposition to the proposed tax increase, particularly in light of concerns raised by the recent audit conducted by the Legislative Auditor General (OLAG).

Constituents voiced apprehension about the District requesting additional funding while they still had many questions regarding financial oversight and accountability. Many comments reflected disappointment in the audit findings and emphasized the need for the District to demonstrate greater transparency, improved communication, and a commitment to rebuilding public trust.

3.1	Resolution Adopting Final Tax Rates and Budgets	
3.2	Adoption of the FY26 Budget	172 - 180
	Board members discussed the proposed tax increase, recent audit findings, and the importance of accountability, transparency, and fiscal responsibility.	

**Board Member Todd Thompson** emphasized the need for increased accountability across the District, highlighting areas such as key performance indicators, student achievement, policy compliance, and internal culture. He expressed concern about the sustainability of the current budget without meaningful cost-saving efforts and recommended the creation of a cost savings committee. He stated that any tax increase must include clear accountability measures and a commitment to improved efficiency.

**Board Member Scott Bryan** clarified that recent budget increases have been primarily allocated to staff compensation, particularly for teachers. He made a motion to adopt the budget with the proposed tax increase, which was seconded by Board Member Emily Syphus. The motion was subsequently amended to include the formation of a cost savings committee tasked with identifying potential efficiencies and reporting back to the Board.

**Board Member Emily Syphus** shared that she had met with auditors to develop a deeper understanding of the audit findings. She also raised concerns specific to kindergarten teachers and expressed a desire to ensure the Board is making informed decisions based on operational realities.

**Board Member Elizabeth Smith** noted that she had been

actively meeting with constituents and emphasized the importance of listening to public feedback throughout the budgeting process.

**Board Member Shields** thanked members of the public for their participation and respectful input during the hearing.

**Vice President Robert Gowans** acknowledged that the issue of the \$50 million deficit had been discussed at length in previous board meetings. He expressed appreciation to community members for attending and sharing their concerns.

Throughout the discussion, Board Members emphasized the importance of public engagement, clear communication, and a commitment to restoring trust through transparent and responsible financial management.

# Property Tax 101

- Revenue Based Tax – Only tax that I am aware of like this
  - Other taxes are rate based
- Because its revenue based, that means your property taxes would be equal from year to year IF:
  - Your property value increased proportionately to all other properties
- Revenue based also means that rates
  - Decrease as property values increase
  - Increase as property values decrease
- Certified Rate Definition
  - Simply put the rate each entity would charge to generate the same revenue as last year (less new growth)

# Quick History

- Our School Board looked at three different options in our June Budget Hearing
  - Certified Tax Rate
  - Flat Tax Rate
  - +\$13.25M Tax
- In the end our Board selected a proposed increase of \$9.25M

# Why is the District proposing a property tax increase?

- The district was using one-time money for ongoing expenditures specifically to increase employee pay
- The one-time money is no longer available and as a result we have been using reserve funds
- This tax increase will help balance our budget going forward

# Truth in Taxation Process

- District needed to notify the county auditor by June 22<sup>nd</sup> of our intent to increase revenues. Information on the date, time, and place of the tax increase hearing must also be given to the auditor.
  - You should have received your individual notice a month later (July 22<sup>nd</sup>)
- Advertise the date of the public hearing
- Hold a public hearing allowing the public to address the Voting Body (following this presentation)
- The Voting Body (School Board) must then vote on whether to adopt the resolution increasing taxes, or to adopt the certified tax rate. This will finalize the tax rates.

# Public Hearing Process

- Truth in Taxation requires us to have a public hearing
- This is your opportunity to address the Board
- Please sign up to speak on the sheet
- Remember our Board is here to listen to you
  - They will listen and won't interrupt or ask you questions
  - It's not a good time to ask individual questions about your property

# What options does the Board have?

- Following the Public Hearing our Board plans to act on the rate we will adopt for property taxes next year
  - Choose to increase taxes to the proposed amount
    - Board can't go above that figure
  - Board could adopt the certified rate which would not be raising taxes
  - Anywhere in between the proposed and certified rate

Property Tax Increases & Financial Pressure: In mid-2023 and 2024, TCSD proposed tax hikes to cover a \$7M budget deficit, partly caused by losing \$50M in state funding when an online program enrollment ended. The proposed increase equated to an average annual rise of \$253.50 per household (about \$21 per month) for a \$460,000 home—an 11.3% hike in just one year. Combined with a one-time revenue recoup and rising property values, total school district taxes for the average homeowner jumped from approximately

\$1,763 in 2023 to \$2,496 in 2024, a 41.6% increase. Between 2022 and 2024, many taxpayers saw their school taxes increase by nearly 60%, including small business owners whose commercial tax bills nearly tripled. Student Outcomes vs. Spending: TCSD earned a 60% overall proficiency score, effectively a failing grade, even though local taxpayers pay on the higher end compared to other Utah districts. Despite new housing growth increasing the tax base, student achievement remains low, indicating a disconnect between funding and results. Budgeting & Fiscal Oversight: In six of the past ten years, the School Board adopted tax rates higher than the certified rate, meaning even with increased new housing revenue, taxes still rose. For the 2024–2025 fiscal year, TCSD's total budget was \$337M, with \$81M (32.6%) coming from property taxes. Construction and facilities made up nearly \$98M alone. Central administration costs—including salaries and benefits for superintendents, assistants, and board members—accounted for \$1.5M, separate from support services (~ \$12–15M) and instructional costs. State Oversight & Classroom Reality: State audit findings show Utah school districts collectively hold more than \$4.5 billion in investment accounts—some individual districts hold hundreds of millions in reserves—raising questions about resource allocation vs. classroom needs (e.g., teachers paying out-of-pocket for supplies) Taxes have skyrocketed, student outcomes are low, spending is misaligned, leadership lacks accountability, and there are reserves. Enough is enough!
