**ORDINANCE NO. 25-12**

**AN ORDINANCE ADOPTING THE NATIONAL INCIDENT MANAGEMENT SYSTEM  
AS THE STANDARD FOR INCIDENT MANAGEMENT AND ESTABLISHING  
COMPLIANCE FOR FEDERAL FUNDING ELIGIBILITY**

WHEREAS, on February 28, 2003, the President of the United States issued Homeland Security Presidential Directive 5 (“HSPD-5”) directing the Department of Homeland Security, in cooperation with representatives of federal, state and local governments, to develop a National Incident Management System (“NIMS”) to provide a consistent approach to the effective planning, training, response and recovery for incidents involving natural disasters, manmade disasters or terrorism; and

WHEREAS, the NIMS contains a practice model for the accomplishment of the significant responsibilities associated with prevention, preparedness, response, recovery, and mitigation of all major incidents; and

WHEREAS, HSPD-5 requires state and local governments to adopt the NIMS as a condition of eligibility to receive federal funding associated with the planning, training, response and recovery for major incidents; and

WHEREAS, the City Council has determined to formally adopt the NIMS as the standard for incident management within the City.

NOW THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF LOGAN, UTAH, AS FOLLOWS:

**SECTION 1. Adoption of NIMS.** The City of Logan hereby adopts the National Incident Management System, as established by the United States Department of Homeland Security, as the standard for incident management in the City of Logan. All departments and personnel with responsibilities in emergency preparedness, response, recovery, or mitigation shall utilize NIMS principles, protocols, and training in all incident management activities.

**SECTION 2: Effective Date.** This ordinance shall become effective upon publication.
