



EVS medical cannabis card redesign

The medical cards issued by the electronic verification system (EVS) have been updated. Both the current and updated cards will be valid to purchase and possess medical cannabis with an active EVS application.

Key changes:

Both the current and updated cards will be valid to purchase and possess medical cannabis with an active EVS application.

System changes

- The card is now vertical so it is easier to view on your smart phone.
- The information about the card holder is located on the front side.
- The design of the card has changed to increase readability and match the DHHS brand.
- We've made backend system changes so it is easier to view and print the card on android phones.

Usability

- We added additional contact information for our office and other emergency contact information.
- We removed the patient's address from the card. Multiple delivery addresses can now be on file in the EVS so that information is no longer needed.
 - Now patients no longer need to reprint their card if they move.
 - This reduces the amount of personally identifiable information (PII) on the printed copy of the card and helps keep patients safe.
- We changed the QR code to provide the patient ID number and date of birth (DOB). This may allow pharmacists to scan the QR code to check in the patient. This change is based on feedback from pharmacists.


Education

- We included information on safe medical cannabis use and key points of the law.
 - Always work closely with a medical provider and a pharmacist when using medical cannabis.
 - Start low and go slow.
 - Only use medical cannabis you've bought from a Utah medical cannabis pharmacy.

- Do not smoke cannabis (it's legal to vape).
- Do not share, sell, or give away your medical cannabis.
- Call the Utah Poison Control Center 1-800-222-1222 if you think you took too much medical cannabis, you have serious side effects, or a child or pet takes it accidentally.
- Call 911 if it is an emergency.

Guardian card





The guardian medical card is issued to patients under 18. The new card:

- Consolidates the guardian card and the patient card into one.
- Does not include information on safe use. This is still included on the patient card.

Non-Utah resident card

The non-Utah resident patient card:

- Does not include a line for the provider's name. Out of state patients are not certified in the EVS.
- Focuses on reminding the patient about the laws in Utah.
- This includes:
 - Replacing "Always work closely with a medical provider and a pharmacist when using medical cannabis." with "Do not use medical cannabis in public (indoors and outdoors) unless it's a medical emergency."
 - Removing "Only use medical cannabis you've bought from a Utah medical cannabis pharmacy." as that law does not apply to non-resident card holders.
