which allocates \$50 billion to all 50 states in the course of 5 years. While the State of Utah will be applying for its share of these funds, individual counties will need to submit applications to the state in order to access them. The CEO is requesting that the commission inform the State of Utah/Department of Health & Human Services that our clinic could greatly benefit from this funding and would be a strong candidate for receipt to improve care. Currently, there are approximately 14 rural health care facilities operating within the State of Utah.
