

2025 UORG Scoring Meeting

Meeting to take place virtually and in person In Person Address: Millcreek Common 1354 E Chambers Ave, Millcreek, UT 84106 6th Floor Multi Purpose Room

April 30, 2025

8:00 AM - Members arrive, breakfast

9:00 AM - Confirm whether a quorum is present. If so, the meeting may proceed with the required 9 out of 17 members in attendance. A quorum was confirmed to be present on April 30th.

- **Recording is started.**
- Jason will call for approval of minutes from the March 31st, 2025 Pre-Scoring meeting. A motion to approve the minutes from the March 31st, 2025 pre-scoring meeting was made by Erin O'Brien, seconded by Scott Strong, and passed unanimously on April 30th.
- **RTP Scoring Approval (15:15):** Evan Bich provided updates on the Recreational Trails Program (RTP). There were 42 non-motorized and 5 motorized RTP applications, with a total of \$2,046,135 awarded for 26 projects totaling \$5 million in project value. Some projects were awarded at a reduced amount, especially UORG combo requests. The committee was asked to approve these recommended RTP projects. A motion was made by Lance to approve the RTP projects as recommended by the committee, seconded by Scott Strong, and passed unanimously on April 30th.

Updates from Jason: (17:33)

- Updates included the introduction of a new committee member, Jordan Washburn from ARI Bikes, filling the outdoor industry partners role.
- An update was given about the statewide trail conference the previous week, attended by almost 300 people and recognized nationally. The Intermountain West Trail Conference happens every other year.
- The scoring for the Off-Highway Vehicle Recreation grant also took place the previous week.
- Updates on new grants were given, including a boating grant led by Jorge expected to award grants in about a year, and another grant in the process of being scoped.
- There was a preliminary meeting of the Outdoor Venture Commission the previous day, with big meetings in October and November for approving funding from regional recreation councils. Representative Jason Kyle was elected the new chair, and a bill that would have removed legislative representatives from the commission did not pass.

April 30th, 2025 - Meeting Details & Project Discussions

- **Review of Agenda and Procedures:** Noemi explained the procedures, spreadsheets were introduced including color codes for missing scores and sheets for applicants who

applied twice and CPR projects. The committee had \$18 million to award. It was the first year all 29 counties were represented. There were 210 applications.

- **Mini-UORG Discussion: Discussion began around 30:22.**

- A motion was made by Lance to take the top three mini-grant projects (Cache County Hospital Greenville Elementary Canal Trail, Utah State Parks EZ Dock Swim Platforms, and Park City Historical Society) and give a quick report. This was modified to a discussion without formal action initially.
- Discussion on Cache County Hospital Greenville Elementary Canal Trail (Presented by Jake): Small connector trail for the Bonneville Shoreline Trail, asking for \$33,000 with a one-to-one match. Seen as well-put-together.
- Discussion on Utah State Parks EZ doc swim platform (Presented by Russ): High score, in a state park, area for recreation like snorkeling.
- Discussion on Park City Historical Society application (Presented by Russ): Related to a trail, potentially part of a larger network, high score.
- A motion was made by Tom to move those top three projects forward, seconded by Scott Strong. Discussion led to deciding on recommendations and discussion first.
- A motion was made by Tom to consider anything with two high recommendations above a score of 20, including Cache County one, Utah Open Lands one, and Utah State Parks Green River Disc Golf. Erin made a substitute motion to include the Far West City application. The substitute motion was seconded and passed to hear from each of those projects.
- Discussion on Farr West City (Presented by Erin): Project faced bid issues, has been in the works.
- Discussion on Utah State Parks Green River Disc Golf (Presented by Lincoln): Disc golf tournaments bring significant economic value (\$10,000 in one weekend mentioned) to the community, impactful for Green River.
- Discussion on Brian Head Town Bristlecone Pond Dock expansion (score above 20): Presented by Evan. Project expands the dock and adjusts the ramp. Concern about accessibility impact due to a potentially steeper shortened ramp led Evan to rank it low.
- A suggestion was made to discuss the rest of the projects scoring above 20.
- Discussion on 27th Street Trail Head User Accessories (Presented by Jason): Foundation of Northern Utah project enhancing an existing trailhead with repair stations, benches, etc. Seen as well-put-together.
- Discussion on Eccles Wildlife Center Braille Trail presented by Betsy
- Discussion on Utah's Buffalo Soldier Heritage Trail project presented by Tom
- Motion by Lance to approve all projects on the mini grant list with a score of 20 or higher, seconded. Passed unanimously via roll call vote. This advances 11 projects.

- **Community Parks and Recreation (CPR) Discussion: Discussion began around 57:15.**

- Discussion about the CPR application focuses on parks and ideals, leading to repeated responses. Difficulty anticipated with multi-application projects for the same site.
- Consideration for multi-applicant/multi-site projects and whether outdoor classrooms are appropriate here, looking for multiple partners.
- Suggestion for a subcommittee for CPR next year to narrow applications and recommend priorities.
- Patrick mentioned there were 28 pickleball applications.
- Discussion on Koosharem Town project (Presented by Des): School donated playground to the city, small town reusing equipment, seen as a "no-brainer".
- Discussion on Town of Springdale project (Presented by Scott): Limited ask despite eligibility for more, receiving county/community funds, deserves the asset. Discussion about missing third score.
- Discussion on Orderville project (Presented by Lincoln): Decent match, rural, multi-sport, contemplated plan, ranked high.
- Discussion on Tooele County Parks and Rec project (Presented by Tom): Large ask (\$800,000) but great match (20% ask), best match among projects reviewed, worth bringing into the conversation.
- Status update on funding total for projects discussed up to this point: \$1.47 million.
- A motion was made by Lincoln to advance the first four projects discussed (Koosharem Town, Springdale, Orderville, Tooele County Parks and Rec) for future consideration. Discussion about potentially funding more projects at lower levels. Discussion about a logical break point in scores (around 33.33). The motion to approve the four projects, seconded by Lance, passed unanimously via roll call vote. These four projects were advanced. Current amount advanced: \$618,000. Lincoln clarified the motion was to advance the four, then make individual motions for others discussed down to the 33.33 score area.
- Discussion on Town of Hatch pickleball court (Score 34): Small town, not many public amenities, pickleball court would be great. Concern about unclear community interest in the application.
- Discussion on St. George Thunder Junction All Abilities Park Phase II (Score 34) (Presented by Jeffrey): Kids love the current park, draws regional visitors, Phase two creates an ice age-focused playground, checks all boxes (regional draw, all-abilities). Jeffrey ranked high but questioned if it would happen anyway.
- Discussion on Minersville Swimming Pool Project (Score 35) (Presented by Tracy): Small, rural community pool, important, old pool needs repair, good return on investment, planning another 40 years. Poor engineering/site map and need for maintenance plan mentioned as drawbacks. Trying to catch up on deferred maintenance to become ADA accessible. Asking \$100,000 out of \$125,000 total.

- Discussion on Town of Bluff project (Score 32) (Presented by Tracy): Small location in San Juan County, looking for new inclusive playground/recreation area. Good schedule and support mentioned. Asking for \$165,000 out of \$226,000. Tracy had a medium score, wanting more design details for accessibility. Concept/layout are good, appreciated for remote area location and tie to other community plans.
- Discussion on Mantua Maple Springs Park bandstand and playground completion: Detailed budget, located near trails, adds value to the big picture.
- Discussion on Fairview City project (Score 31) (Presented by Jake and Tom): Refurbishment of a ballpark, one of several San Pete County projects. Actually creating the resource. Compared to other ballparks, this one was better due to cost value added (fencing, restrooms). The goal is to bring tournaments.
- Current amount advanced for CPR: \$617,000.
- A motion was made by Tom to advance several projects from the first page (down to the 33.33 score area) for consideration: Lake Town Community Park, Ephraim City pickleball court, Mendon City legacy park, Minersville swimming pool project, Hatch pickleball court, and St. George Thunder Junction All Abilities Park. The motion, seconded by Cameron, passed unanimously via roll call vote. These projects were added to the list to consider. Total advance: \$1,450,000.
- Motion by Russ to advance the Sigurd Town exercise path and event pavilion expansion, seconded by Russ. Passed unanimously with one abstention via roll call vote.
- Motion by Jeffrey to advance the Paradise Town and Bluff Town projects Passed unanimously via roll call vote. These projects were added to the list.
- Motion by Tom to add the Cedar City Rotary Club park project, Escalante project, and City of Monticello project to be reviewed tomorrow. Substitute motion seconded by Lance Syrett. Passed unanimously via roll call vote. This brings the total advance for CPR to almost \$2.4 million.
- **Recreation Restoration Infrastructure (RRI) Discussion: (3:39:43)**
 - The total requested amount for RRI is about \$4.7 million. Average score is 32.73
 - A motion was made by Erin to approve projects scoring 38.67 and up, as there was a break there, and all four had high ratings. This was modified to anything scoring 38 or higher without any medium ratings in the funding priority score, including projects from Goblin Valley State Park down to Salt Lake Climbers Alliance. The motion was seconded by Scott Strong and passed unanimously via roll call vote. These five projects were placed on the list to recommend. Total advanced: \$354,000.
 - A motion was made by Erin to do brief presentations on anything with a score of 36 or higher that hasn't been pushed forward, seconded. Tom made a substitute motion to include the Salt Lake Climbers Alliance climbing trail maintenance and education project (score 34.67) because it had two high scores. The substitute motion was seconded by Erin and passed via voice vote. Discussion began for 10 projects.

- Discussion on Limber Flag and Grizzly Ridge Rehabilitation project (Presented by Jordan): Involves refurbishing two yurts to be ADA compliant, asking for \$33,100 out of a \$216,100 project. Considered amazing projects, not enough in the state, bit of economic development piece, very good match.
 - Discussion on Cottonwood Canyons Foundation Secret Lake Silver Lake and Adams Canyon Trail Restoration Projects (Presented by Tracy): Seeking \$250,000 to restore degraded trail portions, huge amount of partnering organizations, detailed work needed for high volume areas, planning to increase accessibility. Tracy ranked it high, feeling it would impact a lot of high-volume trail access. Cottonwood Canyons Foundation has been funded successfully in the past.
 - Discussion on Davis County Regional Trails Surface Restoration Project (Score 36) (Presented by Lance): Replacing old interpretive signs and kiosks on trails, related to safety issues. Received partial funding from RTP, initial request \$190,000, easy to modularize for partial funding, needed project based on local knowledge.
 - Discussion on Superbowl Campground Restoration project (Score 34.67) (Presented by Jake): Forest Service project in San Juan County, restoring campground damaged by flooding, worth funding for San Juan County.
 - Discussion on Marysville Town Rodeo Grounds Improvement project (Score 27.33) (Presented by Betsy): County project, very small, rural, remote (Piute County), might be good to hit all counties. Debate about funding rodeo grounds, some states identify rodeo as outdoor recreation, this project involves a horse riding arena.
 - A motion was made by Jeffrey to advance several projects (total of 12), including everything discussed from the Limber Flag/Grizzly Yurts down to the Salt Lake Climbers Alliance project, plus the San Juan County (Superbowl Campground) and Piute County (Marysville Rodeo Ground) applications. The motion was seconded by Erin and passed unanimously with one abstention (Jake abstained) via roll call vote. These projects were added to the list. Total advance for RRI: \$1.7 million.
 - Discussion on Ogden City Kayak Park Restoration Project (Score 32) (Presented by Evan): Involves replacing failed structures. Concern about accessibility description and lack of kayak group partners. Not many requests for kayaking grants (only about three in 10 years mentioned). Motion passed via roll call vote.
- **2025 Regional Asset Tier Grant Presentations:** Presentations were scheduled between 2:00 pm and 3:30 pm on April 30th. **Began around 5:03:29**

- **Resume application discussions:** Scheduled 3:30 PM.
- **Tier One Discussion: Discussion began around 6:34:30**
 - There is \$12.5 million in requests for Tier One. Average score is 35.3.
 - A motion was made by Lance to advance everything scoring 40 and above. Discussion about including San Juan County with mixed scores. Lance amended his motion to go down to 39.09. Question raised about Wild Willow Park (scoring 39.09). It was confirmed Phase 2 was funded last year. The amended motion was seconded by Des to recommend projects scoring 39.09 and above for the final list of approvals, including the top 12 projects. Passed unanimously via roll call vote. Total advance for Tier One: \$3.27 million.
 - The overall funding amount advanced so far is about \$8 million.
 - Discussion about pausing on advancing more Tier One projects until Regional Asset Tier dollar amounts are figured out, as those are large projects.
 - Suggestion to discuss the Regional Asset Tier projects presented today. Motion by Erin to discuss the regional asset tiers seen today, seconded. Passed. Discussion launched.
 - Discussion revisited on Midway City ice rink presentation. 6:45:00
 - Snowland discussion 6:53:35

- **General discussion of the Regional Asset Tiers began around 2:51:04.**
 - Motion by Lance, seconded by Scott, to advance Millcreek Common Phase 2 and Snowland Recreation Education Area into the list of those to approve on the regional asset tier, with a condition that Snowland document insurance. Vote occurred and passed unanimously.
 - Discussion occurred regarding other Regional Asset projects including Nephi Jamestown Park, Lizard Wash Park, Uintah All Wheels Park, Scenic Slopes

Pump Track, Fort Utah All Wheels, Bastian Natural Resource, and West Jordan Skate Park around

- Motion by Tom, seconded by Tracy, to reduce the requested amount for Bastian to \$500,000 (without moving it to the next round initially). Vote occurred and passed unanimously.
- Discussion occurred regarding the West Jordan project around
- Discussion occurred regarding the Uintah All Wheels project around
- Motion by Tom, seconded by Russ, to reduce the amount for Uintah All Wheels to 750,000. Vote occurred and passed unanimously.
- Discussion occurred regarding Muirfield Park around, with a suggestion it could fit as Tier 1.
- Motion initiated by Tom, refined with Russell, to advance Lizard Wash (750k) and Uintah All Wheels (750k), later amended to include West Jordan (1M) and Nephi (1M) for consideration. Scenic Slopes was added at 750k. Discussion occurred regarding amounts and budget impact.
- Motion made by Jordan and seconded by Lance, to add the Fort Utah one at the amount of 750,000 to the list that was in the prior motion. Vote occurred around 3:37:30 and passed unanimously.
- Motion by Tom, seconded by Des, to approve (advance) USA Climbing to the next approval level at one million dollars. Discussion occurred at around 3:38:07. Vote occurred and passed unanimously.
- Discussion occurred regarding the Tier 1 grants at 3:45:20
- Discussion occurred regarding Grantsville City Scenic Slopes Motion by Tom, seconded by Lance, to change the approved budget for Grantsville City Scenic Slopes from 750,000 to 500,000. Discussion occurred at around 4:24:39.

- Motion by Russ, seconded by Erin, to add West Haven Fishing Pond onto the list. Vote occurred and the vote does not pass.
- Discussion occurred regarding Sunrock High Adventure Adirondack Restoration. A roll call vote occurred and the vote does not pass. The project does not advance.

- Motion by Mike to approve the List of Grant Applications as presently constituted. Substitute motion by Tom to approve the list as currently shown but include Woodland Hills project onto the list. Vote occurred on the constituted list of 99 projects totaling \$15.2 million and passes unanimously. (This appears to be an approval of a batch of projects previously advanced).
- Discussion occurred regarding the Southview Pump Track- Southview Trailhead Improvement.
- Discussion occurred regarding Francis City's Wild Willow Nature Park Completion.
- Discussion shifted to Tier 1 projects.
